- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 48.43 6 RCW to read as follows:
- 7 (1) The insurance commissioner shall utilize the uniform 8 electronic process created by RCW 48.165.035 as a database that 9 manages health care providers' credentialing information and makes 10 the information available to health benefit plans.
- 11 (2) A health benefit plan shall use the database selected 12 pursuant to subsection (1) of this section to accept and manage 13 credentialing applications from health care providers.
 - (a) A health benefit plan shall make a determination approving or denying a credentialing application submitted to the plan no later than fifteen days after receiving a complete application from a health care provider.
- 18 (b) If a health care provider submits an incomplete credentialing 19 application to a health benefit plan, the plan shall notify the 20 health care provider in writing no later than five days after receipt 21 of the application that the application is incomplete. The notice

- 1 must explain what additions or corrections to the application are 2 necessary for the application to be considered complete.
- 3 (3) For purposes of this section, the following definitions apply unless the context clearly requires otherwise:
- 5 (a) "Credentialing" means the collection, verification, and 6 assessment of whether a health care provider meets relevant 7 licensing, education, and training requirements.
- 8 (b) "Health care provider" means a person authorized to issue 9 orders or prescriptions for legend drugs as provided in RCW 10 69.41.030.
- NEW SECTION. Sec. 2. A new section is added to chapter 18.130 RCW to read as follows:
- 13 (1) A health care provider shall submit credentialing 14 applications to health benefit plans using the database selected by 15 the insurance commissioner under section 1 of this act.
- 16 (2) For purposes of this section, the following definitions apply 17 unless the context clearly requires otherwise:
- 18 (a) "Credentialing" means the collection, verification, and 19 assessment of whether a health care provider meets relevant 20 licensing, education, and training requirements.
- 21 (b) "Health benefit plan" has the same meaning as in RCW 22 48.43.005.
- (c) "Health care provider" means a person authorized to issue orders or prescriptions for legend drugs as provided in RCW 69.41.030.
