The conditions and 2 procedure for holding ((such)) the election ((shall be those)) are 3 prescribed by RCW 66.40.020, 66.40.040, 66.40.100, 66.40.110, and 4 66.40.120. Whenever a majority of qualified voters voting upon 5 6 ((said)) the question in ((any such)) the election unit ((shall have 7 voted)) vote "against the sale of liquor under spirits, beer, and wine restaurant; spirits, beer, and wine private club; spirits, beer, 8 and wine nightclub; and sports entertainment facility licenses," the 9 county auditor ((shall)) must file with the liquor control board a 10 11 certificate showing the result of the canvass at ((such)) the election((; and after)). Ninety days ((from and)) after the date of 12 ((the)) that canvass, it ((shall not be lawful)) is unlawful for 13 14 licensees to maintain and operate premises within the election unit licensed under spirits, beer, and wine restaurant; spirits, beer, and 15 16 wine private club; spirits, beer, and wine nightclub; and sports 17 entertainment facility licenses.

(2) The addition after an election under <u>subsection</u> (1) of this section of new territory to ((a city, town, or county,)) the election <u>unit</u> by annexation, disincorporation, or otherwise((, shall)) <u>does</u> not extend the prohibition against the sale of liquor under spirits, beer, and wine restaurant; spirits, beer, and wine private club; spirits, beer, and wine nightclub; and sports entertainment facility licenses to the new territory. <u>Furthermore</u>, the new territory is not:

(a) Within the election unit in any subsequent election under <u>subsection</u> (1) of this section; or (b) subject to any prohibition adopted pursuant to any subsequent election under subsection (1) of this section.

(3) Elections held under RCW 66.40.010, 66.40.020, 66.40.040, 66.40.100, 66.40.110, 66.40.120, and 66.40.140((, shall be)) are limited to the question of whether the sale of liquor by means other than under spirits, beer, and wine restaurant; spirits, beer, and wine private club; spirits, beer, and wine nightclub; and sports entertainment facility licenses ((shall be)) is permitted within ((such)) the election unit.
