- AN ACT Relating to increasing the availability of sexual assault 1

- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON: 4
- 5 NEW SECTION. **Sec. 1.** A new section is added to chapter 43.280
- 6 RCW to read as follows:
- 7 (1) Subject to the availability of amounts appropriated for this
- specific purpose, the office of crime victims advocacy shall study 8
- the availability of sexual assault nurse examiners throughout the 9
- state. The study must include: 10
- (a) An identification of areas of the state that have an adequate 11
- number of sexual assault nurse examiners; 12
- (b) An identification of areas of the state that have 13 an
- 14 inadequate number of sexual assault nurse examiners;
- (c) A list of available resources for facilities in need of 15
- 16 sexual assault nurse examiners or sexual assault nurse examiner
- 17 training; and
- 18 (d) Strategies for increasing the availability of sexual assault
- nurse examiners in underserved areas. 19

- 1 (2) When identifying strategies for increasing the availability 2 of sexual assault nurse examiners in underserved areas, the office of 3 crime victims advocacy shall, at a minimum, consider:
  - (a) Remote training or consultation via electronic means;
  - (b) Mobile teams of sexual assault nurse examiners;
- 6 (c) Costs and reimbursement rates for sexual assault nurse 7 examiners; and
  - (d) Funding options.

- 9 (3) When performing the study under this section, the office of 10 crime victims advocacy shall consult with experts on sexual assault 11 victims' advocacy, experts on sexual assault investigation, and 12 providers including, but not limited to:
- 13 (a) The department of health;
  - (b) The Washington coalition of sexual assault programs;
- 15 (c) The Washington association of sheriffs and police chiefs;
  - (d) The Washington association of prosecuting attorneys;
    - (e) The Washington state hospital association;
- 18 (f) The Harborview center for sexual assault and traumatic 19 stress;
  - (g) The nursing care quality assurance commission; and
- 21 (h) The Washington state nurses association.
- 22 (4) The office of crime victims advocacy shall report its 23 findings and recommendations to the governor and the appropriate 24 committees of the legislature no later than December 1, 2016.
- 25 (5) This section expires July 31, 2017.
