1 AN ACT Relating to increased efficiency in child care reporting;
2 amending RCW 43.215.135 and 43.215.1352; and creating a new section.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 NEW SECTION. **Sec. 1.** The legislature recognizes that the
5 federal government encourages states to ensure that a child who is
6 eligible for subsidized child care remains in child care regardless
7 of temporary changes to the child's family. The legislature intends
8 to meet this federal goal, which will increase administrative
9 efficiency and provide stable child care, by streamlining a family's
10 reporting requirements regarding changes to a family's circumstances.

11 **Sec. 2.** RCW 43.215.135 and 2013 c 323 s 9 are each amended to
12 read as follows:

13 (1) The department shall establish and implement policies in the
14 working connections child care program to promote stability and
15 quality of care for children from low-income households. Policies for
16 the expenditure of funds constituting the working connections child
17 care program must be consistent with the outcome measures defined in
18 RCW 74.08A.410 and the standards established in this section intended
19 to promote continuity of care for children.

1 (2) (~~Beginning in fiscal year 2013~~) As recommended by Public
2 Law 113-186, authorizations for the working connections child care
3 subsidy shall be effective for twelve months (~~unless a change in~~
4 ~~circumstances necessitates reauthorization sooner than twelve~~
5 ~~months~~). The department shall establish and implement policies in
6 accordance with this section no later than November 1, 2016. The
7 twelve-month certification applies only if the enrollments in the
8 child care subsidy or working connections child care program are
9 capped.

10 (3) Subject to the availability of amounts appropriated for this
11 specific purpose, beginning September 1, 2013, working connections
12 child care providers shall receive a five percent increase in the
13 subsidy rate for enrolling in level 2 in the early achievers
14 programs. Providers must complete level 2 and advance to level 3
15 within thirty months in order to maintain this increase.

16 **Sec. 3.** RCW 43.215.1352 and 2012 c 251 s 2 are each amended to
17 read as follows:

18 When an applicant or recipient applies for or receives working
19 connections child care benefits, (~~he or she~~) the applicant or
20 recipient is required to(~~+~~

21 ~~(1))~~ notify the department of social and health services, within
22 five days, of any change in providers(~~+~~and

23 ~~(2) Notify the department of social and health services, within~~
24 ~~ten days, about any significant change related to the number of child~~
25 ~~care hours the applicant or recipient needs, cost sharing, or~~
26 ~~eligibility)).~~
