- AN ACT Relating to decreasing the barriers to successful 1 2 community participation for individuals involved with the juvenile 3 justice system; amending RCW 13.50.260, 13.40.190, 7.68.035, 9.08.070, 9.08.072, 9.46.1961, 9.68A.105, 4 9.68A.106, 9.94A.550, 5 9A.20.021, 9A.50.030, 9A.56.060, 9A.56.085, 9A.88.120, 9A.88.140, 10.73.160, 10.82.090, 10.99.080, 13.40.080, 6 36.18.016, 36.18.020, 36.18.040, 43.43.690, 43.43.7541, 46.61.5054, 46.61.5055, 69.50.401, 7 8 69.50.425, 69.50.430, 69.50.435, and 77.15.420; reenacting and amending RCW 13.50.010 and 13.40.127; adding a new section to chapter 9 13.40 RCW; adding a new section to chapter 13.50 RCW; creating new 10 sections; and repealing RCW 13.40.145 and 13.40.085. 11
- 12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 13 NEW SECTION. Sec. 1. (1) The legislature finds that requiring 14 juvenile offenders to pay all legal financial obligations before being eligible to have a juvenile record automatically sealed 15 16 disproportionately affects youth based on their socioeconomic status. 17 Juveniles who cannot afford to pay their legal financial obligations seal their juvenile records once they turn eighteen and 18 struggle to find 19 oftentimes employment. Ву eliminating most nonrestitution legal financial obligations for juveniles convicted of 20 21 less serious crimes, juvenile offenders will be better able to find

- 1 employment and focus on making restitution payments to the victim.
- 2 Requiring a juvenile offender to pay restitution to victims will help
- 3 juveniles understand the consequences of prior actions and the harm
- 4 that those actions have caused to others without placing
- 5 insurmountable burdens on juveniles attempting to become productive
- 6 members of society. Depending on the juvenile's ability to pay, and
- 7 upon the consent of the victim, courts should also strongly consider
- 8 ordering community restitution in lieu of paying restitution where
- 9 appropriate.
- 10 (2) Therefore, the legislature intends this legislation to 11 eliminate most nonrestitution legal financial obligations for
- 12 juvenile offenders while at the same time keeping juvenile offenders
- 13 accountable and focusing payments that are made on restitution to the
- 14 victim.
- 15 **Sec. 2.** RCW 13.50.010 and 2014 c 175 s 2 and 2014 c 117 s 5 are each reenacted and amended to read as follows:
- 17 (1) For purposes of this chapter:
- 18 (a) "Good faith effort to pay" means a juvenile offender has
- 19 <u>either (i) paid the principal amount in full; (ii) made at least</u>
- 20 <u>eighty percent of the value of full monthly payments within the</u>
- 21 period from disposition or deferred disposition until the time the
- 22 amount of restitution owed is under review; or (iii) can show good
- 23 cause why he or she paid an amount less than eighty percent of the
- 24 value of full monthly payments;
- 25 <u>(b)</u> "Juvenile justice or care agency" means any of the following:
- 26 Police, diversion units, court, prosecuting attorney, defense
- 27 attorney, detention center, attorney general, the legislative
- 28 children's oversight committee, the office of the family and
- 29 children's ombuds, the department of social and health services and
- 30 its contracting agencies, schools; persons or public or private
- 31 agencies having children committed to their custody; and any
- 32 placement oversight committee created under RCW 72.05.415;
- 33 $((\frac{b}{b}))$ <u>(c)</u> "Official juvenile court file" means the legal file
- 34 of the juvenile court containing the petition or information,
- 35 motions, memorandums, briefs, findings of the court, and court

- 37 $((\frac{c}{c}))$ (d) "Records" means the official juvenile court file, the
- 38 social file, and records of any other juvenile justice or care agency

 $((\frac{d}{d}))$ <u>(e)</u> "Social file" means the juvenile court file containing the records and reports of the probation counselor.

- (2) Each petition or information filed with the court may include only one juvenile and each petition or information shall be filed under a separate docket number. The social file shall be filed separately from the official juvenile court file.
- (3) It is the duty of any juvenile justice or care agency to maintain accurate records. To this end:
- (a) The agency may never knowingly record inaccurate information. Any information in records maintained by the department of social and health services relating to a petition filed pursuant to chapter 13.34 RCW that is found by the court to be false or inaccurate shall be corrected or expunged from such records by the agency;
- 14 (b) An agency shall take reasonable steps to assure the security 15 of its records and prevent tampering with them; and
 - (c) An agency shall make reasonable efforts to insure the completeness of its records, including action taken by other agencies with respect to matters in its files.
 - (4) Each juvenile justice or care agency shall implement procedures consistent with the provisions of this chapter to facilitate inquiries concerning records.
 - (5) Any person who has reasonable cause to believe information concerning that person is included in the records of a juvenile justice or care agency and who has been denied access to those records by the agency may make a motion to the court for an order authorizing that person to inspect the juvenile justice or care agency record concerning that person. The court shall grant the motion to examine records unless it finds that in the interests of justice or in the best interests of the juvenile the records or parts of them should remain confidential.
 - (6) A juvenile, or his or her parents, or any person who has reasonable cause to believe information concerning that person is included in the records of a juvenile justice or care agency may make a motion to the court challenging the accuracy of any information concerning the moving party in the record or challenging the continued possession of the record by the agency. If the court grants the motion, it shall order the record or information to be corrected or destroyed.
- 39 (7) The person making a motion under subsection (5) or (6) of 40 this section shall give reasonable notice of the motion to all

parties to the original action and to any agency whose records will be affected by the motion.

- (8) The court may permit inspection of records by, or release of information to, any clinic, hospital, or agency which has the subject person under care or treatment. The court may also permit inspection by or release to individuals or agencies, including juvenile justice advisory committees of county law and justice councils, engaged in legitimate research for educational, scientific, or public purposes. Each person granted permission to inspect juvenile justice or care agency records for research purposes shall present a notarized statement to the court stating that the names of juveniles and parents will remain confidential.
- (9) The court shall release to the caseload forecast council the records needed for its research and data-gathering functions. Access to caseload forecast data may be permitted by the council for research purposes only if the anonymity of all persons mentioned in the records or information will be preserved.
- (10) Juvenile detention facilities shall release records to the caseload forecast council upon request. The commission shall not disclose the names of any juveniles or parents mentioned in the records without the named individual's written permission.
- (11) Requirements in this chapter relating to the court's authority to compel disclosure shall not apply to the legislative children's oversight committee or the office of the family and children's ombuds.
- (12) For the purpose of research only, the administrative office of the courts shall maintain an electronic research copy of all records in the judicial information system related to juveniles. Access to the research copy is restricted to the Washington state center for court research. The Washington state center for court research shall maintain the confidentiality of all confidential records and shall preserve the anonymity of all persons identified in the research copy. The research copy may not be subject to any records retention schedule and must include records destroyed or removed from the judicial information system pursuant to RCW 13.50.270 and 13.50.100(3).
- (13) The court shall release to the Washington state office of public defense records needed to implement the agency's oversight, technical assistance, and other functions as required by RCW 2.70.020. Access to the records used as a basis for oversight,

- 3 office of public defense shall maintain the confidentiality of all

- 5 **Sec. 3.** RCW 13.50.260 and 2014 c 175 s 4 are each amended to 6 read as follows:
- 7 (1)(a) The court shall hold regular sealing hearings. During these regular sealing hearings, the court shall administratively seal 8 9 individual's juvenile ((court)) record pursuant 10 requirements of this subsection unless the court receives an 11 objection to sealing or the court notes a compelling reason not to seal, in which case, the court shall set a contested hearing to be 12 conducted on the record to address sealing. ((The respondent and his 13 or her attorney shall be given at least eighteen days' notice of any 14 15 contested sealing hearing and the opportunity to respond to any 16 objections, but the respondent's presence is not required at any 17 sealing hearing pursuant to this subsection.)) Although the juvenile record shall be sealed, the social file may be available to any 18 juvenile justice or care agency when an investigation or case 19 involving the juvenile subject of the records is being prosecuted by 20 the juvenile justice or care agency or when the juvenile justice or 21 22 care agency is assigned the responsibility of supervising the juvenile. The contested hearing shall be set no sooner than eighteen 23 24 days after notice of the hearing and the opportunity to object has been sent to the juvenile, the victim, and juvenile's attorney. The 25 juvenile respondent's presence is not required at a sealing hearing 26 27 pursuant to this subsection.
 - (b) At the disposition hearing of a juvenile offender, the court shall schedule an administrative sealing hearing to take place during the first regularly scheduled sealing hearing after the latest of the following events that apply:
 - (i) The respondent's eighteenth birthday;

- (iii) Anticipated release from confinement at the juvenile rehabilitation administration, or the completion of parole, if the respondent is transferred to the juvenile rehabilitation administration.

- 1 (c) A court shall enter a written order sealing an individual's juvenile court record pursuant to this subsection if:
- 3 (i) One of the offenses for which the court has entered a disposition is not at the time of commission of the offense:
 - (A) A most serious offense, as defined in RCW 9.94A.030;
 - (B) A sex offense under chapter 9A.44 RCW; or

- (C) A drug offense, as defined in RCW 9.94A.030; and
- 8 (ii) The respondent has completed the terms and conditions of 9 disposition, including affirmative conditions and ((financial obligations)) has paid the full amount of restitution.
 - (d) Following a contested sealing hearing on the record after an objection is made pursuant to (a) of this subsection, the court shall enter a written order sealing the juvenile court record unless the court determines that sealing is not appropriate.
 - (2) The court shall enter a written order immediately sealing the official juvenile court record upon the acquittal after a fact finding or upon the dismissal of charges with prejudice, subject to the state's right, if any, to appeal the dismissal.
 - (3) If a juvenile court record has not already been sealed pursuant to this section, in any case in which information has been filed pursuant to RCW 13.40.100 or a complaint has been filed with the prosecutor and referred for diversion pursuant to RCW 13.40.070, the person who is the subject of the information or complaint may file a motion with the court to have the court vacate its order and findings, if any, and, subject to RCW 13.50.050(13), order the sealing of the official juvenile court record, the social file, and records of the court and of any other agency in the case.
 - (4)(a) The court shall grant any motion to seal records for class A offenses made pursuant to subsection (3) of this section if:
 - (i) Since the last date of release from confinement, including full-time residential treatment, if any, or entry of disposition, the person has spent five consecutive years in the community without committing any offense or crime that subsequently results in an adjudication or conviction;
 - (ii) No proceeding is pending against the moving party seeking the conviction of a juvenile offense or a criminal offense;
- 37 (iii) No proceeding is pending seeking the formation of a 38 diversion agreement with that person;
- 39 (iv) The person is no longer required to register as a sex 40 offender under RCW 9A.44.130 or has been relieved of the duty to

 - (v) The person has not been convicted of rape in the first degree, rape in the second degree, or indecent liberties that was actually committed with forcible compulsion; and

- (b) The court shall grant any motion to seal records for class B, (([class])) <u>class</u> C, gross misdemeanor, and misdemeanor offenses and diversions made under subsection (3) of this section if:
 - (i) Since the date of last release from confinement, including full-time residential treatment, if any, entry of disposition, or completion of the diversion agreement, the person has spent two consecutive years in the community without being convicted of any offense or crime;
- 15 (ii) No proceeding is pending against the moving party seeking 16 the conviction of a juvenile offense or a criminal offense;
- 17 (iii) No proceeding is pending seeking the formation of a 18 diversion agreement with that person;
 - (iv) The person is no longer required to register as a sex offender under RCW 9A.44.130 or has been relieved of the duty to register under RCW 9A.44.143 if the person was convicted of a sex offense; and
 - (v) Full restitution has been paid.
 - (c) Notwithstanding the requirements in (a) or (b) of this subsection, the court shall grant any motion to seal records of any deferred disposition vacated under RCW 13.40.127(9) prior to June 7, 2012, if restitution has been paid and the person is eighteen years of age or older at the time of the motion.
 - (5) The person making a motion pursuant to subsection (3) of this section shall give reasonable notice of the motion to the prosecution and to any person or agency whose records are sought to be sealed.
 - (6)(a) If the court enters a written order sealing the juvenile court record pursuant to this section, it shall, subject to RCW 13.50.050(13), order sealed the official juvenile court record, the social file, and other records relating to the case as are named in the order. Thereafter, the proceedings in the case shall be treated as if they never occurred, and the subject of the records may reply accordingly to any inquiry about the events, records of which are sealed. Any agency shall reply to any inquiry concerning confidential or sealed records that records are confidential, and no information

1 can be given about the existence or nonexistence of records 2 concerning an individual.

- (b) In the event the subject of the juvenile records receives a full and unconditional pardon, the proceedings in the matter upon which the pardon has been granted shall be treated as if they never occurred, and the subject of the records may reply accordingly to any inquiry about the events upon which the pardon was received. Any agency shall reply to any inquiry concerning the records pertaining to the events for which the subject received a pardon that records are confidential, and no information can be given about the existence or nonexistence of records concerning an individual.
- (7) Inspection of the files and records included in the order to seal may thereafter be permitted only by order of the court upon motion made by the person who is the subject of the information or complaint, except as otherwise provided in RCW 13.50.010(8) and 13.50.050(13).
- (8)(a) Any adjudication of a juvenile offense or a crime subsequent to sealing has the effect of nullifying a sealing order; however, the court may order the juvenile court record resealed upon disposition of the subsequent matter if the case meets the sealing criteria under this section and the court record has not previously been resealed.
- 23 (b) Any charging of an adult felony subsequent to the sealing has 24 the effect of nullifying the sealing order.
 - (c) The administrative office of the courts shall ensure that the superior court judicial information system provides prosecutors access to information on the existence of sealed juvenile records.
 - (d) The Washington state patrol shall ensure that the Washington state identification system provides criminal justice agencies access to sealed juvenile records information.
 - (9) If the juvenile court record has been sealed pursuant to this section, the record of an employee is not admissible in an action for liability against the employer based on the former juvenile offender's conduct to show that the employer knew or should have known of the juvenile record of the employee. The record may be admissible, however, if a background check conducted or authorized by the employer contained the information in the sealed record.
 - (10) County clerks may interact or correspond with the respondent, his or her parents, and any holders of potential assets or wages of the respondent for the purposes of collecting an

- 3 <u>NEW SECTION.</u> **Sec. 4.** A new section is added to chapter 13.40 4 RCW to read as follows:
- Cities, towns, and counties may not impose any legal financial obligations, fees, fines, or costs associated with juvenile offenses unless there is express statutory authority for those legal financial obligations, fees, fines, or costs.
- **Sec. 5.** RCW 13.40.190 and 2014 c 175 s 7 are each amended to 10 read as follows:
 - (1)(a) In its dispositional order, the court shall require the respondent to make restitution to any persons who have suffered loss or damage as a result of the offense committed by the respondent. In addition, restitution may be ordered for loss or damage if the offender pleads guilty to a lesser offense or fewer offenses and agrees with the prosecutor's recommendation that the offender be required to pay restitution to a victim of an offense or offenses which, pursuant to a plea agreement, are not prosecuted.
- 19 (b) Restitution may include the costs of counseling reasonably 20 related to the offense.
 - (c) The payment of restitution shall be in addition to any punishment which is imposed pursuant to the other provisions of this chapter.
 - (d) The court may determine the amount, terms, and conditions of the restitution including a payment plan extending up to ten years if the court determines that the respondent does not have the means to make full restitution over a shorter period. If the court determines that a juvenile has insufficient funds to pay and upon agreement of the victim, the court may order performance of a number of hours of community restitution in lieu of monetary penalty, at the rate of the then state minimum wage per hour. The court shall allow the victim to determine the nature of the community restitution to be completed when it is practicable to do so. For the purposes of this section, the respondent shall remain under the court's jurisdiction for a maximum term of ten years after the respondent's eighteenth birthday and, during this period, the restitution portion of the dispositional order may be modified as to amount, terms, and conditions at any time for good cause shown, including inability to pay. Prior to the

- expiration of the ten-year period, the juvenile court may extend the judgment for the payment of restitution for an additional ten years.
- 3 If the court grants a respondent's petition pursuant to RCW
- 4 13.50.260, the court's jurisdiction under this subsection shall terminate.
- 6 (e) Nothing in this section shall prevent a respondent from 7 petitioning the court pursuant to RCW 13.50.260 if the respondent has 8 paid the full restitution amount stated in the court's order and has 9 met the statutory criteria.

- (f) If the respondent participated in the crime with another person or other persons, ((all such participants shall be jointly and severally responsible for the payment of restitution)) the court may either order joint and several restitution or may divide restitution equally among the respondents. In determining whether restitution should be joint and several or equally divided, the court shall consider the interest and circumstances of the victim or victims, the circumstances of the respondents, and the interest of justice.
- (g) At any time, the court may determine that the respondent is not required to pay, or may relieve the respondent of the requirement to pay, full or partial restitution to any insurance provider authorized under Title 48 RCW if the respondent reasonably satisfies the court that he or she does not have the means to make full or partial restitution to the insurance provider and could not reasonably acquire the means to pay the insurance provider the restitution over a ten-year period.
- (2) Regardless of the provisions of subsection (1) of this section, the court shall order restitution in all cases where the victim is entitled to benefits under the crime victims' compensation act, chapter 7.68 RCW. If the court does not order restitution and the victim of the crime has been determined to be entitled to benefits under the crime victims' compensation act, the department of labor and industries, as administrator of the crime victims' compensation program, may petition the court within one year of entry of the disposition order for entry of a restitution order. Upon receipt of a petition from the department of labor and industries, the court shall hold a restitution hearing and shall enter a restitution order.
- (3) If an order includes restitution as one of the monetary assessments, the county clerk shall make disbursements to victims named in the order. The restitution to victims named in the order

- shall be paid prior to any payment for other penalties or monetary assessments. The county clerk shall make restitution disbursements to victims prior to payments to any insurance provider under Title 48 RCW.
- 5 (4) For purposes of this section, "victim" means any person who 6 has sustained emotional, psychological, physical, or financial injury 7 to person or property as a direct result of the offense charged. 8 "Victim" may also include a known parent or guardian of a victim who 9 is a minor child or is not a minor child but is incapacitated, 10 incompetent, disabled, or deceased.
- 11 (5) A respondent under obligation to pay restitution may petition 12 the court for modification of <u>or relief from</u> the restitution order.

- (1)(a) When any person is found guilty in any superior court of having committed a crime, except as provided in subsection (2) of this section, there shall be imposed by the court upon such convicted person a penalty assessment. The assessment shall be in addition to any other penalty or fine imposed by law and shall be five hundred dollars for each case or cause of action that includes one or more convictions of a felony or gross misdemeanor and two hundred fifty dollars for any case or cause of action that includes convictions of only one or more misdemeanors.
- (b) When any juvenile is adjudicated of any offense in any juvenile offense disposition under Title 13 RCW, except as provided in subsection (2) of this section, there shall be imposed upon the juvenile offender a penalty assessment. The assessment shall be in addition to any other penalty or fine imposed by law and shall be one hundred dollars for each case or cause of action that includes one or more adjudications for a felony or gross misdemeanor and seventy-five dollars for each case or cause of action that includes adjudications of only one or more misdemeanors. This penalty assessment shall be imposed on juvenile offenders only when the crime committed has an actual victim.
- 35 (2) The assessment imposed by subsection (1) of this section 36 shall not apply to motor vehicle crimes defined in Title 46 RCW 37 except those defined in the following sections: RCW 46.61.520, 38 46.61.522, 46.61.024, 46.52.090, 46.70.140, 46.61.502, 46.61.504, 39 46.52.101, 46.20.410, 46.52.020, 46.10.495, 46.09.480, 46.61.5249,

- (3) When any person accused of having committed a crime posts bail in superior court pursuant to the provisions of chapter 10.19 RCW and such bail is forfeited, there shall be deducted from the proceeds of such forfeited bail a penalty assessment, in addition to any other penalty or fine imposed by law, equal to the assessment which would be applicable under subsection (1) of this section if the person had been convicted of the crime.
- (4) Such penalty assessments shall be paid by the clerk of the superior court to the county treasurer who shall monthly transmit the money as provided in RCW 10.82.070. Each county shall deposit fifty percent of the money it receives per case or cause of action under subsection (1) of this section and retains under RCW 10.82.070, not less than one and seventy-five one-hundredths percent of the remaining money it retains under RCW 10.82.070 and the money it retains under chapter 3.62 RCW, and all money it receives under subsection (7) of this section into a fund maintained exclusively for the support of comprehensive programs to encourage and facilitate testimony by the victims of crimes and witnesses to crimes. A program shall be considered "comprehensive" only after approval of the department upon application by the county prosecuting attorney. The department shall approve as comprehensive only programs which:
- (a) Provide comprehensive services to victims and witnesses of all types of crime with particular emphasis on serious crimes against persons and property. It is the intent of the legislature to make funds available only to programs which do not restrict services to victims or witnesses of a particular type or types of crime and that such funds supplement, not supplant, existing local funding levels;
- (b) Are administered by the county prosecuting attorney either directly through the prosecuting attorney's office or by contract between the county and agencies providing services to victims of crime;
- (c) Make a reasonable effort to inform the known victim or his or her surviving dependents of the existence of this chapter and the procedure for making application for benefits;

(e) Assist victims of violent crimes in the preparation and presentation of their claims to the department of labor and industries under this chapter.

Before a program in any county west of the Cascade mountains is submitted to the department for approval, it shall be submitted for review and comment to each city within the county with a population of more than one hundred fifty thousand. The department will consider if the county's proposed comprehensive plan meets the needs of crime victims in cases adjudicated in municipal, district or superior courts and of crime victims located within the city and county.

- (5) Upon submission to the department of a letter of intent to adopt a comprehensive program, the prosecuting attorney shall retain the money deposited by the county under subsection (4) of this section until such time as the county prosecuting attorney has obtained approval of a program from the department. Approval of the comprehensive plan by the department must be obtained within one year of the date of the letter of intent to adopt a comprehensive program. The county prosecuting attorney shall not make any expenditures from the money deposited under subsection (4) of this section until approval of a comprehensive plan by the department. If a county prosecuting attorney has failed to obtain approval of a program from the department under subsection (4) of this section or failed to obtain approval of a comprehensive program within one year after submission of a letter of intent under this section, the county treasurer shall monthly transmit one hundred percent of the money deposited by the county under subsection (4) of this section to the state treasurer for deposit in the state general fund.
- (6) County prosecuting attorneys are responsible to make every reasonable effort to insure that the penalty assessments of this chapter are imposed and collected.
- 31 (7) Every city and town shall transmit monthly one and seventy-32 five one-hundredths percent of all money, other than money received 33 for parking infractions, retained under RCW 3.50.100 and 35.20.220 to 34 the county treasurer for deposit as provided in subsection (4) of 35 this section.
- NEW SECTION. Sec. 7. A new section is added to chapter 13.50 RCW to read as follows:
