- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 28A.320 7 RCW to read as follows:
- (1) By July 1, 2016, the Washington state school directors' 8 association, with the assistance of the office of the superintendent 9 of public instruction, shall develop a model policy and procedures 10 11 language access by limited-English proficient parents. developing the model policy and procedures, the school directors' 12 13 association shall consider any quidance materials created by the 14 United States department of justice, the United States department of the office of 15 education. and of the superintendent public 16 instruction, regarding how school districts can effectively assess 17 their language access needs and how to develop appropriately tailored language access plans. The model policy and procedures must at a 18

1 (a) Guidance and procedures for timely and accurate 2 identification of limited-English proficient parents and guardians 3 and their language access needs;

- (b) A recommended process and procedures for when and how to access an interpreter;
- (c) A prohibition on the use of students or children as interpreters for school-related communications;
 - (d) Procedures to ensure appropriate staff are aware of parents' or guardians' need for language assistance, including guidance for all school administrators, teachers, and other appropriate staff regarding when and how to access an interpreter or translation services in a timely manner;
 - (e) A process for communicating with parents and guardians about their rights under federal and state law to be provided with accessible information that allows them to make informed choices regarding their child's education and how to access the resources and services available to them.
 - (2) The office of the superintendent of public instruction shall convene an advisory committee with representatives of parents, school administrators, school principals, classified and certificated staff, and other appropriate parties with interest in language access for limited-English parents to develop sample materials for school districts to disseminate to both school employees and parents regarding parents' rights under the model policy developed by the Washington state school directors' association and the resources available to assist parents and guardians in accessing the services available to them. The development of the sample materials must be completed by July 1, 2016.
 - (3) The school directors' association shall post the model policy and procedures developed under subsection (1) of this section and a link to the sample materials developed by the advisory committee under subsection (2) of this section on its web site.
 - (4) Each school district board of directors shall establish its own language access policy and procedures by January 1, 2017, and shall make the policy and procedures available on the district's web site. The language access policy and procedures adopted by each school district shall at a minimum include the five minimum requirements found in subsection (1) of this section.
- 39 (a) By January 1, 2017, each school district shall notify the 40 office of the superintendent of public instruction whether the

district adopted the model policy, procedures, and sample materials or the district adopted something different. If the district subsequently revises the district policy, then the district shall notify the office of the superintendent of public instruction and the superintendent shall update the list under (b) of this subsection accordingly.

- (b) The office of the superintendent of public instruction shall maintain and have available upon request a list of school districts that have and have not adopted the Washington state school directors' association's model policy developed under subsection (1) of this section.
- 12 (5) The office of the superintendent of public instruction shall 13 adopt rules regarding school districts' communication of the language 14 access policy and procedure to parents, students, employees, and 15 volunteers.
- 16 **Sec. 2.** RCW 28A.300.580 and 2014 c 150 s 4 are each amended to 17 read as follows:
- 18 (1) The office of the superintendent of public instruction ((and the office of the education ombuds)) shall develop a list of and post information on the agency's web site regarding:
- 21 <u>(a) Language access services providers available to school</u>
 22 <u>districts, including but not limited to,</u> the phone interpretation
 23 vendors on contract with the state of Washington, including contact
 24 information; and
- 25 <u>(b) Training programs that are available to support school</u>
 26 <u>districts in preparing employees for how to access and effectively</u>
 27 <u>use an interpreter.</u>
- 28 (2) The list created under subsection (1) of this section shall
 29 be updated and sent to all school districts annually. School
 30 districts shall make this list available to school personnel on an
 31 annual basis.
- 32 (3) School districts are encouraged to use the phone 33 interpretation services addressed in subsection (1) of this section 34 to communicate with student's parents, legal guardians, and family 35 members who have limited English proficiency.
