1 AN ACT Relating to Purple Heart license plates; amending RCW 2 46.18.280, 46.68.425, and 43.60A.140; reenacting and amending RCW 3 46.17.220; and providing an effective date.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 Sec. 1. RCW 46.18.280 and 2011 c 332 s 8 are each amended to 6 read as follows:

7 (1) A registered owner who has been awarded a Purple Heart medal by any branch of the United States armed forces, including the 8 9 merchant marines and the women's air forces service pilots may apply to the department for special license plates for use on ((only one)) 10 11 a motor vehicle required to display one or two license plates, 12 excluding vehicles registered under chapter 46.87 RCW, upon terms and 13 conditions established by the department, and owned by the qualified 14 applicant. The applicant must:

15 (a) Be a resident of this state;

16 (b) Have been wounded during one of this nation's wars or 17 conflicts identified in RCW 41.04.005;

18 (c) Have received an honorable discharge from the United States 19 armed forces;

(d) Provide a copy of the armed forces document showing therecipient was awarded the Purple Heart medal;

(e) Be recorded as the registered owner of the motor vehicle on
 which the Purple Heart ((survivor)) license plate or plates will be
 displayed; and

4 (f) Pay all fees and taxes required by law for registering the 5 motor vehicle.

6 (2) Purple Heart license plates must be issued without the
7 payment of any special license plate fee for one motor vehicle. For
8 other motor vehicles, qualified applicants may purchase Purple Heart
9 license plates for the fee required under RCW 46.17.220(1)(p).

(3) Purple Heart license plates may be issued to the surviving 10 11 spouse or domestic partner of a Purple Heart recipient who met the 12 requirements in subsection (1) of this section. The surviving spouse or domestic partner must be a resident of this state. If the 13 surviving spouse remarries or the surviving domestic partner marries 14 or enters into a new domestic partnership, he or she must return the 15 16 special license plates to the department within fifteen days and 17 apply for regular license plates or another type of special license 18 plate.

19 (4) A Purple Heart license plate or plates may be transferred 20 from one motor vehicle to another motor vehicle owned by the Purple 21 Heart recipient or the surviving spouse or domestic partner as 22 described in subsection (3) of this section upon application to the 23 department, county auditor or other agent, or subagent appointed by 24 the director.

25 Sec. 2. RCW 46.17.220 and 2014 c 77 s 2 and 2014 c 6 s 2 are 26 each reenacted and amended to read as follows:

(1) In addition to all fees and taxes required to be paid upon application for a vehicle registration in chapter 46.16A RCW, the holder of a special license plate shall pay the appropriate special license plate fee as listed in this section.

(2) After deducting administration and collection expenses for 9 the sale of baseball stadium license plates, the remaining proceeds 10 must be distributed to a county for the purpose of paying the 11 12 principal and interest payments on bonds issued by the county to construct a baseball stadium, as defined in RCW 82.14.0485, including 13 reasonably necessary preconstruction costs, while the taxes are being 14 15 collected under RCW 82.14.360. After this date, the state treasurer 16 shall credit the funds to the state general fund.

17 **Sec. 3.** RCW 46.68.425 and 2014 c 77 s 3 are each amended to read 18 as follows:

19 (1) The department shall:

20 (a) Collect special license plate fees established under RCW21 46.17.220;

(b) Deduct an amount not to exceed twelve dollars for initial
 issue and two dollars for renewal issue for administration and
 collection expenses incurred by it; and

(c) Remit the remaining proceeds to the custody of the statetreasurer with a proper identifying detailed report.

(2) The state treasurer shall credit the proceeds to the motor 27 28 vehicle fund until the department determines that the state has been 29 reimbursed for the cost of implementing the special license plate. 30 Upon determination by the department that the state has been 31 reimbursed, the state treasurer shall credit the remaining special 32 license plate fees to the following accounts by special license plate 33 type:

32 **Sec. 4.** RCW 43.60A.140 and 2010 c 161 s 1106 are each amended to 33 read as follows:

(1) The veterans stewardship account is created in the custody of the state treasurer. Disbursements of funds must be on the authorization of the director or the director's designee, and only for the purposes stated in subsection (4) of this section. In order 1 to maintain an effective expenditure and revenue control, funds are 2 subject in all respects to chapter 43.88 RCW, but no appropriation is 3 required to permit expenditure of the funds.

4 (2) The department may request and accept nondedicated 5 contributions, grants, or gifts in cash or otherwise, including funds 6 generated by the issuance of the armed forces license plate 7 collection under chapter 46.18 RCW.

8 (3) All receipts from the sale of armed forces license plates and
9 <u>Purple Heart license plates</u> as required under RCW ((46.17.220(1)(b)))
10 <u>46.68.425(2)</u> must be deposited into the veterans stewardship account.

(4) All moneys deposited into the veterans stewardship account must be used by the department for activities that benefit veterans or their families, including but not limited to, providing programs and services for homeless veterans; establishing memorials honoring veterans; and maintaining a future state veterans' cemetery. Funds from the account may not be used to supplant existing funds received by the department.

18 <u>NEW SECTION.</u> Sec. 5. This act takes effect July 1, 2017.
