- 1 AN ACT Relating to certain recreational guides; amending RCW
- 2 77.15.510, 77.65.010, 77.65.370, 77.65.440, 77.65.480, 77.65.500, and
- 3 77.65.560; and adding new sections to chapter 77.65 RCW.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 77.15.510 and 2009 c 333 s 10 are each amended to 6 read as follows:
- 7 (1) A person is guilty of acting as a game fish guide, food fish guide, or chartering without a license if:
- 9 (a) The person operates a charter boat and does not hold the 10 charter boat license required for the food fish taken;
- 11 (b) The person acts as a food fish guide and does not hold a food 12 fish guide license; or
- 13 (c) The person acts as a game fish guide and does not hold a game 14 fish guide license.
- 15 (2) Acting without a game fish guide license, food fish guide
- 16 license, or charter license is a gross misdemeanor. <u>Upon conviction</u>,
- 17 the department may deny applications submitted by the person for a
- 18 game fish guide license, food fish guide license, or charter boat
- 19 license for up to one year from the date of conviction.

1 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 77.65 2 RCW to read as follows:

- (1) In addition to other license suspension provisions provided 3 in this title, the department may suspend a charter boat license, 4 food fish guide license, or game fish guide license if, within a 6 twelve-month period, a person is convicted of two or more violations 7 of any rule of the commission or director regarding seasons, bag limits, species, size, sex, or other possession restrictions while engaged in charter boat, food fish guide, or game fish guide activities. The department may suspend only the specific type of 11 license or licenses related to the activity or activities for which 12 the person is convicted.
 - (2) A person who has a food fish guide or game fish guide license suspended under this section may file an appeal with the department pursuant to chapter 34.05 RCW. An appeal must be filed within twenty days of notice of license suspension. If a timely appeal is filed, the suspension issued by the department does not take effect until twenty-one days after the department has delivered an opinion affirming the suspension. If no appeal is filed within twenty days of notice of license suspension, the right to an appeal is waived, and the suspension takes effect twenty-one days following the notice of suspension.
- (3) License suspension under this section is in addition to any 23 24 statutory penalties assigned to the underlying violation.
- 25 RCW 77.65.010 and 2009 c 333 s 7 are each amended to read as follows: 26
 - (1) Except as otherwise provided by this title, a person must have a license or permit issued by the director in order to engage in any of the following activities:
 - (a) Commercially fish for or take food fish or shellfish;
- (b) Deliver from a commercial fishing vessel food fish or 31 shellfish taken for commercial purposes in offshore waters. As used 32 in this subsection, "deliver" means arrival at a place or port, and 33 includes arrivals from offshore waters to waters within the state and 34 35 arrivals from state or offshore waters;
- (c) Operate a charter boat or commercial fishing vessel engaged 36 37 in a fishery;
- (d) Engage in processing or wholesaling food fish or shellfish; 38 39 or

- engage in the activities described in (2) No person may 6 subsection (1) of this section unless the licenses or permits 7 required by this title are in the person's possession, and the person is the named license holder or an alternate operator designated on 8 the license and the person's license is not suspended.
- (3) A valid Oregon license that is equivalent to a license under 10 11 this title is valid in the concurrent waters of the Columbia river if the state of Oregon recognizes as valid the equivalent Washington 12 license. The director may identify by rule what Oregon licenses are 13 14 equivalent.
 - (4) No license or permit is required for the production or harvesting of private sector cultured aquatic products as defined in RCW 15.85.020 or for the delivery, processing, or wholesaling of such aquatic products. However, if a means of identifying such products is required by rules adopted under RCW 15.85.060, the exemption from licensing or permit requirements established by this subsection applies only if the aquatic products are identified in conformance with those rules.

 - (1) A person shall not offer or perform the services of a food fish guide without a food fish guide license in the taking of food fish for personal use ((in freshwater rivers and streams)), except that a charter boat license is required to operate a vessel from which a person may for a fee fish for food fish in state waters listed in RCW 77.65.150(4)(b).
- (2) A person shall not offer or perform the services of a game 31 fish guide without a game fish guide license in the taking of game 32 33 fish for personal use.
- (3) Only an individual at least sixteen years of age may hold a 34 35 food fish guide or game fish guide license. No individual may hold more than one food fish guide or game fish guide license. 36
- $((\frac{3}{3}))$ (4) An application for a food fish guide or game fish 37 guide license must include the information required in RCW 77.65.560. 38

- NEW SECTION. Sec. 5. A new section is added to chapter 77.65 RCW to read as follows:
 - (1) The department must issue an identifying decal to all food fish guides, game fish guides, and charter boat operators licensed under RCW 77.65.010. The identifying decal must display the license number prominently.
 - (2) Any person who acts or offers to act as a food fish guide, game fish guide, or charter boat operator must display the identifying decal on vessels in a location easily visible to customers and adjacent vessels.

- 30 (1) A fish guide combination license allows the holder to offer 31 or perform the services of a food fish guide, game fish guide, salmon 32 charter boat operator, and nonsalmon charter boat operator.
- 33 (2) The commission must adopt rules to create and sell a fish 34 guide combination license. The commission may adopt rules to create 35 and sell separate combination licenses, one for food fish and game 36 fish guide activities only and another combination license for all

- 8 (1) A taxidermy license allows the holder to practice taxidermy 9 for commercial purposes, as that term is defined in RCW 77.15.110.
- 10 The fee for this license is one hundred eighty dollars. The 11 application fee is seventy dollars.
- 12 (2) A fur dealer's license allows the holder to purchase, 13 receive, or resell raw furs for commercial purposes, as that term is 14 defined in RCW 77.15.110. The fee for this license is one hundred 15 eighty dollars. The application fee is seventy dollars.
- (3) ((A game fish guide license allows the holder to offer or perform the services of a game fish guide in the taking of game fish.

- ((+5)) (4) A game fish stocking permit allows the holder to release game fish into the waters of the state as prescribed by rule of the commission. The fee for this permit is twenty-four dollars. The application fee is seventy dollars.
- ((\(\frac{(+(+)}{6})\)) (\(\frac{(5)}{6}\)) A fishing or field trial permit allows the holder to promote, conduct, hold, or sponsor a fishing or field trial contest in accordance with rules of the commission. The fee for a fishing contest permit is twenty-four dollars. The fee for a field trial contest permit is twenty-four dollars. The application fee is seventy dollars.
