HB 1238-S by House Committee on Higher Education (originally sponsored by Representatives Pollet, Haler, Bergquist, Hargrove, Sells, Fitzgibbon, Fey, and Tarleton)

Concerning affordable tuition planning.

## (DIGEST OF PROPOSED 1ST SUBSTITUTE)

Declares it is the legislature's goal: (1) To use the total cost of attendance as a factor when considering student financial aid policy to accurately represent the true cost of higher education;

- (2) To make higher education accessible and affordable for all families; and
- (3) For tuition at public institutions of higher education to be no higher than ten percent of the median family income.

Requires the student achievement council, when it conducts its planning and outlines strategies, to report to the legislature on the affordability of the higher education system.

Expires June 30, 2017.

Creating the nurse educator pay it forward program.
(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Creates the nurse educator pay it forward program to provide greater access to higher education for registered nurses pursuing careers as educators.

Requires the student achievement council to develop and implement the program in collaboration with the nursing commission.

Creates the nurse educator pay it forward account.

HB 1346-S by House Committee on Environment

(originally sponsored by Representatives Blake, Takko, Sawyer, Appleton, and Buys)

Allowing additional hunting opportunities on state land. (DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires the parks and recreation commission to: (1) Conduct a pilot project exploring the feasibility, limitations, and benefits of allowing hunting in state parks; and

(2) Develop the pilot project in partnership with the department of fish and wildlife.

Requires the pilot project to allow some level of hunting activity in four state parks during the 2016, 2017, and 2018 calendar years.

Establishing a citizens' initiative review pilot program. (DIGEST OF PROPOSED 1ST SUBSTITUTE)

Establishes a pilot program for a citizen's review of initiatives in 2016.

Creates the citizens' initiative review oversight committee and requires the committee to: (1) Select two initiatives to be voted on at the general election for review by a citizen panel; and

(2) Review the work of the review panels to determine compliance with legislative intent.

Requires the voters' pamphlet to include statements submitted by citizens' initiative review panels.

Requires the state institute for public policy, after the 2016 general election, to contract for an evaluation of the effectiveness of the citizen initiative review process.

Expires July 1, 2017.

Concerning the linked deposit program.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Authorizes the director of the office of minority and women's business enterprises, with regard to the linked deposit program, to adopt rules to: (1) Ensure that certain businesses are given first priority when making a qualified loan under the program; and

(2) Develop reporting requirements for businesses receiving linked deposit loans.

Concerning competency to stand trial evaluations.

Modifies the department of social and health services' requirement to reimburse a county for the cost of competency to stand trial evaluations by qualified experts and professional persons.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Excludes from the definition of "net direct written premiums," for purposes of the Washington insurance guaranty association act, the premiums on policies issued through the Washington longshore and harbor workers' compensation act insurance assigned risk plan by its servicing carrier.

Requiring an analysis of regional higher education capacity to meet educational attainment goals.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires the student achievement council, collaboration with the state board for community and technical colleges, the public and private four-year institutions of higher education, the workforce training and education coordinating board, and the office of financial management, to conduct a study to assess the gap between the current availability of high school completion, certificate, associate, baccalaureate, and graduate higher education in various regions of the state and the capacity needed at higher education institutions to meet the state's educational attainment goals.

Expires July 1, 2017.

Revises involuntary treatment act provisions relating to the timing of emergency detentions and assessments.

Concerning industrial hemp.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Legalizes the agricultural production of industrial hemp and provides a regulatory framework that will ensure the security and safety of hemp crops.

Requires Washington State University to study the feasibility and desirability of industrial hemp production in

Creates the dedicated industrial hemp account.

# Concerning paint stewardship. (DIGEST OF PROPOSED 1ST SUBSTITUTE)

Creates an architectural paint recovery program that will be enforced by the department of ecology.

Requires all producers of architectural paint selling in or into the state to participate in an approved state paint stewardship plan.

Prohibits a producer or paint retailer from selling architectural paint in the state unless the producer or brand of architectural paint is participating in an approved stewardship plan.

Exempts from disclosure under the public records act, records filed with the department of ecology under this act that a court has determined are confidential valuable commercial information.

Creates the paint product stewardship account.

Creating a work group on occupational disease exposure for firefighters.

#### (DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires the department of labor and industries to convene a work group to discuss establishing definitions, policies, and procedures for mandatory reporting of hazardous exposures suffered in the course of employment by firefighters.

Expires January 31, 2016.

Addresses attorneys' fees and costs for certain claims under the industrial insurance laws.

**HB 1617-S** by House Committee on Judiciary (originally sponsored by Representatives Rodne, Goodman, and Jinkins)

Concerning the use of the judicial information system by courts before granting certain orders.

#### (DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires a court to consult the judicial information system or related databases, if available, before granting: (1) Certain orders under Title 26 RCW (domestic relations);

- (2) Orders regarding a vulnerable child, vulnerable adult, or alleged incapacitated person;
- (3) Letters of guardianship or administration or letters testamentary;
  - (4) Relief under Title 71 RCW (mental illness);
  - (5) Relief in certain juvenile proceedings; or
- (6) Orders of protection, temporary orders of protection, or criminal no-contact orders.

Controlling noxious weeds while still supporting pollenrich forage plant communities for honey bees.

## (DĬĞĒST OF PROPOSED 1ST SÚBSTITUTE)

Requires the state noxious weed control board to conduct a pilot project that evaluates the advantages of purposefully replacing pollen and nectar-rich noxious weeds with either native or noninvasive, nonnative forage plants that can produce similar levels of pollen and nectar to support honey bee populations.

Requires state agencies, while conducting planned projects, to give preference to replacing pollen-rich or nectar-rich noxious weeds with native forage plants that are beneficial for all pollinators, including honey bees.

Requires any corps project that involves the removal of noxious weeds to include the planting of pollen-rich and nectar-rich native plants to provide forage for all pollinators, including honey bees.

Establishing a Washington food policy forum.

## (DIGEST OF PROPOSED 1ST SUBSTITUTE)

Creates the Washington food policy forum as a public-private partnership.

Requires the forum to develop recommendations to advance certain food system goals.

Expires July 1, 2017.

HB 1793-S by House Committee on Agriculture & Natural Resources (originally sponsored by Representatives Lytton, Stanford, Fitzgibbon, Tharinger, and Morris)

Working within the existing in-stream flow rules adopted by the department of ecology to provide a suite of tools, applicable to property owners located in areas with limited access to legal new water withdrawals, for alternative water procurement that does not result in a net loss to area surface waters.

#### (DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires the governing body of each county and city with jurisdiction over property that is not eligible to be served by an approved water purveyor, and for which new, unmitigated use of surface or groundwater is not legally available on a year-round basis, to develop and adopt specific local ordinances outlining when and how alternative water sources may be used to satisfy certain adequate water supply requirements and other state or local potable water requirements for new construction.

Requires the department of ecology to coordinate with the appropriate local governmental entities and utility districts to identify possible capital projects that may assist in the legal provision of water to any properties using water in potential violation of the supreme court of Washington's October 3, 2013, opinion in *Swinomish Indian Tribal Community v. Washington State Department of Ecology* as of January 1, 2015.

Hunt, Wylie, Pike, Moeller, Nealey, Hawkins, Johnson, Condotta, Walsh, Fagan, Buys, Kretz, Santos, Fey, Tarleton, and Gregerson)

Addressing small loans and small consumer installment loans.

#### (DIGEST OF PROPOSED 1ST SUBSTITUTE)

Establishes the small consumer installment loan act. Addresses check cashers and sellers and small consumer installment loans.

#### **HB 2135** by Representative Appleton

Modifying Washington homeless client management information system requirements and policies.

Requires the department of commerce to provide technical assistance to a participating local government, or its designated subcontractor at the local level, that includes assistance to implement confidentiality and privacy policies and protocols relating to personal information collected and maintained about homeless individuals and families.

#### **HB 2136** by Representative Carlyle

Relating to comprehensive marijuana market reforms to ensure a well-regulated and taxed marijuana market in Washington state.

Declares an intent to enact legislation concerning comprehensive marijuana market reforms.

## HB 2137 by Representatives Cody and Harris

Concerning the nursing home payment system.

Declares an intent to: (1) Simplify the nursing home payment system through the elimination of rate add-ons;

- (2) Target funding to pay for quality workforce standards;
- (3) Correlate payments to the acuity and unique costs of the clients served; and
- (4) Promote a quality living environment for the increasingly medically complex population.

Requires the department of social and health services to complete a study by January 1, 2019, about the impact of new increased staffing standards on resident satisfaction, worker turnover, worker satisfaction, and resident health outcomes.

Makes appropriations.

HB 2138 by Representatives Reykdal, S. Hunt, Sells,

Providing cost-of-living adjustments for plan 1 retirees of the teachers' retirement system and public employees' retirement system.

Provides the same annual cost-of-living adjustment for plan 1 retirees of the teachers' retirement system and the public employees' retirement system as is provided for plan 2 and plan 3 members of those systems.

HB 2139 by Representatives S. Hunt, Kretz, and Muri; by request of Secretary of State

Modifying presidential primary provisions.

Modifies provisions relating to the presidential primary.

HB 2140 by Representatives Kagi, Orwall, Johnson, Walsh, Sells, Clibborn, Tarleton, Appleton, Ortiz-Self, Hargrove, Zeiger, Senn, Ormsby, Kilduff, Walkinshaw, and Goodman

Concerning good cause exceptions during permanency hearings.

Removes the expiration of certain "good cause exceptions" with regard to permanency planning hearings.

Feb 17 First reading, referred to Early Learning & Human Services (Not Officially read and referred until adoption of Introduction report).

# HB 2141 by Representatives Young, Caldier, and Condotta

Dedicating revenue from civil penalties associated with tolls for crossing the Tacoma Narrows bridge to repaying debt issued to construct the bridge.

Requires civil penalties deposited into the Tacoma Narrows toll bridge account that are in excess of amounts necessary to support the toll adjudication process applicable to toll collection on the Tacoma Narrows bridge to first be allocated toward paying bond obligations incurred in constructing the bridge.

Repeals RCW 47.46.140 (repayment of motor vehicle fund from toll charges).

## **HB 2142** by Representatives Young and Caldier

Providing for a sufficient minimum balance to cover Tacoma Narrows bridge operating expenses.

Prohibits toll charges, other revenue, and interest deposited into the Tacoma Narrows toll bridge account from being used to satisfy a requirement from the office of the state treasurer regarding a sufficient minimum balance as a contingency that would cover forty-five days of operating expenses.

Authorizes the office of the state treasurer to require that a sufficient minimum balance be retained in a state account or multiple state accounts to provide a contingency that would cover forty-five days of operating expenses for the Tacoma Narrows bridge only if the office has adopted a rule, in consultation with the transportation commission, requiring such a balance.

HB 2143 by Representatives Young, Caldier, and Condotta

Deferring the repayment of state sales and use tax on the Tacoma Narrows bridge project.

Delays the deadlines for repayment of the state sales and use taxes on the Tacoma Narrows bridge project.

#### -- 2015 REGULAR SESSION --

Feb 17 First reading, referred to Appropriations (Not Officially read and referred until adoption of Introduction report).

HB 2144 by Representatives Young, Caldier, and Condotta

Requiring that drivers pay only one toll on the Tacoma Narrows bridge for multiple crossings in one calendar day.

Requires the department of transportation to charge a customer only one toll for multiple crossings of the Tacoma Narrows bridge while traveling in the same vehicle in a single calendar day.

## **Senate Bills**

SB 5018-S by Senate Committee on Agriculture, Water & Rural Economic Development (originally sponsored by Senators Honeyford and Ericksen)

Concerning underground artificial storage and recovery projects.

## (DIGEST OF PROPOSED 1ST SUBSTITUTE)

Specifies that an underground artificial storage and recovery project is deemed to comply with state water quality standards for groundwater if the following requirements are met: (1) Water stored in the project is controlled so there is a high likelihood that the quantity of water stored will be available for recovery;

(2) Water stored in the project that is not recovered does not preclude groundwater from being used for beneficial uses in the future;

- (3) The project is protective of aquatic resources; and
