SB 6013.E - DIGEST

(DIGEST AS ENACTED)

Delays, until July 1, 2020, the expiration of the use tax exemption on nonprofit fund-raising activities.

Increases the use tax exemption, from ten thousand dollars to twelve thousand dollars, for any article of personal property purchased or received as a prize in a contest of chance from a nonprofit organization or a library.
