
HOUSE BILL 1771

State of Washington 65th Legislature 2017 Regular Session

1 AN ACT Relating to doctors of medical science; adding new
2 sections to chapter 18.71 RCW; and creating a new section.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 NEW SECTION. **Sec. 1.** This act may be known and cited as the
5 doctor of medical science act.

6 NEW SECTION. **Sec. 2.** A new section is added to chapter 18.71
7 RCW to read as follows:

8 For the purposes of this chapter, unless context clearly requires
9 otherwise:

10 (1) "Doctor of medical science" means an individual who is a
11 graduate of an accredited doctor of medical science program, lawfully
12 renders services, whether diagnostic or therapeutic, in the practice
13 of primary care, and has received a license under section 3 of this
14 act.

15 (2) "Doctor of medical science program" means a doctoral medical
16 program that trains physician assistants in advanced clinical
17 medicine and prepares physician assistants for clinical practice
18 equivalent to a medical doctor in the practice discipline of primary
19 care.

1 (3) "Physician assistant" has the same meaning as in RCW
2 18.71A.010.

3 NEW SECTION. **Sec. 3.** A new section is added to chapter 18.71
4 RCW to read as follows:

5 (1) The commission shall grant an applicant a license as a doctor
6 of medical science if the person:

7 (a) Previously has been licensed and served in primary care
8 clinical practice for at least three years in one or more states as a
9 physician assistant;

10 (b) Is a graduate of a minimum two-year doctor of medical science
11 program accredited by a regional body under the United States
12 department of education;

13 (c) Has successfully completed an examination, equivalent or
14 comparable to that of a physician or osteopathic physician, on the
15 certification of doctors of medical science, as determined by the
16 commission; and

17 (d) As determined by the commission pursuant to rules adopted
18 under section 4 of this act, provides satisfactory evidence of an
19 affiliation or association with a hospital, group practice, or a list
20 of physicians with medical expertise outside the expertise of the
21 person seeking licensure as a doctor of medical science.

22 (2) Upon the issuance of a license by the commission under this
23 section, the person receiving the license is entitled to practice in
24 any county of this state as a doctor of medical science.

25 (3) A person licensed as a doctor of medical science is subject
26 to the provisions of this chapter and rules or regulations adopted by
27 the commission.

28 (4) The commission shall provide for renewal of licenses for a
29 person licensed as a doctor of medical science under this chapter in
30 the same manner as provided for physicians under this chapter, with
31 the further requirement that the renewal application include evidence
32 of affiliation or association with a hospital or group practice, or a
33 list of physicians with medical expertise outside the expertise of
34 the licensee with whom the licensee is able to consult, on file with
35 the commission at the time of relicensing.

36 (a) Every licensed doctor of medical science shall biannually pay
37 a licensing renewal fee as set by the commission and provide evidence
38 to the commission that the licensee, in each year preceding the
39 application for renewal, successfully completed two hundred hours of

1 continuing medical education and meets all of the other licensing
2 requirements under this chapter.

3 (b) Each person licensed under this section shall be notified
4 prior to the due date of the renewal fee.

5 (5) When any licensed doctor of medical science fails to renew
6 his or her license and pay the biannual registration fee within sixty
7 days after registration becomes due, his or her license is
8 automatically revoked at the expiration of the sixty days after the
9 registration was required, without further notice or hearing.

10 (6) Any person whose license is automatically revoked under
11 subsection (5) of this section may apply in writing to the commission
12 for the reinstatement of his or her license, and, upon good cause
13 being shown, the commission, in its discretion, may reinstate the
14 license upon payment of all past due renewal fees and upon further
15 payment of a sum to be set by the commission.

16 (7)(a) Notwithstanding any provision of this chapter to the
17 contrary, the commission shall establish a system of license renewals
18 at alternative intervals that will allow for the distribution of the
19 license workload as uniformly as is practicable throughout the
20 calendar year.

21 (b) A renewal application may not be accepted after the last day
22 of the month following the license expiration date under the
23 alternative method authorized in this subsection.

24 NEW SECTION. **Sec. 4.** A new section is added to chapter 18.71
25 RCW to read as follows:

26 (1) Pursuant to authority granted under this chapter, the
27 commission may adopt rules related to the scope of practice,
28 application process, license renewal, penalties, and other areas the
29 commission determines necessary for licensed doctors of medical
30 science.

31 (2) The commission may also establish a committee on doctors of
32 medical science to assist with the adoption of rules and regulations.
33 Any rules and regulations adopted by the commission must comply with
34 the administrative procedure act, chapter 34.05 RCW.
