1       AN ACT Relating to authorizing licensed spirits and wine  
2 distributors to sell spirits and wine products to their employees in  
3 certain circumstances; and adding a new section to chapter 66.28 RCW.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5       NEW SECTION.   **Sec. 1.** A new section is added to chapter 66.28  
6 RCW to read as follows:

7       (1) A person holding a spirits distributor license issued  
8 pursuant to RCW 66.24.055 may sell spirits directly to bona fide,  
9 full-time employees, subject to the following requirements:

10       (a) No spirits may be sold under this section unless they are in  
11 such condition that they cannot reasonably be sold in the normal  
12 course of business, such as, for example, because of damage to the  
13 labels on individual bottles;

14       (b) No spirits may be sold under this section for less than the  
15 spirits distributor licensee's cost of acquisition;

16       (c) All sales of spirits made under this section are subject to  
17 the license issuance fee established by RCW 66.24.630(4) and the  
18 taxes imposed on a retail sale under RCW 82.08.150;

19       (d) No spirits may be sold under this section to a person who has  
20 been employed by the spirits distributor licensee for less than

1 ninety days at the time of the sale or who is under the age of  
2 twenty-one;

3 (e) No person purchasing spirits under this section may sell such  
4 spirits by the drink or otherwise to a third person, or otherwise  
5 dispose of all or any part of such spirits in any manner or for any  
6 purpose other than personal use; and

7 (f) No spirits may be sold under this section by a person holding  
8 any license other than a spirits distributor license, whether or not  
9 the license held by such person permits the sale of spirits to  
10 consumers.

11 (2) A person holding a wine distributor license issued pursuant  
12 to RCW 66.24.200 may sell wine directly to bona fide, full-time  
13 employees, subject to the following requirements:

14 (a) No wine may be sold under this section unless it is in such  
15 condition that it cannot reasonably be sold in the normal course of  
16 business, such as, for example, because of damage to the labels on  
17 individual bottles;

18 (b) No wine may be sold under this section for less than the wine  
19 distributor licensee's cost of acquisition;

20 (c) All sales of wine made under this section are subject to the  
21 same taxes that would be applicable if the sale were made to a  
22 consumer;

23 (d) No wine may be sold under this section to a person who has  
24 been employed by the wine distributor licensee for less than ninety  
25 days at the time of the sale or who is under the age of twenty-one;

26 (e) No person purchasing wine under this section may sell such  
27 wine by the glass or otherwise to a third person, or otherwise  
28 dispose of all or any part of such wine in any manner or for any  
29 purpose other than personal use; and

30 (f) No wine may be sold under this section by a person holding  
31 any license other than a wine distributor license, whether or not the  
32 license held by such person permits the sale of wine to consumers.
