1 AN ACT Relating to making financial services available to
2 marijuana producers, processors, retailers, qualifying patients,
3 health care professionals, and designated providers as authorized
4 under chapters 69.50 and 69.51A RCW; and adding a new section to
5 chapter 9.01 RCW.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 NEW SECTION. **Sec. 1.** A new section is added to chapter 9.01 RCW
8 to read as follows:

9 (1) A person or entity that receives deposits, extends credit,
10 conducts funds transfers, transports cash or financial instruments on
11 behalf of a financial institution, or provides other financial
12 services for a marijuana producer, marijuana processor, or marijuana
13 retailer authorized under chapter 69.50 RCW or for a qualifying
14 patient, health care professional, or designated provider authorized
15 under chapter 69.51A RCW, does not commit a crime under any
16 Washington law solely by virtue of receiving deposits, extending
17 credit, conducting funds transfers, transporting cash or other
18 financial instruments, or providing other financial services for the
19 person.

20 (2) For the purposes of this section, "person or entity" means a
21 financial institution as defined in RCW 30A.22.040, an armored car

1 service operating under a permit issued by the utilities and
2 transportation commission that has been contracted by a financial
3 institution, or a person providing financial services pursuant to a
4 license issued under chapter 18.44, 19.230, or 31.04 RCW.

5 (3) A certified public accountant or certified public accounting
6 firm, which practices public accounting as defined in RCW 18.04.025,
7 does not commit a crime solely for providing professional accounting
8 services as specified in RCW 18.04.025 for a marijuana producer,
9 marijuana processor, or marijuana retailer authorized under chapter
10 69.50 RCW.
