1 AN ACT Relating to accessible parking spaces for people with
2 disabilities; adding a new section to chapter 19.27 RCW; and
3 providing an effective date.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 NEW SECTION. **Sec. 1.** A new section is added to chapter 19.27
6 RCW to read as follows:

7 (1) In addition to the requirements under RCW 46.61.581, each
8 accessible parking space reserved for a person with a physical
9 disability and designated as "van accessible" under the Americans
10 with disabilities act must have a ninety-six inch or greater adjacent
11 access aisle. The adjacent access aisle space must be in addition to
12 the adjacent van parking space. Two van accessible parking spaces may
13 share a common adjacent access aisle.

14 (2) A sign must be erected at the head of each access aisle that
15 prohibits parking in any access aisle located adjacent to an
16 accessible parking space reserved for a person with a physical
17 disability. The sign may include additional language such as, but not
18 limited to, an indication of any penalty for parking in an access
19 aisle.

1 (3) By January 1, 2018, the building code council shall adopt
2 rules to implement in the building code the access aisle width and
3 access aisle marking requirements of this section.

4 NEW SECTION. **Sec. 2.** This act takes effect January 1, 2018.
