- 7 **Sec. 1.** RCW 43.155.010 and 1996 c 168 s 1 are each amended to 8 read as follows:
- 9 The legislature finds that there exists in the state of
- 10 Washington over four billion dollars worth of critical projects for
- 11 the planning, acquisition, construction, repair, replacement,
- 12 rehabilitation, or improvement of streets and roads, bridges, water
- 13 systems, and storm and sanitary sewage systems. The December, 1983
- 14 Washington state public works report prepared by the planning and
- 15 community affairs agency documented that local governments expect to
- 16 be capable of financing over two billion dollars worth of the costs
- 17 of those critical projects but will not be able to fund nearly half
- 18 of the documented needs.
- 19 The legislature further finds that Washington's local governments
- 20 have unmet financial needs for solid waste disposal, including

recycling, and encourages the board to make an equitable geographic distribution of the funds.

It is the policy of the state of Washington to encourage self-reliance by local governments in meeting their public works needs and to assist in the financing of critical public works projects by making loans, grants, financing guarantees, and technical assistance available to local governments for these projects.

- 8 **Sec. 2.** RCW 43.155.020 and 2009 c 565 s 33 are each amended to 9 read as follows:
- ((Unless the context clearly requires otherwise,)) <u>The</u>
  definitions in this section ((shall)) apply throughout this chapter
  unless the context clearly requires otherwise.
- 13 (1) "Board" means the public works board created in RCW 14 43.155.030.
- 15 (2) "Capital facility plan" means a capital facility plan 16 required by the growth management act under chapter 36.70A RCW or, 17 for local governments not fully planning under the growth management 18 act, a plan required by the public works board.
- 19 (3) "Department" means the department of commerce.
- 20 (4) "Financing guarantees" means the pledge of money in the 21 public works assistance account, or money to be received by the 22 public works assistance account, to the repayment of all or a portion 23 of the principal of or interest on obligations issued by local 24 governments to finance public works projects.
  - (5) "Local governments" means cities, towns, counties, special purpose districts, and any other municipal corporations or quasimunicipal corporations in the state excluding school districts and port districts.
- (6) "Public works project" means a project of a local government 29 30 for the planning, acquisition, construction, repair, reconstruction, replacement, rehabilitation, or improvement of streets and roads, 31 bridges, water systems, or storm and sanitary sewage systems, lead 32 remediation of drinking water systems, and solid waste facilities, 33 including recycling facilities. A planning project may include the 34 35 compilation of biological, hydrological, or other data on a county, drainage basin, or region necessary to develop a base of information 36 37 for a capital facility plan.
- 38 (7) "Solid waste or recycling project" means remedial actions 39 necessary to bring abandoned or closed landfills into compliance with

- regulatory requirements and the repair, restoration, and replacement of existing solid waste transfer, recycling facilities, and landfill projects limited to the opening of landfill cells that are in existing and permitted landfills.
- 5 (8) "Technical assistance" means training and other services 6 provided to local governments to: (a) Help such local governments 7 plan, apply, and qualify for loans, grants, and financing guarantees 8 from the board, and (b) help local governments improve their ability 9 to plan for, finance, acquire, construct, repair, replace, 10 rehabilitate, and maintain public facilities.
- 11 (9) "Value planning" means a uniform approach to assist in 12 decision making through systematic evaluation of potential 13 alternatives to solving an identified problem.

- 17 (2) The board shall be composed of <u>seventeen members as provided</u> 18 in this subsection:
  - (a) Thirteen members appointed by the governor for terms of four years, except that five members initially shall be appointed for terms of two years. ((The board)) These members shall include: ((The board))Three)) (i) Two members, ((two)) one of whom shall be an elected official((s)) and one shall be a public works manager or a finance director, appointed from a list of at least six persons nominated by ((the)) a state association of ((Washington)) cities or its successor; ((\(\frac{t}{b}\) \text{three})) \(\((ii)\) \text{two}\) members, \((\text{two})\) \(\frac{one}{one}\) of whom shall be  $\underline{an}$  elected official((s)) and one shall be a public works manager or a finance director, appointed from a list of at least six persons nominated by ((the Washington)) a state association of counties or its successor; ((<del>(c) three</del>)) <u>(iii) one</u> member((s)) appointed from a list of at least ((six)) three persons nominated ((jointly)) by ((the Washington)) a state association of public utility districts ((association and)) or its successor; (iv) one member appointed from a list of at least three persons nominated by a state association of water-sewer districts( $(\tau)$ ) or ((their)) its successor((s)); and ((their)) four)) (v) seven members appointed from the general public with expertise in relevant fields. - with special expertise in relevant fields such as public finance, architecture and civil engineering, and public works construction. The governor shall appoint one of the general public members of the board as chair. The term of the chair shall coincide with the term of the governor.
- 6 (b) Four members from the legislature appointed for terms of four 7 years. Any members of the board, appointive or otherwise, may be removed by the governor for cause in accordance with RCW 43.06.070 and 43.06.080.

- (4) Develop a program that provides grants and additional assistance to leverage federal programs, and other opportunities to target deeper financial assistance to communities with economic distress or projects that would result in rate increases to residential utility rates that exceed a determined percentage of median household income;
- 11 (5) Adopt rules under chapter 34.05 RCW as necessary to carry out 12 the purposes of this chapter;
- (((+5))) (6) Do all acts and things necessary or convenient to carry out the powers expressly granted or implied under this chapter.
- 15 **Sec. 5.** RCW 43.155.050 and 2015 3rd sp.s. c 4 s 959 and 2015 3rd sp.s. c 3 s 7032 are each reenacted and amended to read as follows:

The public works assistance account is hereby established in the state treasury. Money may be placed in the public works assistance account from the proceeds of bonds when authorized by the legislature or from any other lawful source. Money in the public works assistance account shall be used to make loans and grants and to give financial guarantees to local governments for public works projects. Moneys in the account may also be appropriated or transferred to the water pollution control revolving account and the drinking water assistance account to provide for state match requirements under federal law ((for projects and activities conducted and financed by the board under the drinking water assistance account)). Not more than ((fifteen)) percent of the biennial capital budget twenty appropriation to the public works board from this account may be expended or obligated for preconstruction loans and grants, emergency loans and grants, or loans and grants for capital facility planning under this chapter((; of this amount, not more than ten percent of the biennial capital budget appropriation may be expended for emergency loans and not more than one percent of the biennial capital budget appropriation may be expended for capital facility planning loans)). Not more than ten percent of the biennial capital budget appropriation to the public works board from this account may be expended or obligated as grants for preconstruction, emergency, capital facility planning, and construction projects. 1 2015-2017 fiscal biennium, the legislature may transfer from the public works assistance account to the general fund, the water 2 pollution control revolving account, and the drinking 3 assistance account such amounts as reflect the excess fund balance of 4 the account. ((During the 2013-2015 fiscal biennium, the legislature 5 б may transfer from the public works assistance account to the 7 education legacy trust account such amounts as specified by the legislature.)) During the 2015-2017 fiscal biennium, the legislature 8 9 may appropriate moneys from the account for activities related to the growth management act and the voluntary stewardship program. During 10 11 the 2015-2017 fiscal biennium, the legislature may transfer from the 12 public works assistance account to the state general fund such 13 amounts as specified by the legislature. - (((1))) (a) Make ((low-interest or interest-free)) loans or grants to local governments from the public works assistance account or other funds and accounts for the purpose of assisting local governments in financing public works projects. ((The board may require such terms and conditions and may charge such rates of interest on its loans as it deems necessary or convenient to carry out the purposes of this chapter.)) Money received from local governments in repayment of loans made under this section shall be paid into the public works assistance account for uses consistent with this chapter.
- $((\frac{1}{2}))$  (b) Pledge money in the public works assistance account, or money to be received by the public works assistance account, to the repayment of all or a portion of the principal of or interest on obligations issued by local governments to finance public works projects. The board shall not pledge any amount greater than the sum of money in the public works assistance account plus money to be received from the payment of the debt service on loans made from that account, nor shall the board pledge the faith and credit or the

taxing power of the state or any agency or subdivision thereof to the repayment of obligations issued by any local government.

- $((\frac{3}{3}))$  (c) Create such subaccounts in the public works assistance account as the board deems necessary to carry out the purposes of this chapter.
  - ((4))) (d) Provide a method for the allocation of loans, grants, and financing guarantees and the provision of technical assistance under this chapter.
  - (2) When establishing interest rates for loan programs authorized in this chapter for projects which are supported by a rate base of at least fifty thousand equivalent residential units, the board must base interest rates on the average daily market interest rate for tax-exempt municipal bonds as published in the bond buyer's index for the period from sixty to thirty days before the start of the application cycle.
- 16 <u>(a) For projects with a repayment period between five and twenty</u>
  17 years, the rate must be fifty percent of the market rate.
  - (b) For projects with a repayment period under five years, the rate must be twenty-five percent of the market rate.
  - (c) For any year in which the average daily market interest rate for tax-exempt municipal bonds for the period from sixty to thirty days before the start of an application cycle is nine percent or greater, the board may cap interest rates at four percent for projects with a repayment period between five and twenty years and at two percent for projects with a repayment period under five years.
  - (d) The board may also provide reduced interest rates, extended repayment periods, or grants for projects that meet financial hardship criteria as measured by the affordability index or similar standard measure of financial hardship. The board may provide reduced interest rates, extended repayment periods, or grants for projects that are supported by a rate base of less than fifty thousand equivalent residential units.
  - (3) All local public works projects aided in whole or in part under the provisions of this chapter shall be put out for competitive bids, except for emergency public works under RCW 43.155.065 for which the recipient jurisdiction shall comply with this requirement to the extent feasible and practicable. The competitive bids called for shall be administered in the same manner as all other public works projects put out for competitive bidding by the local governmental entity aided under this chapter.

**Sec. 7.** RCW 43.155.065 and 2001 c 131 s 3 are each amended to 2 read as follows:

The board may make low-interest or interest-free loans or grants to local governments for emergency public works projects. Emergency public works projects shall include the construction, repair, reconstruction, replacement, rehabilitation, or improvement of public water system that is in violation of health and safety standards and is being operated by a local government on a temporary basis. The loans or grants may be used to help fund all or part of an emergency public works project less any reimbursement from any of the following sources: (1) Federal disaster or emergency funds, including funds from the federal emergency management agency; (2) disaster or emergency funds; (3) insurance settlements; or (4) litigation.

**Sec. 8.** RCW 43.155.068 and 2001 c 131 s 4 are each amended to 16 read as follows:

- (1) The board may make ((low-interest or interest-free)) loans or grants to local governments for preconstruction activities on public works projects before the legislature approves the construction phase of the project. Preconstruction activities include design, engineering, bid-document preparation, environmental studies, right-of-way acquisition, value planning, and other preliminary phases of public works projects as determined by the board. The purpose of the loans and grants authorized in this section is to accelerate the completion of public works projects by allowing preconstruction activities to be performed before the ((approval of)) appropriation for the construction phase of the project by the legislature.
- (2) Projects receiving loans <u>or grants</u> for preconstruction activities under this section must be evaluated using the priority process and factors in RCW 43.155.070((<del>(2)</del>)). The receipt of a loan <u>or grant</u> for preconstruction activities does not ensure the receipt of a construction loan <u>or grant</u> for the project under this chapter. Construction loans <u>or grants</u> for projects receiving a loan <u>or grant</u> for preconstruction activities under this section are subject to legislative ((<del>approval</del>)) <u>appropriation</u> under RCW 43.155.070 ((<del>(4)</del>) and <del>(5)</del>)) <u>(7)</u>. The board shall adopt a single application process for local governments seeking both a loan <u>or grant</u> for preconstruction activities under this section and a construction loan for the project.

- (1) To qualify for financial assistance under this chapter the board must determine that a local government meets all of the following conditions:
- 6 (a) The city or county must be imposing a tax under chapter 82.46 7 RCW at a rate of at least one-quarter of one percent;
- 8 (b) The local government must have developed a capital facility 9 plan; and
  - (c) The local government must be using all local revenue sources which are reasonably available for funding public works, taking into consideration local employment and economic factors.
    - (2) Except where necessary to address a public health need or substantial environmental degradation, a county, city, or town planning under RCW 36.70A.040 may not receive financial assistance under this chapter unless it has adopted a comprehensive plan, including a capital facilities plan element, and regulations as required by RCW 36.70A.040. This subsection does not require any county, city, or town planning under RCW 36.70A.040 to adopt a comprehensive plan or development regulations before requesting or receiving financial assistance under this chapter if such request is made before the expiration of the time periods specified in RCW 36.70A.040. A county, city, or town planning under 36.70A.040 that has not adopted a comprehensive plan and development regulations within the time periods specified in RCW 36.70A.040 may apply for and receive financial assistance under this chapter if the comprehensive plan and development regulations are adopted as required by RCW 36.70A.040 before executing a contractual agreement for financial assistance with the board.
    - (3) In considering awarding financial assistance for public facilities to special districts requesting funding for a proposed facility located in a county, city, or town planning under RCW 36.70A.040, the board must consider whether the county, city, or town planning under RCW 36.70A.040 in whose planning jurisdiction the proposed facility is located has adopted a comprehensive plan and development regulations as required by RCW 36.70A.040.
- (4) ((The board must develop a priority process for public works
  projects as provided in this section. The intent of the priority
  process is to maximize the value of public works projects
  accomplished with assistance under this chapter. The board must

attempt to assure a geographical balance in assigning priorities to projects. The board must consider at least the following factors in assigning a priority to a project:

- (a) Whether the local government receiving assistance has experienced severe fiscal distress resulting from natural disaster or emergency public works needs;
- (b) Except as otherwise conditioned by RCW 43.155.110, whether the entity receiving assistance is a Puget Sound partner, as defined in RCW 90.71.010;
- (c) Whether the project is referenced in the action agenda developed by the Puget Sound partnership under RCW 90.71.310;
- (d) Whether the project is critical in nature and would affect the health and safety of a great number of citizens;
- (e) Whether the applicant's permitting process has been certified as streamlined by the office of regulatory assistance;
- (f) Whether the applicant has developed and adhered to guidelines regarding its permitting process for those applying for development permits consistent with section 1(2), chapter 231, Laws of 2007;
- (g) The cost of the project compared to the size of the local government and amount of loan money available;
  - (h) The number of communities served by or funding the project;
- (i) Whether the project is located in an area of high unemployment, compared to the average state unemployment;
  - (j) Whether the project is the acquisition, expansion, improvement, or renovation by a local government of a public water system that is in violation of health and safety standards, including the cost of extending existing service to such a system;
  - (k) Except as otherwise conditioned by RCW 43.155.120, and effective one calendar year following the development of model evergreen community management plans and ordinances under RCW 35.105.050, whether the entity receiving assistance has been recognized, and what gradation of recognition was received, in the evergreen community recognition program created in RCW 35.105.030;
  - (1) The relative benefit of the project to the community, considering the present level of economic activity in the community and the existing local capacity to increase local economic activity in communities that have low economic growth; and
    - (m) Other criteria that the board considers advisable.

- 1 (5) For the 2015-2017 fiscal biennium, in place of the criteria,
  2 ranking, and submission processes for construction loan lists
  3 provided in subsections (4) and (7) of this section:)
- (a) The board must develop a process ((for numerically ranking))
  to prioritize applications ((for construction)) and funding of loans
  and grants for public works projects submitted by local governments.

- (xi) Whether the applicant sought or is seeking funding for the project from other sources; and
- 8 <u>(xii)</u> Other criteria that the board considers necessary to 9 achieve the purposes of this chapter.
  - (b) Before ((November)) September 1, ((2016)) 2018, and each year thereafter, the board must develop and submit a report regarding the construction loans and grants to the office of financial management and appropriate fiscal committees of the senate and house of representatives ((a ranked list of qualified public works projects which have been evaluated by the board and are recommended for funding by the legislature)). The report must include:
- 17 <u>(i) The total number of applications and amount of funding</u>
  18 <u>requested for public works projects;</u>
- (ii) A list and description of projects approved in the preceding
  fiscal year with project scores against the board's prioritization
  criteria;

- 35 (6))) (5) Existing debt or financial obligations of local governments may not be refinanced under this chapter. Each local government applicant must provide documentation of attempts to secure additional local or other sources of funding for each public works project for which financial assistance is sought under this chapter.

1 ((<del>(7)</del>)) (6) Before ((November)) <u>September</u> 1st of each ((evennumbered)) year, the board must develop and submit to the appropriate 2 fiscal committees of the senate and house of representatives a 3 description of the loans and grants made under RCW 43.155.065( $(\frac{1}{7})$ ) 4 and 43.155.068((, and subsection (10) of this section during the 5 6 preceding fiscal year and a prioritized list of projects which are recommended for funding by the legislature, including one copy to the 7 staff of each of the committees. The list must include, but not be 8 limited to, a description of each project and recommended financing, 9 the terms and conditions of the loan or financial guarantee, the 10 11 local government jurisdiction and unemployment rate, demonstration of 12 the jurisdiction's critical need for the project and documentation of local funds being used to finance the public works project. The list 13 must also include measures of fiscal capacity for each jurisdiction 14 recommended for financial assistance, compared to authorized limits 15 16 and state averages, including local government sales taxes; real 17 estate excise taxes; property taxes; and charges for or taxes on 18 sewerage, water, garbage, and other utilities)).

Note: Governor's explanation of partial veto is as follows:

"I am returning herewith, without my approval as to Section 3, Engrossed Substitute House Bill No. 1677 entitled:

"AN ACT Relating to local government infrastructure funding."

This bill provides targeted reforms to the Public Works Assistance Account and directs the Public Works Board (Board) to study new and innovative financing tools. This bill will help local governments in need of financial support and provide additional tools to pay for basic infrastructure needs.

I am, however, vetoing Section 3, which modifies the composition of the Board. Section 3 adds four legislators. Changes to the Board's composition should be based on a member's skill set, rather than organizational representation. I would support the addition of legislators to the Board as ex-offico and non-voting members.

For these reasons I have vetoed Section 3 of Engrossed Substitute House Bill No. 1677.

With the exception of Section 3, Engrossed Substitute House Bill No. 1677 is approved."
