AN ACT Relating to creating Patches pal special license plates; amending RCW 46.18.200, 46.17.220, and 46.68.420; adding a new section to chapter 46.04 RCW; and providing an effective date.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 46.18.200 and 2018 c 67 s 5 are each amended to read 6 as follows:

7 (1) Special license plate series reviewed and approved by the 8 department:

9 (a) May be issued in lieu of standard issue or personalized 10 license plates for vehicles required to display one and two license 11 plates unless otherwise specified;

12 (b) Must be issued under terms and conditions established by the 13 department;

14 (c) Must not be issued for vehicles registered under chapter 15 46.87 RCW; and

16 (d) Must display a symbol or artwork approved by the department.

17 (2) The department approves and shall issue the following special 18 license plates:

31 (3) Applicants for initial and renewal professional firefighters 32 and paramedics special license plates must show proof of eligibility 33 by providing a certificate of current membership from the Washington 34 state council of firefighters.

35 (4) Applicants for initial volunteer firefighters special license 36 plates must (a) have been a volunteer firefighter for at least ten 37 years or be a volunteer firefighter for one or more years and (b) 38 have documentation of service from the district of the appropriate

fire service. If the volunteer firefighter leaves firefighting 1 service before ten years of service have been completed, the 2 volunteer firefighter shall surrender the license plates to the 3 department on the registration renewal date. If the volunteer 4 firefighter stays in service for at least ten years and then leaves, 5 6 the license plate may be retained by the former volunteer firefighter 7 and as long as the license plate is retained for use the person will continue to pay the future registration renewals. A qualifying 8 volunteer firefighter may have no more than one set of license plates 9 per vehicle, and a maximum of two sets per applicant, for their 10 11 personal vehicles. If the volunteer firefighter is convicted of a 12 violation of RCW 46.61.502 or a felony, the license plates must be surrendered upon conviction. 13

14 Sec. 2. RCW 46.17.220 and 2018 c 67 s 4 are each amended to read 15 as follows:

In addition to all fees and taxes required to be paid upon application for a vehicle registration in chapter 46.16A RCW, the holder of a special license plate shall pay the appropriate special license plate fee as listed in this section.

15 Sec. 3. RCW 46.68.420 and 2018 c 67 s 2 are each amended to read 16 as follows:

17 (1) The department shall:

18 (a) Collect special license plate fees established under RCW19 46.17.220;

20 (b) Deduct an amount not to exceed twelve dollars for initial 21 issue and two dollars for renewal issue for administration and 22 collection expenses incurred by it; and

23 (c) Remit the remaining proceeds to the custody of the state 24 treasurer with a proper identifying detailed report.

25 (2) The state treasurer shall credit the proceeds to the motor 26 vehicle account until the department determines that the state has 27 been reimbursed for the cost of implementing the special license 28 plate. Upon determination by the department that the state has been 29 reimbursed, the state treasurer shall credit the remaining special 30 license plate fee amounts for each special license plate to the 31 following appropriate account as created in this section in the 32 custody of the state treasurer:

7 (3) Except as otherwise provided in this section, only the 8 director or the director's designee may authorize expenditures from 9 the accounts described in subsection (2) of this section. The 10 accounts are subject to allotment procedures under chapter 43.88 RCW, 11 but an appropriation is not required for expenditures.

12 (4) Except as otherwise provided in this section, funds in the 13 special license plate accounts described in subsection (2) of this 14 section must be disbursed subject to the conditions described in this section and under contract between 15 subsection (2) of the 16 department and qualified nonprofit organizations that provide the 17 services described in subsection (2) of this section.

18 (5) Funds from the Seattle Seahawks account may be provided to 19 the lieutenant governor solely for the purpose of administering the 20 Washington world fellows program. Of the amounts received by the 21 lieutenant governor's office under this subsection, at least ninety 22 percent must be provided as fellowships under the program.

(6) Beginning January 1, 2019, funds from the Seattle Mariners account may be provided to the office of lieutenant governor solely for the purpose of administering the sports mentoring program. Of the amounts received by the office of lieutenant governor, at least ninety percent must be applied towards services directly provided to youth participants.

(7) For the purposes of this section, a "qualified nonprofit organization" means a not-for-profit corporation operating in Washington that has received a determination of tax exempt status under 26 U.S.C. Sec. 501(c)(3). The qualified nonprofit organization must meet all the requirements under RCW 46.18.100(1).

34 <u>NEW SECTION.</u> Sec. 4. A new section is added to chapter 46.04 35 RCW to read as follows:

36 "Patches pal license plates" means special license plates issued 37 under RCW 46.18.200 that display the likenesses of the J.P. Patches 38 and Gertrude characters from the J.P. Patches show.
