1 AN ACT Relating to establishing a statewide free college program
2 by changing the state need grant to the Washington college promise
3 scholarship; amending RCW 28B.92.030, 28B.15.820, 43.88C.010,
4 28B.10.790, 28B.12.030, 28B.92.040, 28B.92.065, 28B.15.065,
5 28B.15.740, 28B.15.760, 28B.15.762, 28B.116.010, 28A.180.120,
6 28B.76.502, 28B.76.525, 28B.76.526, 28B.76.540, 28B.76.699,
7 28B.77.020, 28B.117.020, 28B.118.090, 28B.133.010, 28B.133.020, and
8 28C.18.166; reenacting and amending RCW 28B.108.010, 28B.118.010,
9 28B.145.010, and 28B.145.030; adding new sections to chapter 28B.92
10 RCW; repealing RCW 28B.92.010, 28B.92.020, 28B.92.050, 28B.92.060,
11 28B.92.080, 28B.92.082, 28B.92.084, 28B.119.005, 28B.119.010,

14 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

15 **PART I**
16 **CREATES THE WASHINGTON COLLEGE PROMISE SCHOLARSHIP**
17 **PROGRAM TO REPLACE THE STATE NEED GRANT PROGRAM**

18 NEW SECTION. **Sec. 1.** A new section is added to chapter 28B.92
19 RCW to read as follows:

1 (1) The legislature finds that individuals with a postsecondary
2 credential have a greater chance of earning a wage that can support
3 themselves and their families than if they do not obtain a
4 postsecondary credential. At the same time, Washington employers are
5 in need of many more individuals who possess postsecondary
6 qualifications. Access to postsecondary opportunities are vital to
7 ensure that more Washington high school graduates and working adults
8 can enter and complete a postsecondary program and compete for the
9 job opportunities available in the state.

10 (2) The legislature further finds that a statewide free college
11 program, for students who demonstrate financial need as defined in
12 section 3 of this act, is necessary to significantly reduce the
13 financial costs of obtaining a postsecondary credential. The
14 Washington college promise scholarship program is intended to
15 increase access to postsecondary opportunities for Washington
16 residents.

17 NEW SECTION. **Sec. 2.** A new section is added to chapter 28B.92
18 RCW to read as follows:

19 (1) The Washington college promise scholarship program is created
20 to provide a statewide free college program for eligible participants
21 and greater access to postsecondary education for Washington
22 residents. The Washington college promise scholarship program is
23 intended to increase the number of high school graduates and adults
24 that can attain a postsecondary credential and provide them with the
25 qualifications needed to compete for job opportunities in Washington.

26 (2) The office of student financial assistance shall implement
27 and administer the Washington college promise scholarship program and
28 is authorized to establish rules necessary for implementation of the
29 program.

30 (3) Except as provided in subsection (13) of this section, the
31 legislature shall appropriate funding for the Washington college
32 promise scholarship program. Allocations must be made on the basis of
33 estimated eligible participants enrolled in eligible institutions of
34 higher education or apprenticeship programs. Except as provided in
35 subsection (13) of this section, all eligible students are entitled
36 to a Washington college promise scholarship.

37 (4) The office shall award Washington college promise
38 scholarships to all eligible students beginning in academic year
39 2021-22.

1 (5) To be eligible for the Washington college promise
2 scholarship, students must meet the following requirements:

3 (a) Demonstrate financial need under section 3 of this act;

4 (b) (i) Be enrolled or accepted for enrollment for at least three
5 quarter credits or the equivalent semester credits at an institution
6 of higher education in Washington as defined in RCW 28B.92.030; or

7 (ii) Be enrolled in a registered apprenticeship program approved
8 under chapter 49.04 RCW;

9 (c) (i) Be a resident student as defined in RCW 28B.15.012(2) (a)
10 through (e); or

11 (ii) Be a student who has:

12 (A) Completed the full senior year of high school and obtained a
13 high school diploma, or the equivalent, either at a Washington public
14 high school or private high school approved under chapter 28A.195
15 RCW;

16 (B) Lived in Washington state for at least three years
17 immediately before receiving the diploma or its equivalent;

18 (C) Continuously lived in Washington state after receiving the
19 diploma or its equivalent and until such time as the individual is
20 admitted to an eligible institution of higher education; and

21 (D) Been granted deferred action for childhood arrival status
22 pursuant to the rules and regulations adopted by the United States
23 citizenship and immigration services;

24 (d) File an annual application for financial aid as approved by
25 the office; and

26 (e) Must not have earned a baccalaureate degree or higher from a
27 postsecondary institution.

28 (6) Washington college promise scholarship eligibility may not
29 extend beyond five years or one hundred twenty-five percent of the
30 published length of the program in which the student is enrolled or
31 the credit or clock-hour equivalent.

32 (7) Institutional aid administrators shall determine whether a
33 student eligible for the Washington college promise scholarship in a
34 given academic year may remain eligible for the ensuing year if the
35 student's family income increases by no more than three percent.

36 (8) Qualifications for receipt and renewal include maintaining
37 satisfactory academic progress toward completion of an eligible
38 program as determined by the office and established in rule.

39 (9) Should a recipient terminate his or her enrollment for any
40 reason during the academic year, the unused portion of the

1 scholarship shall be returned to the state educational grant fund by
2 the institution of higher education according to the institution of
3 higher education's policy for issuing refunds, except as provided in
4 RCW 28B.92.070.

5 (10) An eligible student enrolled on a part-time basis shall
6 receive a prorated portion of the Washington college promise
7 scholarship for any academic period in which he or she is enrolled on
8 a part-time basis.

9 (11) The Washington college promise scholarship is intended to be
10 used to meet the costs of postsecondary education for students with
11 financial need. The student shall be awarded all need-based financial
12 aid for which the student qualifies as determined by the institution.

13 (12) Students and participating institutions of higher education
14 shall comply with all the rules adopted by the council for the
15 administration of this chapter.

16 (13) The requirements in subsection (3) of this section do not
17 apply in a fiscal year immediately following a five quarter period in
18 which personal income declined in at least two consecutive quarters,
19 according to the economic revenue and forecast council's published
20 economic forecasts.

21 NEW SECTION. **Sec. 3.** A new section is added to chapter 28B.92
22 RCW to read as follows:

23 (1) In addition to other eligibility requirements outlined in
24 this chapter, students who demonstrate financial need are eligible to
25 receive the Washington college promise scholarship. For the purposes
26 of this act, students who demonstrate financial need are students
27 with family incomes at or below seventy percent of the state median
28 family income, adjusted for family size.

29 (2) Students with family incomes between zero and fifty percent
30 of the state median family income shall receive the maximum
31 Washington college promise scholarship award as defined in RCW
32 28B.92.030. Awards for students with incomes between fifty-one and
33 seventy percent of the state median family income shall be prorated
34 at the following percentages of the maximum Washington college
35 promise scholarship award amount granted to those with incomes below
36 fifty-one percent of the state median family income:

37 (a) Seventy percent for students with family incomes between
38 fifty-one and fifty-five percent of the state median family income;

1 (b) Sixty-five percent for students with family incomes between
2 fifty-six and sixty percent of the state median family income;

3 (c) Sixty percent for students with family incomes between sixty-
4 one and sixty-five percent of the state median family income; and

5 (d) Fifty percent for students with family incomes between sixty-
6 six and seventy percent of the state median family income.

7 **Sec. 4.** RCW 28B.92.030 and 2013 c 248 s 2 are each amended to
8 read as follows:

9 As used in this chapter:

10 (1) "Council" means the student achievement council.

11 (2) (~~"Disadvantaged student" means a posthigh school student who~~
12 ~~by reason of adverse cultural, educational, environmental,~~
13 ~~experiential, familial or other circumstances is unable to qualify~~
14 ~~for enrollment as a full-time student in an institution of higher~~
15 ~~education, who would otherwise qualify as a needy student, and who is~~
16 ~~attending an institution of higher education under an established~~
17 ~~program designed to qualify the student for enrollment as a full-time~~
18 ~~student.~~

19 ~~(3))~~ "Financial aid" means loans and/or grants to ~~((needy))~~
20 students who demonstrate financial need enrolled or accepted for
21 enrollment as a student at institutions of higher education.

22 (3) "Financial need" means a demonstrated financial inability to
23 bear the total cost of education as directed in rule by the office.

24 (4) "Institution" or "institutions of higher education" means:

25 (a) Any public university, college, community college, or
26 technical college operated by the state of Washington or any
27 political subdivision thereof; or

28 (b) Any other university, college, school, or institute in the
29 state of Washington offering instruction beyond the high school level
30 that is a member institution of an accrediting association recognized
31 by rule of the council for the purposes of this section and that
32 agrees to and complies with program rules adopted pursuant to RCW
33 28B.92.150. However, any institution, branch, extension or facility
34 operating within the state of Washington that is affiliated with an
35 institution operating in another state must be:

36 (i) A separately accredited member institution of any such
37 accrediting association;

38 (ii) A branch of a member institution of an accrediting
39 association recognized by rule of the council for purposes of this

1 section, that is eligible for federal student financial aid
2 assistance and has operated as a nonprofit college or university
3 delivering on-site classroom instruction for a minimum of twenty
4 consecutive years within the state of Washington, and has an annual
5 enrollment of at least seven hundred full-time equivalent students;
6 (~~(e)~~)

7 (iii) A nonprofit institution recognized by the state of
8 Washington as provided in RCW 28B.77.240; or

9 (iv) An approved apprenticeship program under chapter 49.04 RCW.

10 (5) (~~("Needy student" means a posthigh school student of an~~
11 ~~institution of higher education who demonstrates to the office the~~
12 ~~financial inability, either through the student's parents, family~~
13 ~~and/or personally, to meet the total cost of board, room, books, and~~
14 ~~tuition and incidental fees for any semester or quarter. "Needy~~
15 ~~student" also means an opportunity internship graduate as defined by~~
16 ~~RCW 28C.18.162 who enrolls in a postsecondary program of study as~~
17 ~~defined in RCW 28C.18.162 within one year of high school~~
18 ~~graduation.)) "Maximum Washington college promise scholarship award":~~

19 (a) For students attending two or four-year institutions of
20 higher education as defined in RCW 28B.10.016, is tuition for fifteen
21 quarter credit hours or the equivalent, as determined by the office,
22 including operating fees and building fees.

23 (b) For students attending private four-year institutions of
24 higher education in Washington, is the lesser of the maximum
25 Washington college promise scholarship award under (a) of this
26 subsection, or individual institution tuition for fifteen quarter
27 credit hours or the equivalent.

28 (c) For students attending two-year private institutions of
29 higher education in Washington, is the lesser of the maximum
30 Washington college promise scholarship award at a community or
31 technical college or individual institution tuition for fifteen
32 quarter credit hours or the equivalent.

33 (d) For students attending approved apprenticeship programs, is
34 tuition and fees, as determined by the office, in addition to
35 required program supplies and equipment.

36 (6) "Office" means the office of student financial assistance.

37 (~~(7) "Placebound student" means a student who (a) is unable to~~
38 ~~complete a college program because of family or employment~~
39 ~~commitments, health concerns, monetary inability, or other similar~~
40 ~~factors; and (b) may be influenced by the receipt of an enhanced~~

1 ~~student financial aid award to complete a baccalaureate degree at an~~
2 ~~eligible institution.))~~

3 **Sec. 5.** RCW 28B.15.820 and 2009 c 215 s 9 are each amended to
4 read as follows:

5 (1) Each institution of higher education, including technical
6 colleges, shall deposit a minimum of three and one-half percent of
7 revenues collected from tuition and services and activities fees in
8 an institutional financial aid fund that is hereby created and which
9 shall be held locally. Beginning in academic year 2021-22, moneys in
10 the fund must first be used to cover the cost of the services and
11 activities fees as defined in RCW 28B.15.041 for Washington college
12 promise scholarship recipients. Remaining moneys in the fund shall be
13 used only for the following purposes: (a) To make guaranteed long-
14 term loans to eligible students as provided in subsections (3)
15 through (8) of this section; (b) to make short-term loans as provided
16 in subsection (9) of this section; (c) to provide financial aid to
17 ~~((needy))~~ students who demonstrate financial need as provided in
18 subsection (10) of this section; or (d) to provide financial aid to
19 students as provided in subsection (11) of this section.

20 (2) An "eligible student" for the purposes of subsections (3)
21 through (8) and (10) of this section is a student registered for at
22 least three credit hours or the equivalent, who is eligible for
23 resident tuition and fee rates as defined in RCW 28B.15.012 and
24 28B.15.013, and who is a ~~((needy))~~ student ~~(("))~~ who demonstrates
25 financial need as defined in RCW 28B.92.030.

26 (3) The amount of the guaranteed long-term loans made under this
27 section shall not exceed the demonstrated financial need of the
28 student. Each institution shall establish loan terms and conditions
29 which shall be consistent with the terms of the guaranteed loan
30 program established by 20 U.S. Code Section 1071 et seq., as now or
31 hereafter amended. All loans made shall be guaranteed by the
32 Washington student loan guaranty association or its successor agency.
33 Institutions are hereby granted full authority to operate as an
34 eligible lender under the guaranteed loan program.

35 (4) Before approving a guaranteed long-term loan, each
36 institution shall analyze the ability of the student to repay the
37 loan based on factors which include, but are not limited to, the
38 student's accumulated total education loan burdens and the employment
39 opportunities and average starting salary characteristics of the

1 student's chosen fields of study. The institution shall counsel the
2 student on the advisability of acquiring additional debt, and on the
3 availability of other forms of financial aid.

4 (5) Each institution is responsible for collection of guaranteed
5 long-term loans made under this section and shall exercise due
6 diligence in such collection, maintaining all necessary records to
7 insure that maximum repayments are made. Institutions shall cooperate
8 with other lenders and the Washington student loan guaranty
9 association, or its successor agency, in the coordinated collection
10 of guaranteed loans, and shall assure that the guarantability of the
11 loans is not violated. Collection and servicing of guaranteed long-
12 term loans under this section shall be performed by entities approved
13 for such servicing by the Washington student loan guaranty
14 association or its successor agency: PROVIDED, That institutions be
15 permitted to perform such servicing if specifically recognized to do
16 so by the Washington student loan guaranty association or its
17 successor agency. Collection and servicing of guaranteed long-term
18 loans made by community colleges under subsection (1) of this section
19 shall be coordinated by the state board for community and technical
20 colleges and shall be conducted under procedures adopted by the state
21 board.

22 (6) Receipts from payment of interest or principal or any other
23 subsidies to which institutions as lenders are entitled, that are
24 paid by or on behalf of borrowers of funds under subsections (3)
25 through (8) of this section, shall be deposited in each institution's
26 financial aid fund and shall be used to cover the costs of making the
27 guaranteed long-term loans under this section and maintaining
28 necessary records and making collections under subsection (5) of this
29 section: PROVIDED, That such costs shall not exceed five percent of
30 aggregate outstanding loan principal. Institutions shall maintain
31 accurate records of such costs, and all receipts beyond those
32 necessary to pay such costs, shall be deposited in the institution's
33 financial aid fund.

34 (7) The governing boards of the state universities, the regional
35 universities, and The Evergreen State College, and the state board
36 for community and technical colleges, on behalf of the community
37 colleges and technical colleges, shall each adopt necessary rules and
38 regulations to implement this section.

39 (8) First priority for any guaranteed long-term loans made under
40 this section shall be directed toward students who would not normally

1 have access to educational loans from private financial institutions
2 in Washington state, and maximum use shall be made of secondary
3 markets in the support of loan consolidation.

4 (9) Short-term loans, not to exceed one year, may be made from
5 the institutional financial aid fund to students enrolled in the
6 institution. No such loan shall be made to any student who is known
7 by the institution to be in default or delinquent in the payment of
8 any outstanding student loan. A short-term loan may be made only if
9 the institution has ample evidence that the student has the
10 capability of repaying the loan within the time frame specified by
11 the institution for repayment.

12 (10) Any moneys deposited in the institutional financial aid fund
13 that are not used in making long-term or short-term loans may be used
14 by the institution for locally administered financial aid programs
15 for (~~needy~~) students who demonstrate financial need, such as need-
16 based institutional employment programs or need-based tuition and fee
17 scholarship or grant programs. These funds shall be used in addition
18 to and not to replace institutional funds that would otherwise
19 support these locally administered financial aid programs. First
20 priority in the use of these funds shall be given to (~~needy~~)
21 students who demonstrate financial need and have accumulated
22 excessive educational loan burdens. An excessive educational loan
23 burden is a burden that will be difficult to repay given employment
24 opportunities and average starting salaries in the student's chosen
25 fields of study. Second priority in the use of these funds shall be
26 given to (~~needy~~) single parents who are students who demonstrate
27 financial need, to assist these students with their educational
28 expenses, including expenses associated with child care and
29 transportation.

30 (11) Any moneys deposited in the institutional financial aid fund
31 may be used by the institution for a locally administered financial
32 aid program for high school students enrolled in dual credit
33 programs. If institutions use funds in this manner, the governing
34 boards of the state universities, the regional universities, The
35 Evergreen State College, and the state board for community and
36 technical colleges shall each adopt necessary rules to implement this
37 subsection. Moneys from this fund may be used for all educational
38 expenses related to a student's participation in a dual credit
39 program including but not limited to tuition, fees, course materials,
40 and transportation.

PART II
CASELOAD FORECAST

NEW SECTION. **Sec. 6.** A new section is added to chapter 28B.92 RCW to read as follows:

The caseload forecast council shall estimate the anticipated caseload of the Washington college promise scholarship program and submit the caseload forecast as specified in RCW 43.88C.020.

Sec. 7. RCW 43.88C.010 and 2018 c 208 s 4 are each amended to read as follows:

(1) The caseload forecast council is hereby created. The council shall consist of two individuals appointed by the governor and four individuals, one of whom is appointed by the chairperson of each of the two largest political caucuses in the senate and house of representatives. The chair of the council shall be selected from among the four caucus appointees. The council may select such other officers as the members deem necessary.

(2) The council shall employ a caseload forecast supervisor to supervise the preparation of all caseload forecasts. As used in this chapter, "supervisor" means the caseload forecast supervisor.

(3) Approval by an affirmative vote of at least five members of the council is required for any decisions regarding employment of the supervisor. Employment of the supervisor shall terminate after each term of three years. At the end of the first year of each three-year term the council shall consider extension of the supervisor's term by one year. The council may fix the compensation of the supervisor. The supervisor shall employ staff sufficient to accomplish the purposes of this section.

(4) The caseload forecast council shall oversee the preparation of and approve, by an affirmative vote of at least four members, the official state caseload forecasts prepared under RCW 43.88C.020. If the council is unable to approve a forecast before a date required in RCW 43.88C.020, the supervisor shall submit the forecast without approval and the forecast shall have the same effect as if approved by the council.

(5) A councilmember who does not cast an affirmative vote for approval of the official caseload forecast may request, and the supervisor shall provide, an alternative forecast based on assumptions specified by the member.

1 (6) Members of the caseload forecast council shall serve without
2 additional compensation but shall be reimbursed for travel expenses
3 in accordance with RCW 44.04.120 while attending sessions of the
4 council or on official business authorized by the council.
5 Nonlegislative members of the council shall be reimbursed for travel
6 expenses in accordance with RCW 43.03.050 and 43.03.060.

7 (7) "Caseload," as used in this chapter, means:

8 (a) The number of persons expected to meet entitlement
9 requirements and require the services of public assistance programs,
10 state correctional institutions, state correctional noninstitutional
11 supervision, state institutions for juvenile offenders, the common
12 school system, long-term care, medical assistance, foster care, and
13 adoption support;

14 (b) The number of students who are eligible for the Washington
15 college bound scholarship program and are expected to attend an
16 institution of higher education as defined in RCW 28B.92.030;

17 (c) The number of students who are eligible for the Washington
18 college promise scholarship program under section 2 of this act and
19 are expected to attend an institution of higher education as defined
20 in RCW 28B.92.030; and

21 (d) The number of children who are eligible, as defined in RCW
22 43.216.505, to participate in, and the number of children actually
23 served by, the early childhood education and assistance program.

24 (8) The caseload forecast council shall forecast the temporary
25 assistance for needy families and the working connections child care
26 programs as a courtesy.

27 (9) The caseload forecast council shall forecast youth
28 participating in the extended foster care program pursuant to RCW
29 74.13.031 separately from other children who are residing in foster
30 care and who are under eighteen years of age.

31 (10) The caseload forecast council shall forecast the number of
32 youth expected to receive behavioral rehabilitation services while
33 involved in the foster care system and the number of screened in
34 reports of child abuse or neglect.

35 (11) Unless the context clearly requires otherwise, the
36 definitions provided in RCW 43.88.020 apply to this chapter.

18 read as follows:

19 (~~As used~~) The definitions in this section apply throughout this
20 chapter(~~, the following words and terms shall have the following~~
21 ~~meanings,~~) unless the context (~~shall~~) clearly (~~indicate another~~
22 ~~or different meaning or intent:~~) requires otherwise.

23 (1) (~~The term "needy student" shall mean a student enrolled or~~
24 ~~accepted for enrollment at a postsecondary institution who, according~~
25 ~~to a system of need analysis approved by the office of student~~
26 ~~financial assistance, demonstrates a financial inability, either~~
27 ~~parental, familial, or personal, to bear the total cost of education~~
28 ~~for any semester or quarter.~~

29 (~~2) The term~~) "Eligible institution" (~~shall~~) means any
30 postsecondary institution in this state accredited by the Northwest
31 Association of Schools and Colleges, or a campus of a member
32 institution of an accrediting association recognized by rule of the
33 student achievement council for purposes of this section, that is
34 eligible for federal student financial aid assistance and has
35 operated as a nonprofit college or university delivering on-site
36 classroom instruction for a minimum of twenty consecutive years
37 within the state of Washington, or any public technical college in
38 the state.

39 (2) "Financial need" has the same meaning as in RCW 28B.92.030.

1 **Sec. 10.** RCW 28B.92.040 and 2011 1st sp.s. c 11 s 160 are each
2 amended to read as follows:

3 The office shall be cognizant of the following guidelines in the
4 performance of its duties:

5 (1) The office shall be research oriented, not only at its
6 inception but continually through its existence.

7 (2) The office shall coordinate all existing programs of
8 financial aid except those specifically dedicated to a particular
9 institution by the donor.

10 (3) The office shall take the initiative and responsibility for
11 coordinating all federal student financial aid programs to ensure
12 that the state recognizes the maximum potential effect of these
13 programs, and shall design state programs that complement existing
14 federal, state, and institutional programs. (~~The office shall ensure
15 that state programs continue to follow the principle that state
16 financial aid funding follows the student to the student's choice of
17 institution of higher education.~~)

18 (4) Counseling is a paramount function of the (~~state need
19 grant~~) Washington college promise scholarship program and other
20 state student financial aid programs, and in most cases could only be
21 properly implemented at the institutional levels; therefore, state
22 student financial aid programs shall be concerned with the attainment
23 of those goals which, in the judgment of the office, are the reasons
24 for the existence of a student financial aid program, and not solely
25 with administration of the program on an individual basis.

26 (5) The "package" approach of combining loans, grants and
27 employment for student financial aid shall be the conceptual element
28 of the state's involvement.

29 (6) The office shall ensure that allocations of state
30 appropriations for financial aid are made to individuals and

11 higher education to improve student transitions and success including
12 but not limited to:

13 (a) Setting minimum college admission standards for four-year
14 institutions of higher education, including:

15 (i) A requirement that coursework in American sign language or an
16 American Indian language satisfies any requirement for instruction in
17 a language other than English that the council or the institutions
18 may establish as a general undergraduate admissions requirement; and

19 (ii) Encouragement of the use of multiple measures to determine
20 whether a student must enroll in a precollege course, such as
21 placement tests, the SAT, high school transcripts, college
22 transcripts, or initial class performance;

23 (b) Proposing comprehensive policies and programs to encourage
24 students to prepare for, understand how to access, and pursue
25 postsecondary college and career programs, including specific
26 policies and programs for students with disabilities;

27 (c) Recommending policies that require coordination between or
28 among sectors such as dual high school-college programs, awarding
29 college credit for advanced high school work, and transfer between

1 funds deposited in each account, except that no more than one million
2 dollars in state match shall be deposited into the advanced degrees
3 pathways account in a single fiscal biennium; and

4 (vi) Once moneys in the opportunity scholarship match transfer
5 account are subject to an agreement under RCW 28B.145.050(5) and are
6 deposited in the scholarship account, the student support pathways
7 account, the advanced degrees pathways account, or the endowment
8 account under this section, the state acts in a fiduciary rather than
9 ownership capacity with regard to those assets. Assets in the
10 scholarship account, the student support pathways account, the
11 advanced degrees pathways account, and the endowment account are not
12 considered state money, common cash, or revenue to the state;

13 (c) Provide proof of receipt of grants and contributions from
14 private sources to the council, identifying the amounts received by
15 name of private source and date, and whether the amounts received
16 were deposited into the scholarship account, the student support
17 pathways account, the advanced degrees pathways account, or the
18 endowment account((~~s~~));

19 (d) In consultation with the council and the state board for
20 community and technical colleges, make an assessment of the
21 reasonable annual eligible expenses associated with eligible
22 education programs and eligible advanced degree programs identified
23 by the board;

24 (e) Determine the dollar difference between tuition fees charged
25 by institutions of higher education in the 2008-09 academic year and
26 the academic year for which an opportunity scholarship is being
27 distributed;

28 (f) Develop and implement an application, selection, and
29 notification process for awarding opportunity scholarships;

30 (g) Determine the annual amount of the opportunity scholarship
31 for each selected participant. The annual amount shall be at least
32 one thousand dollars or the amount determined under (e) of this
33 subsection, but may be increased on an income-based, sliding scale
34 basis up to the amount necessary to cover all reasonable annual
35 eligible expenses as assessed pursuant to (d) of this subsection, or
36 to encourage participation in professional-technical certificate
37 programs, professional-technical degree programs, ((~~o~~))
38 baccalaureate degree programs, or eligible advanced degree programs
39 identified by the board;

1 (h) Distribute scholarship funds to selected participants. Once
2 awarded, and to the extent funds are available for distribution, an
3 opportunity scholarship shall be automatically renewed as long as the
4 participant annually submits documentation of filing both a free
5 application for federal student aid (FAFSA) and for available federal
6 education tax credits including, but not limited to, the American
7 opportunity tax credit, or if ineligible to apply for federal student
8 aid, the participant annually submits documentation of filing a state
9 financial aid application as approved by the office of student
10 financial assistance; and until the participant withdraws from or is
11 no longer attending the program, completes the program, or has taken
12 the credit or clock hour equivalent of one hundred twenty-five
13 percent of the published length of time of the participant's program,
14 whichever occurs first;

15 (i) Notify institutions of scholarship recipients who will attend
16 their institutions and inform them of the terms of the students'
17 eligibility;

18 (j) Establish a required service obligation for participants
19 enrolled in an eligible advanced degree program, and establish a
20 process for verifying a participant's employment in a service
21 obligation area; and

22 (k) Establish a repayment obligation and appeals process for
23 participants who serve less than the required service obligation,
24 unless the program administrator determines the circumstances are
25 beyond the participant's control. If the participant is unable to pay
26 the repayment obligation in full, the participant may enter into
27 payment arrangements with the program administrator. The program
28 administrator is responsible for the collection of repayment
29 obligations on behalf of participants who fail to complete their
30 service obligation.

31 (3) With respect to the opportunity expansion program, the
32 program administrator shall:

33 (a) Assist the board in developing and implementing an
34 application, selection, and notification process for making
35 opportunity expansion awards; and

36 (b) Solicit and accept grants and contributions from private
37 sources for opportunity expansion awards.
