- Sec. 1. RCW 46.18.200 and 2019 c 384 s 1 and 2019 c 177 s 1 are each reenacted and amended to read as follows:
- 8 (1) Special license plate series reviewed and approved by the 9 department:
- 10 (a) May be issued in lieu of standard issue or personalized 11 license plates for vehicles required to display one and two license 12 plates unless otherwise specified;
- 13 (b) Must be issued under terms and conditions established by the department;
- 15 (c) Must not be issued for vehicles registered under chapter 16 46.87 RCW; and
- 17 (d) Must display a symbol or artwork approved by the department.

(3) Applicants for initial and renewal professional firefighters and paramedics special license plates must show proof of eligibility by providing a certificate of current membership from the Washington state council of firefighters.

(4) Applicants for initial volunteer firefighters special license 5 plates must (a) have been a volunteer firefighter for at least ten 6 years or be a volunteer firefighter for one or more years and (b) 7 have documentation of service from the district of the appropriate 8 9 fire service. If the volunteer firefighter leaves firefighting 10 service before ten years of service have been completed, the volunteer firefighter shall surrender the license plates to the 11 12 department on the registration renewal date. If the volunteer 13 firefighter stays in service for at least ten years and then leaves, 14 the license plate may be retained by the former volunteer firefighter and as long as the license plate is retained for use the person will 15 16 continue to pay the future registration renewals. A qualifying 17 volunteer firefighter may have no more than one set of license plates per vehicle, and a maximum of two sets per applicant, for their 18 19 personal vehicles. If the volunteer firefighter is convicted of a 20 violation of RCW 46.61.502 or a felony, the license plates must be 21 surrendered upon conviction.

Sec. 2. RCW 46.17.220 and 2019 c 384 s 2 and 2019 c 177 s 2 are each reenacted and amended to read as follows:

In addition to all fees and taxes required to be paid upon application for a vehicle registration in chapter 46.16A RCW, the holder of a special license plate shall pay the appropriate special license plate fee as listed in this section.

  - (2) The state treasurer shall credit the proceeds to the motor vehicle ((account [fund])) <u>fund</u> until the department determines that the state has been reimbursed for the cost of implementing the special license plate. Upon determination by the department that the state has been reimbursed, the state treasurer shall credit the remaining special license plate fee amounts for each special license plate to the following appropriate account as created in this section in the custody of the state treasurer:

- (3) Except as otherwise provided in this section, only the director or the director's designee may authorize expenditures from the accounts described in subsection (2) of this section. The accounts are subject to allotment procedures under chapter 43.88 RCW, but an appropriation is not required for expenditures.
- (4) Except as otherwise provided in this section, funds in the special license plate accounts described in subsection (2) of this section must be disbursed subject to the conditions described in subsection (2) of this section and under contract between the department and qualified nonprofit organizations that provide the services described in subsection (2) of this section.
- (5) Funds from the Seattle Seahawks account may be provided to the lieutenant governor solely for the purpose of administering the Washington world fellows program. Of the amounts received by the lieutenant governor's office under this subsection, at least ninety percent must be provided as fellowships under the program.
- (6) Beginning January 1, 2019, funds from the Seattle Mariners account may be provided to the office of lieutenant governor solely for the purpose of administering the sports mentoring program. Of the amounts received by the office of lieutenant governor, at least ninety percent must be applied towards services directly provided to youth participants.
- (7) For the purposes of this section, a "qualified nonprofit organization" means a not-for-profit corporation operating in Washington that has received a determination of tax exempt status under 26 U.S.C. Sec. 501(c)(3). The qualified nonprofit organization must meet all the requirements under RCW 46.18.100(1).
- NEW SECTION. Sec. 4. A new section is added to chapter 46.04 RCW to read as follows:
- "Washington law enforcement health and wellness license plates"
  means special license plates issued under RCW 46.18.200 that
