AN ACT Relating to firearm theft; reenacting and amending RCW 9.94A.515; adding a new section to chapter 9A.56 RCW; and prescribing penalties.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 <u>NEW SECTION.</u> Sec. 1. A new section is added to chapter 9A.56 6 RCW to read as follows:

7 (1) A person is guilty of theft of a firearm from a residence, 8 store, shop, sales outlet, or vehicle if he or she commits a theft of 9 any firearm from a residence, store, shop, or sales outlet where 10 firearms are sold, or from any vehicle.

11 (2) This section applies regardless of the value of the firearm 12 taken in the theft.

13 (3) Each firearm taken in the theft under this section is a 14 separate offense.

15 (4) (a) For the purposes of this section, "theft" has the same 16 meaning as defined in RCW 9A.56.020.

(b) The defense allowed against the prosecution for theft underRCW 9A.56.020 shall apply to the crime of theft of a firearm.

19 (5) For the purposes of this section:

20 (a) "Firearm" means any firearm as defined in RCW 9.41.010.

21 (b) "Vehicle" means any vehicle as defined in RCW 46.04.670.

1 (6) Theft of a firearm from a residence, store, shop, sales 2 outlet, or vehicle is a class B felony.
