AN ACT Relating to recognizing the eighteenth day of December as blood donor day; reenacting and amending RCW 1.16.050; and creating a new section.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

Sec. 1. The legislature finds that with the help 5 NEW SECTION. 6 of over two hundred fifty thousand registered donors and volunteers 7 in the state, blood centers collect close to one thousand units of blood each day. All blood receives immediate, comprehensive testing 8 9 so that it can be available to regional hospitals, usually in less 10 than twenty-four hours after donation. About one in seven people 11 entering a hospital need blood. Blood is always needed for treatment 12 of accident victims, cancer patients, hemophiliacs, and surgery patients. Blood cannot be manufactured. Blood is collected at local 13 donor centers and mobile units travel to hundreds of blood drives 14 every month at work sites, schools, places of worship, and other 15 16 community locations throughout the Pacific Northwest. Blood donation 17 is one of the most significant contributions that a person can make towards our society. When the Amtrak Cascades passenger train 501 18 tragically derailed near Olympia on December 18, 2017, our state came 19 together to save the lives of more than eighty injured passengers. A 20 21 team comprised of emergency responders, health care providers,

ordinary citizens, and blood donors at blood centers throughout the state collected over two thousand units to respond to the lives of those in need. Blood donation is an integral community responsibility that connects all of us in our state. Therefore, it is the intent of the legislature to recognize and celebrate the incredible value of blood donors and blood donations in Washington by designating the eighteenth day of December as blood donor day.

8 Sec. 2. RCW 1.16.050 and 2019 c 224 s 2 and 2019 c 10 s 1 are 9 each reenacted and amended to read as follows:

- 10 (1) The following are state legal holidays:
- 11 (a) Sunday;

12 (b) The first day of January, commonly called New Year's Day;

13 (c) The third Monday of January, celebrated as the anniversary of 14 the birth of Martin Luther King, Jr.;

(d) The third Monday of February, to be known as Presidents' Day and celebrated as the anniversary of the births of Abraham Lincoln and George Washington;

(e) The last Monday of May, commonly known as Memorial Day;

19 (f) The fourth day of July, the anniversary of the Declaration of 20 Independence;

21 (g) The first Monday in September, to be known as Labor Day;

22 (h) The eleventh day of November, to be known as Veterans' Day;

(i) The fourth Thursday in November, to be known as ThanksgivingDay;

(j) The Friday immediately following the fourth Thursday in
November, to be known as Native American Heritage Day; and

27 (k) The twenty-fifth day of December, commonly called Christmas 28 Day.

(2) Employees of the state and its political subdivisions, except 29 30 employees of school districts and except those nonclassified 31 employees of institutions of higher education who hold appointments or are employed under contracts to perform services for periods of 32 less than twelve consecutive months, are entitled to one paid holiday 33 per calendar year in addition to those specified in this section. 34 35 Each employee of the state or its political subdivisions may select the day on which the employee desires to take the additional holiday 36 provided for in this section after consultation with the employer 37 38 pursuant to guidelines to be promulgated by rule of the appropriate

1 personnel authority, or in the case of local government by ordinance 2 or resolution of the legislative authority.

Employees of the state and its political subdivisions, 3 (3) including employees of school districts and those nonclassified 4 employees of institutions of higher education who hold appointments 5 6 or are employed under contracts to perform services for periods of less than twelve consecutive months, are entitled to two unpaid 7 holidays per calendar year for a reason of faith or conscience or an 8 organized activity conducted under the auspices of a religious 9 10 denomination, church, or religious organization. This includes employees of public institutions of higher education, including 11 12 community colleges, technical colleges, and workforce training programs. The employee may select the days on which the employee 13 desires to take the two unpaid holidays after consultation with the 14 15 employer pursuant to guidelines to be promulgated by rule of the 16 appropriate personnel authority, or in the case of local government 17 by ordinance or resolution of the legislative authority. If an employee prefers to take the two unpaid holidays on specific days for 18 a reason of faith or conscience, or an organized activity conducted 19 under the auspices of a religious denomination, church, or religious 20 21 organization, the employer must allow the employee to do so unless 22 the employee's absence would impose an undue hardship on the employer 23 or the employee is necessary to maintain public safety. Undue hardship shall have the meaning established in rule by the office of 24 25 financial management under RCW 43.41.109.

(4) If any of the state legal holidays specified in this section 26 27 are also federal legal holidays but observed on different dates, only 28 the state legal holidays are recognized as a paid legal holiday for employees of the state and its political subdivisions. However, for 29 port districts and the law enforcement and public transit employees 30 31 of municipal corporations, either the federal or the state legal holiday is recognized as a paid legal holiday, but in no case may 32 both holidays be recognized as a paid legal holiday for employees. 33

(5) Whenever any state legal holiday:

35 (a) Other than Sunday, falls upon a Sunday, the following Monday36 is the legal holiday; or

37 (b) Falls upon a Saturday, the preceding Friday is the legal 38 holiday.

39 (6) Nothing in this section may be construed to have the effect40 of adding or deleting the number of paid holidays provided for in an

1 agreement between employees and employers of political subdivisions of the state or as established by ordinance or resolution of the 2 local government legislative authority. 3 The legislature declares that the following days are 4 (7) recognized as provided in this subsection, but may not be considered 5 6 legal holidays for any purpose: 7 (a) The thirteenth day of January, recognized as Korean-American 8 day; (b) The twelfth day of October, recognized as Columbus day; 9 (c) The ninth day of April, recognized as former prisoner of war 10 11 recognition day; 12 (d) The twenty-sixth day of January, recognized as Washington

13 army and air national guard day; 14 (e) The seventh day of August, recognized as purple heart

15 recipient recognition day;

16 (f) The second Sunday in October, recognized as Washington state 17 children's day;

(g) The sixteenth day of April, recognized as Mother Joseph day;

(h) The fourth day of September, recognized as Marcus Whitman20 day;

21 (i) The seventh day of December, recognized as Pearl Harbor 22 remembrance day;

(j) The twenty-seventh day of July, recognized as national Korean war veterans armistice day;

25 (k) The nineteenth day of February, recognized as civil liberties 26 day of remembrance;

(1) The nineteenth day of June, recognized as Juneteenth, a dayof remembrance for the day the slaves learned of their freedom;

29 (m) The thirtieth day of March, recognized as welcome home 30 Vietnam veterans day;

31 (n) The eleventh day of January, recognized as human trafficking 32 awareness day;

33 (o) The thirty-first day of March, recognized as Cesar Chavez 34 day;

35 (p) The tenth day of April, recognized as Dolores Huerta day; 36 ((and))

37 (q) The fourth Saturday of September, recognized as public lands 38 day; and
