- 1 AN ACT Relating to providing whale watching guidelines in the
- 2 boating safety education program; and amending RCW 79A.60.630.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 79A.60.630 and 2011 c 171 s 118 are each amended to read as follows:
 - program to provide required boating safety education. The boating safety education program shall include training on preventing the spread of aquatic invasive species. The boating safety education program shall include educational materials regarding whale watching guidelines and other voluntary and regulatory measures related to

The commission shall establish and implement by rule a

- 12 <u>whale watching.</u> The program shall be phased in so that all boaters
- 13 not exempted under RCW 79A.60.640(3) are required to obtain a boater
- 14 education card by January 1, 2016. To obtain a boater education card,
- 15 a boater shall provide a certificate of accomplishment issued by a
- 16 boating educator for taking and passing an accredited boating safety
- 17 education course, or pass an equivalency exam, or provide proof of
- 18 completion of a course that meets the standard adopted by the
- 19 commission.

20 (2) As part of the boating safety education program, the 21 commission shall:

- 1 (a) Establish a program to be phased over eleven years starting
- 2 July 1, 2005, with full implementation by January 1, 2016. The period
- 3 July 1, 2005, through December 31, 2007, will be program development,
- 4 boater notification of the new requirements for mandatory education,
- 5 and processing cards to be issued to individuals having taken an
- 6 accredited course prior to January 1, 2008. The schedule for phase-in
- 7 of the mandatory education requirement by age group is as follows:
- 8 January 1, 2008 All boat operators twenty years old and younger;
- 9 January 1, 2009 All boat operators twenty-five years old and
- 10 younger;
- 11 January 1, 2010 All boat operators thirty years old and younger;
- 12 January 1, 2011 All boat operators thirty-five years old and
- 13 younger;
- 14 January 1, 2012 All boat operators forty years old and younger;
- 15 January 1, 2013 All boat operators fifty years old and younger;
- 16 January 1, 2014 All boat operators sixty years old and younger;
- January 1, 2015 All boat operators seventy years old and younger;
- 18 January 1, 2016 All boat operators;
- 19 (b) Establish a minimum standard of boating safety education
- 20 accomplishment. The standard must be consistent with the applicable
- 21 standard established by the national association of state boating law
- 22 administrators;
- 23 (c) Adopt minimum standards for boating safety education course
- 24 of instruction and examination that ensures compliance with the
 - national association of state boating law administrators minimum
- 26 standards;

- 27 (d) Approve and provide accreditation to boating safety education
- 28 courses operated by volunteers, or commercial or nonprofit
- 29 organizations, including, but not limited to, courses given by the
- 30 United States coast guard auxiliary and the United States power
- 31 squadrons;
- 32 (e) Develop an equivalency examination that may be taken as an
- 33 alternative to the boating safety education course;
- 34 (f) Establish a fee of ten dollars for the boater education card
- 35 to fund all commission activities related to the boating safety
- 36 education program created by chapter 392, Laws of 2005, including the
- 37 initial costs of developing the program. Any surplus funds resulting
- 38 from the fees received shall be distributed by the commission as
- 39 grants to local marine law enforcement programs approved by the
- 40 commission as provided in RCW 88.02.650;

1 (g) Establish a fee for the replacement of the boater education 2 card that covers the cost of replacement;

- (h) Consider and evaluate public agency and commercial opportunities to assist in program administration with the intent to keep administrative costs to a minimum;
- 6 (i) Approve and provide accreditation to boating safety education 7 courses offered online; and
- 8 (j) Provide a report to the legislature by January 1, 2008, on 9 its progress of implementation of the mandatory education program.
