- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- NEW SECTION. Sec. 1. A new section is added to chapter 28A.410 RCW to read as follows:
- 8 (1) The Washington professional educator standards board must 9 adopt rules for renewal of administrator certificates and teacher 10 certificates that meet the continuing education requirements of this 11 section.
- (2) To renew an administrator certificate on or after July 1, 2023, continuing education must meet the following requirements: 10 percent must focus on equity-based school practices, 10 percent must focus on the national professional standards for education leaders, and five percent must focus on government-to-government relationships with federally recognized tribes.
- 18 (3) To renew a teacher certificate on or after July 1, 2023, 15 19 percent of continuing education must focus on equity-based school 20 practices. This subsection (3) does not apply to a person renewing 21 both a teacher certificate and an administrator certificate.

- 1 (4)(a) Except as provided under (b) of this subsection (4), 2 continuing education must be provided by one or more of the following 3 entities, if they are an approved clock hour provider:
  - (i) The office of the superintendent of public instruction;
  - (ii) A school district;

- (iii) An educational service district;
- 7 (iv) A Washington professional educator standards board-approved 8 administrator or teacher preparation program;
  - (v) The association of Washington school principals; or
  - (vi) The Washington education association.
  - (b) Continuing education related to government-to-government relationships with federally recognized tribes must be provided by one or more subject matter experts approved by the governor's office on Indian affairs in collaboration with the tribal leaders congress on education and the office of Native education in the office of the superintendent of public instruction.
- 17 (5) Continuing education focused on equity-based school practices 18 must be aligned with the standards for cultural competency developed 19 under RCW 28A.410.260.
