- AN ACT Relating to modifying requirements in order to pay for debt service obligations when toll revenues are not sufficient to cover legal obligations; amending RCW 47.56.876; and declaring an emergency.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 **Sec. 1.** RCW 47.56.876 and 2019 c 416 s 710 are each amended to read as follows:
- 8 (1) A special account to be known as the state route number 520 civil penalties account is created in the state treasury. All state 9 10 route number 520 bridge replacement and HOV program civil penalties 11 generated from the nonpayment of tolls on the state route number 520 12 corridor must be deposited into the account, as provided under RCW 13 47.56.870(4)(b)(vii). Moneys in the account may be spent only after 14 appropriation. Expenditures from the account ((may)) must be used to 15 fund legal obligations associated with bonds and loans associated 16 with the construction and operation of state route number 520 under 17 circumstances where the toll revenue collections at the time are not 18 sufficient to fully cover such legal obligations, and then may be 19 used to fund any project within the state route number 520 bridge 20 replacement and HOV program, including mitigation. During 21 2013-2015 and 2015-2017 fiscal biennia, the legislature may transfer
