- 1 (1) The department, upon receipt of a fee of seventy-two
- 2 dollars, unless the driver's license is issued for a period other
- 3 than eight years, in which case the fee shall be nine dollars for
- 4 each year that the license is issued, which includes the fee for the
- 5 required photograph, shall issue to every qualifying applicant a
- 6 driver's license. A driver's license issued to a person under the
- 7 age of eighteen is an intermediate license, subject to the
- 8 restrictions imposed under RCW 46.20.075, until the person reaches
- 9 the age of eighteen.

- 11 (a) A distinguishing number assigned to the licensee;
