(1)(a) A legislative task force on 4 housing stability is established, with members as provided in this 5 subsection. 6 (i) The president of the senate shall appoint one member from each of the two largest caucuses of the senate. 8 (ii) The speaker of the house of representatives shall appoint 9 one member from each of the two largest caucuses of the house of 10 representatives. 11 (iii) The president of the senate and the speaker of the house 12 of representatives jointly shall appoint the following members: 13 (A) Two economists with expertise in the economic disciplines 14 most relevant to housing; 15 (B) One member representing nonprofit housing developers; 16 (C) One member representing for-profit housing developers; 17 (D) One member representing builders; 18 (E) One member representing labor; 19 (F) One member representing realtors; 20 (G) One member representing cities; 21 (H) One member representing counties; 22 (I) One member representing tenants; 23 (J) One member representing landlords; 2.4 (K) One member representing home mortgage lenders; 25 (L) One member representing multifamily lenders;

(M) One member representing utility providers;

(N) One member representing public housing authorities;

- 5 (Q) One member from an organization representing architects.
- 6 (b) The task force shall choose its cochairs from among its
- 7 legislative membership. The legislative membership shall convene the
- 8 initial meeting of the task force.
- 9 (2) The task force shall research, analyze, and determine the
- 10 primary cost drivers of housing and their impact on housing
- 11 stability in Washington state.
- 12 (3) Staff support for the task force must be provided by the
- 13 senate committee services and the house of representatives office of
- 14 program research.
- 15 (4) The task force, in completing the duties prescribed by this
- 16 section, shall solicit and consider information and perspectives
- 17 provided by the affordable housing advisory board and other entities
- 18 with relevant interest and expertise.
- 19 (5) Legislative members of the task force are reimbursed for
- 20 travel expenses in accordance with RCW 44.04.120. Nonlegislative
- 21 members are not entitled to be reimbursed for travel expenses if
- 22 they are elected officials or are participating on behalf of an
- 23 employer, governmental entity, or other organization. Any
- 24 reimbursement for other nonlegislative members is subject to chapter
- 25 43.03 RCW.
- 26 (6) The expenses of the task force must be paid jointly by the
- 27 senate and the house of representatives. Task force expenditures are
- 28 subject to approval by the senate facilities and operations
- 29 committee and the house of representatives executive rules
- 30 committee, or their successor committees.
- 31 (7) The task force shall report its findings and recommendations
- 32 to the appropriate committees of the legislature by December 1, 2025.
- 33 (8) This section expires June 1, 2026."
