EFFECT: Increases reimbursement rates on an ongoing basis through the Health Care Authority and the Department of Social and Health Services for the Home Health and the Medically Intensive Children's Group Home Program; and for independent contractor nurses and agency-employed nurses providing private duty nursing, skilled nursing, in-home skilled nursing services, and private duty nursing in adult family homes.

## FISCAL IMPACT:

Increases General Fund - State by \$1,035,000.
Increases General Fund - Medicaid by \$1,173,000.
