PART I NEW TITLE CREATED

33 <u>NEW SECTION.</u> Sec. 101. This act is intended to make technical 34 amendments to certain codified statutes that involve campaign 35 disclosure and contribution. Any statutory changes made by this act 36 should be interpreted as technical in nature and not interpreted to 37 have any substantive, policy implications. <u>NEW SECTION.</u> Sec. 102. A rule adopted under authority provided in chapter 42.17A RCW remains valid and is not affected by the recodification in this act.

4 <u>NEW SECTION.</u> Sec. 103. A new title is added to the Revised Code 5 of Washington to be codified as Title 29B RCW.

PART II

DEFINITIONS SPLIT

8 <u>NEW SECTION.</u> Sec. 201. Words and phrases as defined in this 9 chapter, wherever used in this title, shall have the meaning as in 10 this chapter ascribed to them, unless where used the context thereof 11 shall clearly indicate to the contrary or unless otherwise defined in 12 the chapter of which they are a part.

13 <u>NEW SECTION.</u> Sec. 202. "Actual malice" means to act with 14 knowledge of falsity or with reckless disregard as to truth or 15 falsity.

16 NEW SECTION. Sec. 203. "Agency" includes all state agencies and all local agencies. "State agency" includes every state office, 17 department, division, bureau, board, commission, or other state 18 agency. "Local agency" includes every county, city, town, municipal 19 20 corporation, quasi-municipal corporation, or special purpose district, or any office, department, division, bureau, board, 21 commission, or agency thereof, or other local public agency. "Agency" 22 23 does not include a comprehensive cancer center participating in a 24 collaborative arrangement as defined in RCW 28B.10.930 that is operated in conformance with RCW 28B.10.930. 25

26 <u>NEW SECTION.</u> Sec. 204. "Authorized committee" means the 27 political committee authorized by a candidate, or by the public 28 official against whom recall charges have been filed, to accept 29 contributions or make expenditures on behalf of the candidate or 30 public official.

31 <u>NEW SECTION.</u> Sec. 205. "Ballot proposition" means any "measure" 32 as defined by RCW 29A.04.091, or any initiative, recall, or 33 referendum proposition proposed to be submitted to the voters of the state or any municipal corporation, political subdivision, or other voting constituency from and after the time when the proposition has been initially filed with the appropriate election officer of that constituency before its circulation for signatures.

5 <u>NEW SECTION.</u> Sec. 206. "Benefit" means a commercial, 6 proprietary, financial, economic, or monetary advantage, or the 7 avoidance of a commercial, proprietary, financial, economic, or 8 monetary disadvantage.

9 <u>NEW SECTION.</u> Sec. 207. "Bona fide political party" means:

10 (1) An organization that has been recognized as a minor political 11 party by the secretary of state;

12 (2) The governing body of the state organization of a major 13 political party, as defined in RCW 29A.04.086, that is the body 14 authorized by the charter or bylaws of the party to exercise 15 authority on behalf of the state party; or

16 (3) The county central committee or legislative district 17 committee of a major political party. There may be only one 18 legislative district committee for each party in each legislative 19 district.

20 <u>NEW SECTION.</u> Sec. 208. "Books of account" means:

(1) In the case of a campaign or political committee, a ledger or similar listing of contributions, expenditures, and debts, such as a campaign or committee is required to file regularly with the commission, current as of the most recent business day; or

(2) In the case of a commercial advertiser, details of political advertising or electioneering communications provided by the advertiser, including the names and addresses of persons from whom it accepted political advertising or electioneering communications, the exact nature and extent of the services rendered, and the total cost and the manner of payment for the services.

31 <u>NEW SECTION.</u> Sec. 209. "Candidate" means any individual who 32 seeks nomination for election or election to public office. An 33 individual seeks nomination or election when the individual first:

34 (1) Receives contributions or makes expenditures or reserves
 35 space or facilities with intent to promote the individual's candidacy
 36 for office;

- (2) Announces publicly or files for office;

2 (3) Purchases commercial advertising space or broadcast time to
 3 promote the individual's candidacy; or

4 (4) Gives consent to another person to take on behalf of the 5 individual any of the actions in subsection (1) or (3) of this 6 section.

7 <u>NEW SECTION.</u> Sec. 210. "Caucus political committee" means a 8 political committee organized and maintained by the members of a 9 major political party in the state senate or state house of 10 representatives.

NEW SECTION. Sec. 211. "Commercial advertiser" means any person 11 12 that sells the service of communicating messages or producing material for broadcast or distribution to the general public or 13 14 segments of the general public whether through brochures, fliers, 15 newspapers, magazines, television, radio, billboards, direct mail 16 advertising, printing, paid internet or digital communications, or any other means of mass communication used for the purpose of 17 18 appealing, directly or indirectly, for votes or for financial or 19 other support in any election campaign.

20 <u>NEW SECTION.</u> Sec. 212. "Commission" means the agency 21 established under RCW 42.17A.100 (as recodified by this act).

22 <u>NEW SECTION.</u> Sec. 213. "Committee" unless the context indicates 23 otherwise, includes a political committee such as a candidate, ballot 24 proposition, recall, political, or continuing political committee.

Sec. 214. "Compensation" unless the context 25 NEW SECTION. 26 requires a narrower meaning, includes payment in any form for real or 27 personal property or services of any kind. For the purpose of 28 compliance with RCW 42.17A.710 (as recodified by this act), "compensation" does not include per diem allowances or other payments 29 made by a governmental entity to reimburse a public official for 30 expenses incurred while the official is engaged in the official 31 32 business of the governmental entity.

33 <u>NEW SECTION.</u> Sec. 215. "Continuing political committee" means a 34 political committee that is an organization of continuing existence

1 not limited to participation in any particular election campaign or 2 election cycle.

3 <u>NEW SECTION.</u> Sec. 216. (1) "Contribution" includes:

4 (a) A loan, gift, deposit, subscription, forgiveness of
5 indebtedness, donation, advance, pledge, payment, transfer of funds,
6 or anything of value, including personal and professional services
7 for less than full consideration;

8 (b) An expenditure made by a person in cooperation, consultation, 9 or concert with, or at the request or suggestion of, a candidate, a 10 political or incidental committee, the person or persons named on the 11 candidate's or committee's registration form who direct expenditures 12 on behalf of the candidate or committee, or their agents;

(c) The financing by a person of the dissemination, distribution, or republication, in whole or in part, of broadcast, written, graphic, digital, or other form of political advertising or electioneering communication prepared by a candidate, a political or incidental committee, or its authorized agent;

(d) Sums paid for tickets to fund-raising events such as dinners and parties, except for the actual cost of the consumables furnished at the event.

(2) "Contribution" does not include:

22 (a) Accrued interest on money deposited in a political or 23 incidental committee's account;

24

(b) Ordinary home hospitality;

(c) A contribution received by a candidate or political or incidental committee that is returned to the contributor within 10 business days of the date on which it is received by the candidate or political or incidental committee;

(d) A news item, feature, commentary, or editorial in a regularly scheduled news medium that is of interest to the public, that is in a news medium controlled by a person whose business is that news medium, and that is not controlled by a candidate or a political or incidental committee;

(e) An internal political communication primarily limited to the members of or contributors to a political party organization or political or incidental committee, or to the officers, management staff, or stockholders of a corporation or similar enterprise, or to the members of a labor organization or other membership organization;

1 (f) The rendering of personal services of the sort commonly 2 performed by volunteer campaign workers, or incidental expenses 3 personally incurred by volunteer campaign workers not in excess of 4 \$50 personally paid for by the worker. "Volunteer services," for the 5 purposes of this section, means services or labor for which the 6 individual is not compensated by any person;

7 (g) Messages in the form of reader boards, banners, or yard or 8 window signs displayed on a person's own property or property 9 occupied by a person. However, a facility used for such political 10 advertising for which a rental charge is normally made must be 11 reported as an in-kind contribution and counts toward any applicable 12 contribution limit of the person providing the facility;

13

(h) Legal or accounting services rendered to or on behalf of:

(i) A political party or caucus political committee if the person paying for the services is the regular employer of the person rendering such services; or

(ii) A candidate or an authorized committee if the person paying for the services is the regular employer of the individual rendering the services and if the services are solely for the purpose of ensuring compliance with state election or public disclosure laws; or

(i) The performance of ministerial functions by a person on behalf of two or more candidates or political or incidental committees either as volunteer services defined in (f) of this subsection or for payment by the candidate or political or incidental committee for whom the services are performed as long as:

(i) The person performs solely ministerial functions;

(ii) A person who is paid by two or more candidates or political or incidental committees is identified by the candidates and political committees on whose behalf services are performed as part of their respective statements of organization under RCW 42.17A.205 (as recodified by this act); and

(iii) The person does not disclose, except as required by law, any information regarding a candidate's or committee's plans, projects, activities, or needs, or regarding a candidate's or committee's contributions or expenditures that is not already publicly available from campaign reports filed with the commission, or otherwise engage in activity that constitutes a contribution under subsection (1)(b) of this section.

A person who performs ministerial functions under this subsection (2)(i) is not considered an agent of the candidate or committee as

long as the person has no authority to authorize expenditures or make
 decisions on behalf of the candidate or committee.

3 (3) Contributions other than money or its equivalent are deemed 4 to have a monetary value equivalent to the fair market value of the 5 contribution. Services or property or rights furnished at less than 6 their fair market value for the purpose of assisting any candidate or 7 political committee are deemed a contribution. Such a contribution 8 must be reported as an in-kind contribution at its fair market value 9 and counts towards any applicable contribution limit of the provider.

10 <u>NEW SECTION.</u> Sec. 217. "Depository" means a bank, mutual 11 savings bank, savings and loan association, or credit union doing 12 business in this state.

13 <u>NEW SECTION.</u> Sec. 218. "Elected official" means any person 14 elected at a general or special election to any public office, and 15 any person appointed to fill a vacancy in any such office.

NEW SECTION. Sec. 219. "Election" includes any primary, general, or special election for public office and any election in which a ballot proposition is submitted to the voters. An election in which the qualifications for voting include other than those requirements set forth in Article VI, section 1 (Amendment 63) of the Constitution of the state of Washington shall not be considered an election for purposes of this title.

23 <u>NEW SECTION.</u> Sec. 220. "Election campaign" means any campaign 24 in support of or in opposition to a candidate for election to public 25 office and any campaign in support of, or in opposition to, a ballot 26 proposition.

NEW SECTION. Sec. 221. "Election cycle" means the period beginning on the first day of January after the date of the last previous general election for the office that the candidate seeks and ending on December 31st after the next election for the office. In the case of a special election to fill a vacancy in an office, "election cycle" means the period beginning on the day the vacancy occurs and ending on December 31st after the special election.

<u>NEW SECTION.</u> Sec. 222. (1) "Electioneering communication" means
 any broadcast, cable, or satellite television, radio transmission,
 digital communication, United States postal service mailing,
 billboard, newspaper, or periodical that:

5 (a) Clearly identifies a candidate for a state, local, or 6 judicial office either by specifically naming the candidate, or 7 identifying the candidate without using the candidate's name;

8 (b) Is broadcast, transmitted electronically or by other means, 9 mailed, erected, distributed, or otherwise published within 60 days 10 before any election for that office in the jurisdiction in which the 11 candidate is seeking election; and

12 (c) Either alone, or in combination with one or more 13 communications identifying the candidate by the same sponsor during 14 the 60 days before an election, has a fair market value or cost of 15 \$1,000 or more.

16

(2) "Electioneering communication" does not include:

(a) Usual and customary advertising of a business owned by a candidate, even if the candidate is mentioned in the advertising when the candidate has been regularly mentioned in that advertising appearing at least 12 months preceding the candidate becoming a candidate;

(b) Advertising for candidate debates or forums when the advertising is paid for by or on behalf of the debate or forum sponsor, so long as two or more candidates for the same position have been invited to participate in the debate or forum;

26 (c) A news item, feature, commentary, or editorial in a regularly 27 scheduled news medium that is:

28

(i) Of interest to the public;

(ii) In a news medium controlled by a person whose business is that news medium; and

31 (iii) Not a medium controlled by a candidate or a political or 32 incidental committee;

33

(d) Slate cards and sample ballots;

(e) Advertising for books, films, dissertations, or similar works
(i) written by a candidate when the candidate entered into a contract
for such publications or media at least 12 months before becoming a
candidate, or (ii) written about a candidate;

(f) Public service announcements;

39 (g) An internal political communication primarily limited to the 40 members of or contributors to a political party organization or 1 political or incidental committee, or to the officers, management 2 staff, or stockholders of a corporation or similar enterprise, or to 3 the members of a labor organization or other membership organization;

4 (h) An expenditure by or contribution to the authorized committee 5 of a candidate for state, local, or judicial office; or

6 (i) Any other communication exempted by the commission through 7 rule consistent with the intent of this title.

Sec. 223. "Expenditure" includes a payment, 8 <u>NEW SECTION</u>. contribution, subscription, distribution, loan, advance, deposit, or 9 gift of money or anything of value, and includes a contract, promise, 10 or agreement, whether or not legally enforceable, to make an 11 expenditure. "Expenditure" also includes a promise to pay, a payment, 12 13 or a transfer of anything of value in exchange for goods, services, property, facilities, or anything of value for the purpose of 14 15 assisting, benefiting, or honoring any public official or candidate, or assisting in furthering or opposing any election campaign. For the 16 17 purposes of this title, agreements to make expenditures, contracts, and promises to pay may be reported as estimated obligations until 18 actual payment is made. "Expenditure" shall not include the partial 19 20 or complete repayment by a candidate or political or incidental 21 committee of the principal of a loan, the receipt of which loan has 22 been properly reported.

23 <u>NEW SECTION.</u> Sec. 224. "Final report" means the report 24 described as a final report in RCW 42.17A.235(11)(a) (as recodified 25 by this act).

26 <u>NEW SECTION.</u> Sec. 225. "Foreign national" means:

(1) An individual who is not a citizen of the United States andis not lawfully admitted for permanent residence;

29

(2) A government, or subdivision, of a foreign country;

30 (3) A foreign political party; and

31 (4) Any entity, such as a partnership, association, corporation, 32 organization, or other combination of persons, that is organized 33 under the laws of or has its principal place of business in a foreign 34 country.

35 <u>NEW SECTION.</u> Sec. 226. "General election," for the purposes of 36 RCW 42.17A.405 (as recodified by this act), means the election that

results in the election of a person to a state or local office. It
 does not include a primary.

3 <u>NEW SECTION.</u> Sec. 227. "Gift" has the definition in RCW 42.52.010.

5 <u>NEW SECTION.</u> Sec. 228. "Immediate family" includes the spouse or domestic partner, dependent children, and other dependent 6 relatives, if living in the household. For the purposes of the 7 definition of "intermediary" in section 232 of this act, "immediate 8 9 family" means an individual's spouse or domestic partner, and child, stepchild, grandchild, parent, stepparent, grandparent, brother, half 10 brother, sister, or half sister of the individual and the spouse or 11 the domestic partner of any such person and a child, stepchild, 12 grandchild, parent, stepparent, grandparent, brother, half brother, 13 14 sister, or half sister of the individual's spouse or domestic partner 15 and the spouse or the domestic partner of any such person.

Sec. 229. "Incidental committee" means any 16 NEW SECTION. nonprofit organization not otherwise defined as a political committee 17 18 but that may incidentally make a contribution or an expenditure in 19 excess of the reporting thresholds in RCW 42.17A.235 (as recodified by this act), directly or through a political committee. Any 20 nonprofit organization is not an incidental committee if it is only 21 22 remitting payments through the nonprofit organization in an aggregated form and the nonprofit organization is not required to 23 24 report those payments in accordance with this title.

25 <u>NEW SECTION.</u> Sec. 230. "Incumbent" means a person who is in 26 present possession of an elected office.

27 <u>NEW SECTION.</u> Sec. 231. (1) "Independent expenditure" means an 28 expenditure that has each of the following elements:

(a) It is made in support of or in opposition to a candidate foroffice by a person who is not:

31 (i) A candidate for that office;

32 (ii) An authorized committee of that candidate for that office; 33 and

34 (iii) A person who has received the candidate's encouragement or 35 approval to make the expenditure, if the expenditure pays in whole or

1 in part for political advertising supporting that candidate or 2 promoting the defeat of any other candidate or candidates for that 3 office;

4 (b) It is made in support of or in opposition to a candidate for 5 office by a person with whom the candidate has not collaborated for 6 the purpose of making the expenditure, if the expenditure pays in 7 whole or in part for political advertising supporting that candidate 8 or promoting the defeat of any other candidate or candidates for that 9 office;

10 (c) The expenditure pays in whole or in part for political 11 advertising that either specifically names the candidate supported or 12 opposed, or clearly and beyond any doubt identifies the candidate 13 without using the candidate's name; and

(d) The expenditure, alone or in conjunction with another expenditure or other expenditures of the same person in support of or opposition to that candidate, has a value of \$1,000 or more. A series of expenditures, each of which is under \$1,000, constitutes one independent expenditure if their cumulative value is \$1,000 or more.

(2) "Independent expenditure" does not include: Ordinary home 19 hospitality; communications with journalists or editorial staff 20 21 designed to elicit a news item, feature, commentary, or editorial in 22 a regularly scheduled news medium that is of primary interest to the general public, controlled by a person whose business is that news 23 medium, and not controlled by a candidate or a political committee; 24 25 participation in the creation of a publicly funded voters' pamphlet in written or video form; an 26 statement internal political communication primarily limited to contributors to a political party 27 organization or political action committee, the officers, management 28 staff, and stockholders of a corporation or similar enterprise, or 29 the members of a labor organization or other membership organization; 30 31 or the rendering of personal services of the sort commonly performed 32 by volunteer campaign workers or incidental expenses personally 33 incurred by volunteer campaign workers not in excess of \$250 personally paid for by the worker. 34

35 <u>NEW SECTION.</u> Sec. 232. (1) "Intermediary" means an individual 36 who transmits a contribution to a candidate or committee from another 37 person unless the contribution is from the individual's employer, 38 immediate family, or an association to which the individual belongs.

CONFORMING AMENDMENTS

(1) That political campaign and lobbying contributions and expenditures be fully disclosed to the public and that secrecy is to be avoided.

(2) That the people have the right to expect from their elected

honesty, and fairness in their dealings.

(3) That the people shall be assured that the private financial dealings of their public officials, and of candidates for those offices, present no conflict of interest between the public trust and private interest.

33 (4) That our representative form of government is founded on a 34 belief that those entrusted with the offices of government have nothing to fear from full public disclosure of their financial and business holdings, provided those officials deal honestly and fairly with the people.

4 (5) That public confidence in government at all levels is 5 essential and must be promoted by all possible means.

6 (6) That public confidence in government at all levels can best 7 be sustained by assuring the people of the impartiality and honesty 8 of the officials in all public transactions and decisions.

9 (7) That the concept of attempting to increase financial 10 participation of individual contributors in political campaigns is 11 encouraged by the passage of the Revenue Act of 1971 by the Congress 12 of the United States, and in consequence thereof, it is desirable to 13 have implementing legislation at the state level.

14 (8) That the concepts of disclosure and limitation of election 15 campaign financing are established by the passage of the Federal 16 Election Campaign Act of 1971 by the Congress of the United States, 17 and in consequence thereof it is desirable to have implementing 18 legislation at the state level.

(9) That small contributions by individual contributors are to be encouraged, and that not requiring the reporting of small contributions may tend to encourage such contributions.

(10) That the public's right to know of the financing of political campaigns and lobbying and the financial affairs of elected officials and candidates far outweighs any right that these matters remain secret and private.

(11) That, mindful of the right of individuals to privacy and of the desirability of the efficient administration of government, full access to information concerning the conduct of government on every level must be assured as a fundamental and necessary precondition to the sound governance of a free society.

31 The provisions of this ((chapter)) title shall be liberally 32 construed to promote complete disclosure of all information 33 respecting the financing of political campaigns and lobbying, and the financial affairs of elected officials and candidates, and full 34 access to public records so as to assure continuing public confidence 35 of fairness of elections and governmental processes, and so as to 36 assure that the public interest will be fully protected. In promoting 37 such complete disclosure, however, this ((chapter)) title shall be 38 39 enforced so as to ensure that the information disclosed will not be 40 misused for arbitrary and capricious purposes and to ensure that all

Public funds may not be expended as a direct or indirect gift or campaign contribution to any elected 13 official or officer or employee of any agency. For the purposes of 14 this subsection, "gift" means a voluntary transfer of any thing of 15 16 value without consideration of equal or greater value, but does not 17 include informational material transferred for the sole purpose of informing the recipient about matters pertaining to official agency 18 19 business.
