

**RCW 30B.04.100 Investment in corporations—Subsidiaries.** Except as otherwise provided by this chapter or rules adopted under this chapter, a state trust company may invest in corporations, limited liability companies, and other entities, and may acquire or establish a \*subsidiary to conduct any activity that may lawfully be conducted through the form of organization chosen for the \*subsidiary, in accordance with that which is permissible for state banks under RCW 30A.04.125 and 30A.04.127.
