
AND finding it necessary to follow the legislature's directive to adopt rules to provide for fees for examination of certified public accountants, and for registration of public accountancy partnerships, and for annual licensure of public accountants, licensed public accountants, certified public accountants and their partnerships and professional corporations,

AND in order to provide interim fees until statutory time for enactment of permanent rules has elapsed,

HEREBY adopts the attached rules as emergency rules of this agency.

New WAC 4-04-200 FEES FOR CPA EXAMINATION

An application for certified public accountant's examination or re-examination in any subject shall be accompanied by a fee of \$60 for four parts; \$50 for three parts; or \$40 for one or two parts.

New WAC 4-04-201 FEES FOR CPA PARTNERSHIP REGISTRATION

An application for registration or for amendment to registration as a certified public accountant partnership or professional corporation shall be accompanied by a fee of \$15 for registration and \$10 for each amendment.

New WAC 4-04-202 FEES FOR REGISTRATION OF LICENSED PUBLIC ACCOUNTANT PARTNERSHIPS

An application for registration or for amendment to registration as a partnership or professional corporation of licensed public accountants shall be accompanied by a fee of \$15 for registration and \$10 for each amendment.

New WAC 4-04-203 FEES FOR REGISTRATION OF PUBLIC ACCOUNTANT PARTNERSHIPS

An application for registration or for amendment to registration as a partnership or professional corporation of public accountants shall be accompanied by a fee of \$15 for registration and \$10 for each amendment.

New WAC 4-04-204 ANNUAL LICENSE FEES FOR CPA'S

The annual fee for a Certified Public Accountant's license shall be \$25.

New WAC 4-04-205 ANNUAL LICENSE FEE FOR CPA PARTNERSHIP OR PROFESSIONAL CORPORATION

The annual fee for a certified public accountant's partnership or professional corporation license shall be \$25.

New WAC 4-04-206 ANNUAL LICENSE FEE FOR LICENSED PUBLIC ACCOUNTANTS

The annual fee for a licensed public accountant's license shall be \$25.

New WAC 4-04-207 ANNUAL LICENSE FEE FOR LPA PARTNERSHIPS

The annual fee for a licensed public accountant's partnership or professional corporation license shall be \$25.

New WAC 4-04-208 ANNUAL LICENSE FEE FOR PUBLIC ACCOUNTANTS

The annual fee for a public accountant's license shall be \$25.

New WAC 4-04-209 ANNUAL LICENSE FEE FOR PUBLIC ACCOUNTANT PARTNERSHIPS

The annual fee for a public accountant's partnership or professional corporation shall be \$25.
