PROCEDURES FOR ADMINISTERING THE
PROFESSIONAL NEGOTIATIONS LAW

NEW

WAC 132L-112-923 EFFECT OF BOARD/ACADEMIC EMPLOYEE AGREEMENT. Where there exists a valid Board/Academic Employee Agreement in effect with the recognized employee organization, no question of academic employee representation or request for an election may be raised except during the period not more than ninety (90) or less than sixty (60) days prior to the expiration date of the agreement.
