5 Strike everything after the enacting clause and insert the  
6 following:

7 "Sec. 1. RCW 41.04.230 and 1988 c 107 s 19 are each amended to  
8 read as follows:

9 Any official of the state authorized to disburse funds in payment  
10 of salaries and wages of public officers or employees is authorized,  
11 upon written request of the officer or employee, to deduct from the  
12 salaries or wages of the officers or employees, the amount or amounts  
13 of subscription payments, premiums, contributions, or continuation  
14 thereof, for payment of the following:

15 (1) Credit union deductions: PROVIDED, (~~(That the credit union is~~  
16 ~~organized solely for public employees: AND PROVIDED FURTHER,)~~) That  
17 twenty-five or more employees of a single state agency or a total of  
18 one hundred or more state employees of several agencies have authorized  
19 such a deduction for payment to the same credit union. An agency may,  
20 in its own discretion, establish a minimum participation requirement of  
21 fewer than twenty-five employees.

22 (2) Parking fee deductions: PROVIDED, That payment is made for  
23 parking facilities furnished by the agency or by the department of  
24 general administration.

25 (3) U.S. savings bond deductions: PROVIDED, That a person within  
26 the particular agency shall be appointed to act as trustee. The  
27 trustee will receive all contributions; purchase and deliver all bond

1 certificates; and keep such records and furnish such bond or security  
2 as will render full accountability for all bond contributions.

3 (4) Board, lodging or uniform deductions when such board, lodging  
4 and uniforms are furnished by the state, or deductions for academic  
5 tuitions or fees or scholarship contributions payable to the employing  
6 institution.

7 (5) Dues and other fees deductions: PROVIDED, That the deduction is  
8 for payment of membership dues to any professional organization formed  
9 primarily for public employees or college and university professors:  
10 AND PROVIDED, FURTHER, That twenty-five or more employees of a single  
11 state agency, or a total of one hundred or more state employees of  
12 several agencies have authorized such a deduction for payment to the  
13 same professional organization.

14 (6) Labor or employee organization dues may be deducted in the  
15 event that a payroll deduction is not provided under a collective  
16 bargaining agreement under the provisions of RCW 41.06.150: PROVIDED,  
17 That twenty-five or more officers or employees of a single agency, or  
18 a total of one hundred or more officers or employees of several  
19 agencies have authorized such a deduction for payment to the same labor  
20 or employee organization: PROVIDED, FURTHER, That labor or employee  
21 organizations with five hundred or more members in state government may  
22 have payroll deduction for employee benefit programs.

23 (7) Voluntary deductions for political committees duly registered  
24 with the public disclosure commission and/or the federal election  
25 commission: PROVIDED, That twenty-five or more officers or employees  
26 of a single agency or a total of one hundred or more officers or  
27 employees of several agencies have authorized such a deduction for  
28 payment to the same political committee.

29 (8) Insurance contributions to the authority for payment of  
30 premiums under contracts authorized by the state health care authority.

1       (9) Deductions to a bank, savings bank, or savings and loan  
2 association if (a) the bank, savings bank, or savings and loan  
3 association is authorized to do business in this state; and (b) twenty-  
4 five or more employees of a single agency, or fewer, if a lesser number  
5 is established by such agency, or a total of one hundred or more state  
6 employees of several agencies have authorized a deduction for payment  
7 to the same bank, savings bank, or savings and loan association.

8       Deductions from salaries and wages of public officers and employees  
9 other than those enumerated in this section or by other law, may be  
10 authorized by the director of financial management for purposes clearly  
11 related to state employment or goals and objectives of the agency and  
12 for plans authorized by the state health care authority.

13       The authority to make deductions from the salaries and wages of  
14 public officers and employees as provided for in this section shall be  
15 in addition to such other authority as may be provided by law:  
16 PROVIDED, That the state or any department, division, or separate  
17 agency of the state shall not be liable to any insurance carrier or  
18 contractor for the failure to make or transmit any such deduction."

19       "NEW SECTION. Sec. 2. A new section is added to chapter 41.04 RCW  
20 to read as follows:

21       Any official of any local political subdivision of the state,  
22 municipal corporation, or quasi-municipal corporation authorized to  
23 disburse funds in payment of salaries and wages of employees is  
24 authorized upon written request of any employee, to deduct all or part  
25 of such employee's salary or wages for payment to any bank, savings  
26 bank, credit union, or savings and loan association if (1) the bank,  
27 savings bank, credit union, or savings and loan association is  
28 authorized to do business in this state; and (2) twenty-five or more  
29 employees of a single local political subdivision, or fewer, if a

1 lesser number is established by such local political subdivision,  
2 authorize such a deduction for payment to the same bank, savings bank,  
3 credit union, or savings and loan association."
