- 1 TO THE HONORABLE GEORGE BUSH, PRESIDENT OF THE UNITED STATES, AND
- 2 TO THE PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE OF
- 3 REPRESENTATIVES, AND TO THE SENATE AND HOUSE OF REPRESENTATIVES OF THE
- 4 UNITED STATES, IN CONGRESS ASSEMBLED:
- 5 We, your Memorialists, the Senate and House of Representatives of
- 6 the State of Washington, in legislative session assembled, respectfully
- 7 represent and petition as follows:
- 8 WHEREAS, Although the right of free speech is part of the
- 9 foundation of the United States Constitution, no right is absolute and
- 10 certain limits on expression have long been recognized as lawful and
- 11 legitimate means of maintaining public safety and decency, as well as
- 12 the orderliness and productive value of public debate; and
- 13 WHEREAS, Certain actions, although arguably related to one person's
- 14 free expression, nevertheless raise issues concerning public decency,
- 15 public peace, and the rights of expression and sacred values of others;
- 16 and

- 1 WHEREAS, There are symbols of our national soul such as the
- 2 Washington Monument, the United States Capitol Building, the White
- 3 House, and memorials to our greatest leaders, such as Thomas Jefferson
- 4 and Abraham Lincoln, which are the property of every American and are
- 5 therefore worthy of protection from desecration and dishonor; and
- 6 WHEREAS, The Flag of the United States was most nobly born in the
- 7 struggle for independence that began on a bridge in Concord,
- 8 Massachusetts and came to symbolize the stands of a young and brave
- 9 nation against the mighty world powers of that day, and its courageous
- 10 resilience inspired our national anthem; and
- 11 WHEREAS, In the Second World War the Flag of the United States was
- 12 the banner that led the American battle against fascist imperialism
- 13 from the depth of Pearl Harbor to the mountaintop on Iwo Jima, and to
- 14 victory against Hitler's Nazi war machine; and
- 15 WHEREAS, The Flag of the United States symbolizes the principles,
- 16 values, and ideals for which good and decent people have fought for,
- 17 often at the expense of their lives or at the cost of cruel
- 18 condemnation upon their return home; and
- 19 WHEREAS, The Flag of the United States was carried to the moon by
- 20 our astronauts as a banner of goodwill, vision, and triumph on behalf
- 21 of all mankind; and
- 22 WHEREAS, The Flag of the United States to this day is a most
- 23 honorable and worthy banner of a nation which is thankful for its
- 24 strengths and committed to curing its faults, and remains the hope of
- 25 millions of immigrants attracted by the universal power of the American
- 26 ideal; and
- 27 WHEREAS, The law as interpreted by the United States Supreme Court
- 28 can no longer accord to the "Stars and Stripes" that reverence,
- 29 respect, and dignity befitting the banner of that most noble experiment
- 30 of a nation-state; and

- 1 WHEREAS, It is only fitting that people everywhere should lend
- 2 their voices to a forceful call for restoration of the "Stars and
- 3 Stripes to a proper station under law and decency.
- 4 NOW, THEREFORE, Your Memorialists respectively petition the
- 5 Congress of the United States to propose an amendment of the United
- 6 States Constitution, for ratification by the states, specifying that
- 7 Congress and the states shall have the power to prohibit the physical
- 8 desecration of the Flag of the United States.
- 9 BE IT RESOLVED, That copies of this Memorial be immediately
- 10 transmitted to the Honorable George Bush, President of the United
- 11 States, the President of the United States Senate, the Speaker of the
- 12 House of Representatives, and to each member of Congress from the State
- 13 of Washington.
