1            AN ACT Relating to the international marketing program for  
2 agricultural commodities and trade; amending RCW 43.131.329 and  
3 43.131.330; and creating a new section.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5            **Sec. 1.** RCW 43.131.329 and 1988 c 288 s 11 are each amended to  
6 read as follows:

7            The international marketing program for agricultural commodities  
8 and trade at Washington State University shall be terminated on June  
9 30, (~~(1992)~~) 1996, as provided in RCW 43.131.330.

10           **Sec. 2.** RCW 43.131.330 and 1988 c 288 s 12 are each amended to  
11 read as follows:

13 hereafter amended, are each repealed, effective June 30, (~~(1993)~~) 1997:

8 (4) Section 6, chapter 57, Laws of 1984, section 4, chapter 39,  
9 Laws of 1985 and RCW 28B.30.541; and

10 (5) Section 7, chapter 57, Laws of 1984, section 5, chapter 39,  
11 Laws of 1985 and RCW 28B.30.543.

12 NEW SECTION. **Sec. 3.** If specific funding for the purposes of  
13 this act, referencing this act by bill number, is not provided by June  
14 30, 1992, in the omnibus appropriations act, this act shall be null and  
15 void.
