HOUSE CONCURRENT RESOLUTION 4412

State of Washington 52nd Legislature 1991 Regular Session

By Representatives Dellwo, Rayburn and Pruitt. Read first time April 5, 1991. Referred to Committee on State Government.

1 WHEREAS, On February 8, 1989, the Senate established the Senate
2 Select Committee on Washington 2000 A.D.; and

3 WHEREAS, The Senate Select Committee on Washington 2000 A.D. was
4 charged with developing a process for the identification and refinement
5 of goals and objectives for the State of Washington, and designing and
6 implementing a process for achieving those goals and objectives by the
7 year 2000; and

8 WHEREAS, The setting of goals and objectives for the State of
9 Washington requires a legislative approach involving both the House of
10 Representatives and the Senate, and the Legislature can be the catalyst
11 that unites all segments of our society in setting long range goals and
12 objectives for the State of Washington; and

13 WHEREAS, Such processes have already begun to take shape with
14 standing committees in both the Senate and the House of Representatives
15 looking at issues from a long-term perspective and in terms of goals
16 and objectives, and with members of the House of Representatives
17 actively involved in the Senate Select Committee's work to date;

1 NOW, THEREFORE, BE IT RESOLVED, By the House of Representatives,
2 the Senate of the State of Washington concurring, That the Senate
3 Select Committee on Washington 2000 A.D. is renamed the Joint Select
4 Committee on Washington 2000, comprised of six Senators, three from
5 each caucus, appointed by the Lieutenant Governor, and six members of
6 the House of Representatives, three from each caucus, appointed by the
7 Speaker of the House; provided that the original members of the Joint
8 Select Committee on Washington 2000 shall be those members of the
9 Senate and the House of Representatives currently assigned to serve on
10 the Senate Select Committee on Washington 2000 A.D.; and

11 BE IT FURTHER RESOLVED, That the Joint Select Committee on
12 Washington 2000 shall report to the Legislature at regular intervals,
13 and shall continue in existence until it has accomplished its
14 objectives, and shall solicit the cooperation and input of members of
15 the private sector, the public sector, and the academic community.
