5 state universities, regional universities, and The Evergreen State College shall submit to the Washington higher education coordinating 6 board a comprehensive plan to combat student alcohol abuse, including The comprehensive plan must include means for underage drinking. 8 9 assuring to the highest degree possible that there is no underage 10 drinking on the college or university campus. The comprehensive plan must also provide details of services that will be offered to students 11

Sec. 1. No later than January 1, 1994, each of the

- 12 who are problem drinkers. Further, the plan must include strategies
- 13 combating alcohol abuse and underage drinking in
- 14 residences, such as fraternities and sororities. The strategies for
- 15 combating alcohol abuse and underage drinking must include, but not be
- 16 limited to, a program in which the college or university enters into
- 17 individual agreements with all of the fraternities and sororities at
- the college or university, setting forth its expectations with respect 18
- 19 to the conduct of those groups and their members and the sanctions that

- 1 are to be imposed should the groups fail to satisfy the expectations.
- 2 The agreements must contain at least the following provisions:
- 3 (1) Chapters and their individual members must be expected to 4 comply with federal, state, and local laws and to cooperate fully with
- 5 the police, fire safety officials, and representatives of the
- 6 Washington state liquor control board as they carry out their
- 7 responsibilities;
- 8 (2) Chapters must be held accountable for the conduct of their
- 9 individual members, residents, and guests, and must be expected to take
- 10 disciplinary actions against members who violate the rules and
- 11 expectations of their chapters, the college or university, or the
- 12 community, and to report the actions taken to the appropriate college
- 13 or university official;
- 14 (3) Each organization shall identify persons who can be contacted
- 15 by the police and other enforcement agencies twenty-four hours a day to
- 16 handle emergency concerns;
- 17 (4) Chapters shall conduct uniform education programs covering
- 18 substance abuse and acquaintance rape;
- 19 (5) Chapters shall register all parties involving a minimum of
- 20 twenty-five people where alcohol is consumed with the college or
- 21 university. A chapter meeting or gathering with only chapter members
- 22 in attendance shall not be considered a party under this subsection.
- 23 Banquet permits must be obtained from the liquor control board for
- 24 every party under this subsection;
- 25 (6) The college or university shall review the agreements for
- 26 renewal on an annual basis;
- 27 (7) Sanctions for violations of the agreements must include, but
- 28 not be limited to, warnings, reprimands, monetary fines, restitution
- 29 for property damage, probation, suspension, or withdrawal of
- 30 recognition. Upon withdrawal of recognition of a fraternity or
- 31 sorority chapter the college or university shall immediately notify the
- 32 national fraternity or sorority that the chapter is no longer in good
- 33 standing at the college or university.
- Copies of the comprehensive plan must be submitted by January 1,
- 35 1994, to the house of representatives committees on commerce and labor
- 36 and higher education and the senate committees on labor and commerce
- 37 and higher education.
