- 4 **Sec. 1.** RCW 83.100.160 and 1988 c 64 s 15 are each amended to read 5 as follows:
- 6 Upon filing findings under RCW 83.100.150, the clerk of the
- 7 superior court shall give notice of the filing ((to all persons
- 8 interested in the proceeding)) by causing notice thereof to be posted
- 9 at the courthouse in the county in which the court is located((, and in
- 10 addition thereto shall mail)). In addition, the department of revenue
- 11 shall give notice of the filing to all persons interested in the
- 12 proceeding by mailing a copy of the notice to all persons having an
- 13 interest in property subject to the tax. The department of revenue is
- 14 not required to conduct a search for persons interested in the
- 15 proceedings or property. The department of revenue must mail a copy of
