- 4 <u>NEW SECTION.</u> **Sec. 1.** The legislature recognizes the importance of 5 manufactured housing as an affordable housing source, and the need to develop a feasible alternative to vehicle titling for obtaining and 6 transferring ownership of manufactured homes. The department of and economic development, community, trade, the department 8 licensing, and the department of revenue shall study and develop 9 10 proposed legislation that creates a certificate of ownership program for manufactured homes. The department of community, trade, and 11 economic development shall act as the lead agency in the development of 12 13 the proposed legislation. The proposed legislation shall treat 14 manufactured housing as real property to the greatest extent possible 15 for ownership and taxation purposes, with the program being administered at the local level. 16 The departments shall consult with 17 the various affected interest groups, including local government officials and the affordable housing advisory board established in RCW 18

43.185B.020, in the development of this proposed legislation.
