6 following:

7 NEW SECTION. **Sec. 1.** A new section is added to chapter 2.48 RCW  
8 to read as follows:

9 The Washington state supreme court may provide by court rule that  
10 nonpayment or default on a federally or state-guaranteed educational  
11 loan shall result in disbarment or license suspension of the license of  
12 any person who has been certified by a lending agency and reported to  
13 the court for nonpayment or default on a federally or state-guaranteed  
14 educational loan or service-conditional scholarship. The supreme court  
15 may reinstate the person when provided with a written release issued by  
16 the lending agency stating that the person is making payments on the  
17 loan in accordance with a repayment agreement approved by the lending  
18 agency.

19 NEW SECTION. **Sec. 2.** A new section is added to chapter 18.04 RCW  
20 to read as follows:

21 The board shall suspend the license or certificate of any person  
22 who has been certified by a lending agency and reported to the board  
23 for nonpayment or default on a federally or state-guaranteed  
24 educational loan or service-conditional scholarship. Prior to the  
25 suspension, the agency must provide the person an opportunity for a  
26 brief adjudicative proceeding under RCW 34.05.485 through 34.05.494 and  
27 issue a finding of nonpayment or default on a federally or state-  
28 guaranteed educational loan or service-conditional scholarship. The  
29 person's license or certificate shall not be reissued until the person  
30 provides the board a written release issued by the lending agency  
31 stating that the person is making payments on the loan in accordance  
32 with a repayment agreement approved by the lending agency. If the  
33 person has continued to meet all other requirements for licensure or  
34 certification during the suspension, reinstatement shall be automatic

1 upon receipt of the notice and payment of any reinstatement fee the  
2 board may impose.

3 NEW SECTION. **Sec. 3.** A new section is added to chapter 18.08 RCW  
4 to read as follows:

5 The board shall suspend the certificate or registration of any  
6 person who has been certified by a lending agency and reported to the  
7 board for nonpayment or default on a federally or state-guaranteed  
8 educational loan or service-conditional scholarship. Prior to the  
9 suspension, the agency must provide the person an opportunity for a  
10 brief adjudicative proceeding under RCW 34.05.485 through 34.05.494 and  
11 issue a finding of nonpayment or default on a federally or state-  
12 guaranteed educational loan or service-conditional scholarship. The  
13 person's certificate or registration shall not be reissued until the  
14 person provides the board a written release issued by the lending  
15 agency stating that the person is making payments on the loan in  
16 accordance with a repayment agreement approved by the lending agency.  
17 If the person has continued to meet all other requirements for  
18 certification or registration during the suspension, reinstatement

27 scholarship. Prior to the suspension, the agency must provide the  
28 person an opportunity for a brief adjudicative proceeding under RCW  
29 34.05.485 through 34.05.494 and issue a finding of nonpayment or  
30 default on a federally or state-guaranteed educational loan or  
31 service-conditional scholarship. The person's license, certificate, or  
32 registration shall not be reissued until the person provides the  
33 director a written release issued by the lending agency stating that

37 or registration during the suspension, reinstatement shall be automatic

5 The director shall suspend the license of any person who has been  
6 certified by a lending agency and reported to the director for  
7 nonpayment or default on a federally or state-guaranteed educational  
8 loan or service-conditional scholarship. Prior to the suspension, the  
9 agency must provide the person an opportunity for a brief adjudicative  
10 proceeding under RCW 34.05.485 through 34.05.494 and issue a finding of  
11 nonpayment or default on a federally or state-guaranteed educational  
12 loan or service-conditional scholarship. The person's license shall  
13 not be reissued until the person provides the director a written

27 proceeding under RCW 34.05.485 through 34.05.494 and issue a finding of  
28 nonpayment or default on a federally or state-guaranteed educational  
29 loan or service-conditional scholarship. The person's license shall  
30 not be reissued until the person provides the secretary a written  
31 release issued by the lending agency stating that the person is making  
32 payments on the loan in accordance with a repayment agreement approved  
33 by the lending agency. If the person has continued to meet all other  
34 requirements for licensure during the suspension, reinstatement shall  
35 be automatic upon receipt of the notice and payment of any  
36 reinstatement fee the secretary may impose.

7 suspension, the agency must provide the person an opportunity for a

15 payments on the loan in accordance with a repayment agreement approved  
16 by the lending agency. If the person has continued to meet all other  
17 requirements for licensure during the suspension, reinstatement shall  
18 be automatic upon receipt of the notice and payment of any  
19 reinstatement fee the director may impose.

20 NEW SECTION. **Sec. 27.** A new section is added to chapter 28A.410  
21 RCW to read as follows:

22 The authorizing authority shall suspend the certificate or permit  
23 of any person who has been certified by a lending agency and reported  
24 to the authorizing authority for nonpayment or default on a federally  
25 or state-guaranteed educational loan or service-conditional  
26 scholarship. Prior to the suspension, the agency must provide the  
27 person an opportunity for a brief adjudicative proceeding under RCW  
28 34.05.485 through 34.05.494 and issue a finding of nonpayment or  
29 default on a federally or state-guaranteed educational loan or  
30 service-conditional scholarship. The person's certificate or permit  
31 shall not be reissued until the person provides the authorizing  
32 authority a written release issued by the lending agency stating that  
33 the person is making payments on the loan in accordance with a  
34 repayment agreement approved by the lending agency. If the person has  
35 continued to meet all other requirements for certification or permit  
36 during the suspension, reinstatement shall be automatic upon receipt of

1 the notice and payment of any reinstatement fee the authorizing  
2 authority may impose.

3 NEW SECTION. **Sec. 28.** If any provision of this act or its  
4 application to any person or circumstance is held invalid, the  
5 remainder of the act or the application of the provision to other  
6 persons or circumstances is not affected."
