- 8 age but under twenty-one years of age may elect to exclude from
- 9 mandatory coverage under this title the parent's employment of that
- 10 person in agricultural activities on their family farm if:
- 11 (a) The person resides with his or her parent or parents or resides
- 12 on their family farm; and
- 13 (b) The parent or parents file a written notice with the department
- 14 electing exclusion from coverage.

- 2 this subsection may subsequently obtain coverage for that person under
