7 "Sec. 1. RCW 70.93.010 and 1992 c 175 s 1 are each amended to read
8 as follows:

9 (1) The legislature finds:

10 (a) Washington state is experiencing rapid population growth and
11 its citizens are increasingly mobile;

12 (b) There is a fundamental need for a healthful, clean, and
13 beautiful environment;

14 (c) The proliferation and accumulation of litter discarded
15 throughout this state impairs this need and constitutes a public health
16 hazard;

17 (d) There is a need to conserve energy and natural resources, and
18 the effective litter control and recovery and recycling of litter
19 materials will serve to accomplish such conservation; and

20 (e) In addition to effective litter control, there must be
21 effective programs to accomplish waste reduction, the state's highest
22 waste management priority(~~(/and~~

23 ~~(f) There must also be effective systems to accomplish all~~
24 ~~components of recycling, including collection, processing, and the~~
25 ~~marketing of recyclable materials and recycled content products)).~~

26 (2) Recognizing the multifaceted nature of the state's solid waste
27 management problems, the legislation enacted in 1971 and entitled the
28 "Model Litter Control and Recycling Act" is hereby renamed the "waste
29 reduction, recycling, and model litter control act."

30 **Sec. 2.** RCW 70.93.020 and 1992 c 175 s 2 are each amended to read
31 as follows:

32 The purpose of this chapter is to accomplish litter control,
33 increase waste reduction, and stimulate all components of recycling
34 throughout this state by delegating to the department of ecology the
35 authority to:

- 1 (1) Conduct a permanent and continuous program to control and
2 remove litter from this state to the maximum practical extent possible;
3 (2) Recover and recycle waste materials related to litter and
4 littering;
5 (3) Foster public and private recycling of recyclable materials;
6 and
7 (4) Increase public awareness of the need for waste reduction,
8 recycling, and litter control.

9 ~~((It is further the intent and purpose of this chapter to promote
10 markets for recyclable materials through programs of the clean
11 Washington center and other means.))~~

12 It is further the intent and purpose of this chapter to create jobs
13 for employment of youth in litter cleanup and related activities and to
14 stimulate and encourage small, private recycling centers. This program
15 shall include the compatible goal of recovery of recyclable materials
16 to conserve energy and natural resources wherever practicable. Every
17 other department of state government and all local governmental units
18 and agencies of this state shall cooperate with the department of
19 ecology in the administration and enforcement of this chapter. The
20 intent of this chapter is to add to and to coordinate existing
21 recycling and litter control and removal efforts and not terminate or
22 supplant such efforts.

23 **Sec. 3.** RCW 70.93.180 and 1992 c 175 s 8 are each amended to read
24 as follows:

25 (1) There is hereby created an account within the state treasury to
26 be known as the "waste reduction, recycling, and litter control
27 account". Moneys in the account may be spent only after appropriation.
28 After June 30, 1997, expenditures from the waste reduction, recycling,
29 and litter control account shall be used as follows:

30 (a) ~~((From July 1, 1992, to June 30, 1993, funds shall be used for
31 programs to: Control litter; encourage recycling; develop markets for
32 recyclable materials; and enforce compliance with the litter tax
33 imposed in RCW 82.19.010.~~

34 ~~(b) After June 30, 1993, funds shall be used as follows:~~

35 ~~(i) Not less than forty percent nor more than)) Fifty percent for
36 a litter patrol program to employ youth from the state to remove litter
37 from places and areas that are most visible to the public ((and to
38 enforce compliance with the litter tax imposed in RCW 82.19.010)). The~~

1 department may enter into an interagency agreement with the department
2 of corrections to provide for litter removal in areas that are not
3 accessible to the youth crew;

4 (b) Twenty-five percent for grants to local governments for litter
5 cleanup under RCW 70.93.250; ((and

6 (ii) Not more than sixty)) (c) Twenty-five percent for the
7 following purposes:

8 (i) Public education and awareness programs to reduce waste,
9 increase recycling, and to control litter((; programs to promote public
10 education and awareness of the model litter control and recycling act;
11 programs to foster private local recycling efforts, encourage
12 recycling, and develop markets for recyclable materials)); and

13 (ii) To increase compliance with the litter tax imposed in RCW
14 82.19.010.

15 (2) All taxes imposed in RCW 82.19.010 and fines and bail
16 forfeitures collected or received pursuant to this chapter shall be
17 deposited in the waste reduction, recycling, and litter control account
18 and used for the programs under subsection (1) of this section(~~(, and~~
19 ~~except as required to be otherwise distributed under RCW 70.93.070)).~~

20 **Sec. 4.** RCW 82.19.010 and 1992 c 175 s 3 are each amended to read
21 as follows:

22 In addition to any other taxes, there is hereby levied and there
23 shall be collected by the department of revenue from every person for
24 the privilege of engaging within this state in business as a
25 manufacturer, as a wholesaler, or as a retailer, ~~((an annual))~~ a
26 quarterly litter tax equal to the value of products listed in RCW
27 82.19.020, including byproducts, manufactured within this state,
28 multiplied by fifteen one-thousandths of one percent in the case of
29 manufacturers, and equal to the gross proceeds of sales of the products
30 listed in RCW 82.19.020 that are sold within this state multiplied by
31 fifteen one-thousandths of one percent in the case of wholesalers and
32 retailers.

33 NEW SECTION. **Sec. 5.** A new section is added to chapter 70.93 RCW
34 to read as follows:

35 The department shall convene a task force to review and make
36 recommendations on the appropriate funding levels for the activities
37 identified under RCW 70.93.180. The task force shall consist of four

1 legislators, one from each caucus; one person each to represent the
2 departments of ecology, transportation, and corrections; two persons
3 each to represent cities and counties; and one person each to represent
4 four different industry groups paying the tax imposed under RCW
5 82.19.010. Members of the house of representatives shall be appointed
6 by the speaker of the house of representatives and members of the
7 senate shall be appointed by the president of the senate. Agency
8 representatives shall be appointed by the respective agency director.
9 All other appointments shall be made by the director of the department
10 of ecology. The task force shall submit a report with recommendations
11 on funding levels for activities under RCW 70.93.180 to the appropriate
12 committees of the house of representatives and senate by December 1,
13 1997.

14 NEW SECTION. **Sec. 6.** Section 4 of this act takes effect January
15 1, 1998."
