7 NEW SECTION. **Sec. 1.** The Lewis and Clark bicentennial advisory
8 committee is created under the auspices of the Washington state
9 historical society. The committee shall consist of fifteen members, as
10 follows:

11 (1) Nine citizen members, at least four of whom must be enrolled
12 members of a Washington Indian tribe, who shall be appointed by the
13 governor;

14 (2) The president of the Washington state historical society;

15 (3) The director of the Washington state parks and recreation
16 commission;

17 (4) The secretary of the Washington state department of
18 transportation;

19 (5) The director of the Washington state department of community,
20 trade, and economic development;

21 (6) The secretary of state or his or her designee; and

22 (7) The chair of the Lewis and Clark trail advisory committee.

23 NEW SECTION. **Sec. 2.** (1) The Lewis and Clark bicentennial
24 committee shall coordinate and provide guidance to Washington's
25 observance of the bicentennial of the Lewis and Clark expedition. The
26 committee may:

27 (a) Cooperate with national, regional, state-wide, and local events
28 promoting the bicentennial;

29 (b) Assist, plan, or conduct bicentennial events;

30 (c) Engage in or encourage fund-raising activities including
31 revenue-generating enterprises, as well as the solicitation of
32 charitable gifts, grants, or donations;

33 (d) Promote public education concerning the importance of the Lewis
34 and Clark expedition in American history, including the role of Native
35 people in making the expedition a success;

1 (e) Coordinate interagency participation in the observance; and
2 (f) Perform other related duties.

3 (2) The committee is attached to the Washington state historical
4 society for administrative purposes. Accordingly, the society shall:

5 (a) Direct and supervise the budgeting, recordkeeping, reporting,
6 and related administrative and clerical functions of the committee;

7 (b) Include the committee's budgetary requests in the society's
8 departmental budget;

9 (c) Collect all nonappropriated revenues for the committee and
10 deposit them in the proper fund or account;

11 (d) Provide staff support for the committee;

12 (e) Print and disseminate for the committee any required notices,
13 rules, or orders adopted by the committee; and

14 (f) Allocate or otherwise provide office space to the committee as
15 may be necessary.

16 NEW SECTION. **Sec. 3.** The Lewis and Clark bicentennial account is
17 created in the state treasury. Expenditures from the account may only
18 be expended to finance the activities of the Lewis and Clark
19 bicentennial committee and all expenditures must be authorized by the
20 director of the Washington state historical society or the director's
21 designee. Moneys in the account may only be spent after appropriation.
22 The account is subject to the allotment procedures under chapter 43.88
23 RCW.

24 NEW SECTION. **Sec. 4.** Sections 1 through 3 of this act expire June
25 30, 2007.

26 NEW SECTION. **Sec. 5.** RCW 27.34.340 and 1996 c 65 s 1 are each
27 repealed."
