14 following:

15 "**Sec. 2.** RCW 46.20.720 and 1997 c 229 s 8 are each amended to read
16 as follows:

17 (1) The court may order that after a period of suspension,
18 revocation, or denial of driving privileges, and for up to as long as
19 the court has jurisdiction, any person convicted of any offense
20 involving the use, consumption, or possession of alcohol while
21 operating a motor vehicle may drive only a motor vehicle equipped with
22 a functioning ignition interlock or other biological or technical
23 device.

24 (2) If a person is convicted of a violation of RCW 46.61.502 or
25 46.61.504 or an equivalent local ordinance, the court shall order that
26 after a period of suspension, revocation, or denial of driving
27 privileges, the person may drive only a motor vehicle equipped with a
28 functioning ignition interlock or other biological or technical device.

29 (3) The court shall establish a specific calibration setting at
30 which the ignition interlock or other biological or technical device
31 will prevent the motor vehicle from being started and the period of
32 time that the person shall be subject to the restriction. In the case

1 of a person under subsection (2) of this section, the period of time of
2 the restriction will be as follows:

3 (a) For a person subject to RCW 46.61.5055 (1)(b), (2), or (3) who
4 has not previously been restricted under this section, a period of not
5 less than one year;

6 (b) For a person who has previously been restricted under (a) of
7 this subsection, a period of not less than five years;

8 (c) For a person who has previously been restricted under (b) of
9 this subsection, a permanent, lifetime restriction.

10 For purposes of this section, "convicted" means being found guilty
11 of an offense or being placed on a deferred prosecution program under
12 chapter 10.05 RCW."

21 of financial management."
