- 4 (5) The department of revenue shall perform the collection of such taxes on behalf of the county at no cost to the county. In lieu of the 5 charge for the administration and collection of local sales and use 6 taxes under RCW 82.14.050 from which the county is exempt under this 7 8 subsection (5), a percentage of the tax revenues authorized by this section equal to one-half of the maximum percentage provided in RCW 9 82.14.050 shall be transferred annually to the department of community, 10 trade, and economic development, or its successor agency, from the 11 funds allocated under subsection (6)(b) of this section for a period of 12 twelve years from the first date of distribution of funds under 13 14 subsection (6)(b) of this section.
