- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 9.94A.120 and 1999 c 324 s 2, 1999 c 197 s 4, 1999 c
- 6 196 s 5, and 1999 c 147 s 3 are each reenacted and amended to read as
- 7 follows:
- 8 When a person is convicted of a felony, the court shall impose
- 9 punishment as provided in this section.
- 10 (1) Except as authorized in subsections (2), (4), (5), (6), and (8)
- 11 of this section, the court shall impose a sentence within the sentence
- 12 range for the offense.
- 13 (2) The court may impose a sentence outside the standard sentence
- 14 range for that offense if it finds, considering the purpose of this
- 15 chapter, that there are substantial and compelling reasons justifying
- 16 an exceptional sentence.
- 17 (3) Whenever a sentence outside the standard range is imposed, the
- 18 court shall set forth the reasons for its decision in written findings

of fact and conclusions of law. A sentence outside the standard range shall be a determinate sentence.

(4) A persistent offender shall be sentenced to a term of total 3 4 confinement for life without the possibility of parole or, when authorized by RCW 10.95.030 for the crime of aggravated murder in the 5 first degree, sentenced to death, notwithstanding the maximum sentence 6 7 under any other law. An offender convicted of the crime of murder in 8 the first degree shall be sentenced to a term of total confinement not 9 less than twenty years. An offender convicted of the crime of assault 10 in the first degree or assault of a child in the first degree where the offender used force or means likely to result in death or intended to 11 kill the victim shall be sentenced to a term of total confinement not 12 less than five years. An offender convicted of the crime of rape in 13 14 the first degree shall be sentenced to a term of total confinement not 15 less than five years. The foregoing minimum terms of total confinement 16 are mandatory and shall not be varied or modified as provided in subsection (2) of this section. In addition, all offenders subject to 17 the provisions of this subsection shall not be eligible for community 18 19 custody, earned release time, furlough, home detention, partial confinement, work crew, work release, or any other form of early 20 release as defined under RCW 9.94A.150 (1), (2), (3), (((5), (7), or21 (8))) (6), (8), or (9), or any other form of authorized leave of 22 absence from the correctional facility while not in the direct custody 23 24 of a corrections officer or officers during such minimum terms of total 25 confinement except: (a) In the case of an offender in need of 26 emergency medical treatment; (b) for the purpose of commitment to an inpatient treatment facility in the case of an offender convicted of 27 the crime of rape in the first degree; or (c) for an extraordinary 28 29 medical placement when authorized under RCW 9.94A.150(4).

(5)(a) In sentencing a first-time offender the court may waive the imposition of a sentence within the sentence range and impose a sentence which may include up to ninety days of confinement in a facility operated or utilized under contract by the county and a requirement that the offender refrain from committing new offenses. The sentence may also include a term of community supervision or community custody as specified in (b) of this subsection, which, in addition to crime-related prohibitions, may include requirements that the offender perform any one or more of the following:

(i) Devote time to a specific employment or occupation;

- (ii) Undergo available outpatient treatment for up to the period 1 specified in (b) of this subsection, or inpatient treatment not to 2 exceed the standard range of confinement for that offense; 3
- 4 (iii) Pursue a prescribed, secular course of study or vocational 5 training;
- (iv) Remain within prescribed geographical boundaries and notify 6 7 the community corrections officer prior to any change in the offender's 8 address or employment;
 - (v) Report as directed to a community corrections officer; or
- 10 (vi) Pay all court-ordered legal financial obligations as provided 11 in RCW 9.94A.030 and/or perform community service work.

- 12 (b) The terms and statuses applicable to sentences under (a) of 13 this subsection are:
- 14 (i) For sentences imposed on or after July 25, 1999, for crimes 15 committed before July 1, 2000, up to one year of community supervision.
- 16 If treatment is ordered, the period of community supervision may 17 include up to the period of treatment, but shall not exceed two years; 18 and
- 19 (ii) For crimes committed on or after July 1, 2000, up to one year 20 of community custody unless treatment is ordered, in which case the period of community custody may include up to the period of treatment, 21 but shall not exceed two years. Any term of community custody imposed 22 under this subsection (5) is subject to conditions and sanctions as 23 24 authorized in this subsection (5) and in subsection (11)(b) and (c) of

- (iii) For a violation of the uniform controlled substances act 38 39 under chapter 69.50 RCW or a criminal solicitation to commit such a

- 1 violation under chapter 9A.28 RCW, the offense involved only a small
- 2 quantity of the particular controlled substance as determined by the
- 3 judge upon consideration of such factors as the weight, purity,
- 4 packaging, sale price, and street value of the controlled substance;

- 6 (iv) The offender has not been found by the United States attorney
- 7 general to be subject to a deportation detainer or order and does not

- (F) Stay out of areas designated by the sentencing judge;
- 14 (G) Such other conditions as the court may require such as 15 affirmative conditions.
- (c) If the offender violates any of the sentence conditions in (b) of this subsection or is found by the United States attorney general to be subject to a deportation order, a violation hearing shall be held by the department unless waived by the offender.
- 20 <u>(i)</u> If the department finds that conditions have been willfully 21 violated, the offender may be reclassified to serve the remaining 22 balance of the original sentence.
 - (ii) If the department finds that the offender is subject to a valid deportation order, the department may administratively terminate the offender from the program and reclassify the offender to serve the remaining balance of the original sentence.
 - (d) The department shall determine the rules for calculating the value of a day fine based on the offender's income and reasonable obligations which the offender has for the support of the offender and any dependents. These rules shall be developed in consultation with the administrator for the courts, the office of financial management, and the commission.
- 33 (e) An offender who fails to complete the special drug offender 34 sentencing alternative program or who is administratively terminated 35 from the program shall be reclassified to serve the unexpired term of 36 his or her sentence as ordered by the sentencing judge and shall be 37 subject to all rules relating to <u>community custody and</u> earned early 38 release time. An offender who violates any conditions of supervision 39 as defined by the department shall be sanctioned. Sanctions may

- 21 court, on its own motion or the motion of the state or the defendant,
- 22 may order an examination to determine whether the defendant is amenable

(E) Recommended crime-related prohibitions.

The court on its own motion may order, or on a motion by the state shall order, a second examination regarding the offender's amenability to treatment. The evaluator shall be selected by the party making the motion. The defendant shall pay the cost of any second examination ordered unless the court finds the defendant to be indigent in which acse the state shall pay the cost.

- 9 (ii) After receipt of the reports, the court shall consider whether 10 the offender and the community will benefit from use of this special sex offender sentencing alternative and consider the victim's opinion 11 whether the offender should receive a treatment disposition under this 12 13 subsection. If the court determines that this special sex offender sentencing alternative is appropriate, the court shall then impose a 14 15 sentence within the sentence range. If this sentence is less than 16 eleven years of confinement, the court may suspend the execution of the 17 sentence and impose the following conditions of suspension:
- (A) The court shall place the defendant on community custody for the length of the suspended sentence or three years, whichever is greater, and require the offender to comply with any conditions imposed by the department of corrections under subsection (15) of this section;
 - (B) The court shall order treatment for any period up to three years in duration. The court in its discretion shall order outpatient sex offender treatment or inpatient sex offender treatment, if available. A community mental health center may not be used for such treatment unless it has an appropriate program designed for sex The offender shall not change sex offender offender treatment. treatment providers or treatment conditions without first notifying the prosecutor, the community corrections officer, and the court, and shall not change providers without court approval after a hearing if the prosecutor or community corrections officer object to the change. In addition, as conditions of the suspended sentence, the court may impose other sentence conditions including up to six months of confinement, not to exceed the sentence range of confinement for that offense, crime-related prohibitions, and requirements that the offender perform any one or more of the following:
 - (I) Devote time to a specific employment or occupation;

- 1 (II) Remain within prescribed geographical boundaries and notify 2 the court or the community corrections officer prior to any change in 3 the offender's address or employment;
- 4 (III) Report as directed to the court and a community corrections 5 officer;
- 6 (IV) Pay all court-ordered legal financial obligations as provided 7 in RCW 9.94A.030, perform community service work, or any combination 8 thereof; or
- 9 (V) Make recoupment to the victim for the cost of any counseling 10 required as a result of the offender's crime; and
- 11 (C) Sex offenders sentenced under this special sex offender 12 sentencing alternative are not eligible to accrue any earned release 13 time while serving a suspended sentence.
- (iii) The sex offender therapist shall submit quarterly reports on the defendant's progress in treatment to the court and the parties. The report shall reference the treatment plan and include at a minimum the following: Dates of attendance, defendant's compliance with requirements, treatment activities, the defendant's relative progress in treatment, and any other material as specified by the court at
- (iv) At the time of sentencing, the court shall set a treatment 21 termination hearing for three months prior to the anticipated date for 22 completion of treatment. Prior to the treatment termination hearing, 23 24 the treatment professional and community corrections officer shall 25 submit written reports to the court and parties regarding the 26 defendant's compliance with treatment and monitoring requirements, and recommendations regarding termination from treatment, 27 proposed community supervision conditions. Either party may request 28 and the court may order another evaluation regarding the advisability 29 30 of termination from treatment. The defendant shall pay the cost of any 31 additional evaluation ordered unless the court finds the defendant to be indigent in which case the state shall pay the cost. 32 treatment termination hearing the court may: (A) Modify conditions of 33 34 community custody, and either (B) terminate treatment, or (C) extend 35 treatment for up to the remaining period of community custody.

- (vii) Except as provided in (a)(viii) of this subsection, after July 1, 1991, examinations and treatment ordered pursuant to this subsection shall only be conducted by sex offender treatment providers certified by the department of health pursuant to chapter 18.155 RCW.

(ii) Except for persons sentenced under (b) of this subsection or subsection (10)(a) of this section, when a court sentences a person to a term of total confinement to the custody of the department of corrections for a violent offense, any crime against a person under RCW 9.94A.440(2), or any felony offense under chapter 69.50 or 69.52 RCW not sentenced under subsection (6) of this section, committed on or after July 25, 1999, but before July 1, 2000, the court shall in addition to the other terms of the sentence, sentence the offender to a one-year term of community placement beginning either upon completion of the term of confinement or at such time as the offender is transferred to community custody in lieu of earned release in accordance with RCW 9.94A.150 (1) and (2). - 3 (vi) For an offender convicted of a felony sex offense against a 4 minor victim after June 6, 1996, the offender shall comply with any 5 terms and conditions of community placement imposed by the department 6 of corrections relating to contact between the sex offender and a minor 7 victim or a child of similar age or circumstance as a previous victim.
 - (d) Prior to transfer to, or during, community placement, any conditions of community placement may be removed or modified so as not to be more restrictive by the sentencing court, upon recommendation of the department of corrections.

- (10)(a) When a court sentences a person to the custody of the 12 13 department of corrections for an offense categorized as a sex offense committed on or after June 6, 1996, but before July 1, 2000, the court 14 shall, in addition to other terms of the sentence, sentence the 15 16 offender to community custody for three years or up to the period of 17 earned release awarded pursuant to RCW 9.94A.150 (1) and (2), whichever is longer. The community custody shall begin either upon completion of 18 19 the term of confinement or at such time as the offender is transferred 20 to community custody in lieu of earned release in accordance with RCW 9.94A.150 (1) and (2). 21
 - (b) Unless a condition is waived by the court, the terms of community custody shall be the same as those provided for in subsection (9)(b) of this section and may include those provided for in subsection (9)(c) of this section. As part of any sentence that includes a term of community custody imposed under this subsection, the court shall also require the offender to comply with any conditions imposed by the department of corrections under subsection (15) of this section.
- 29 (c) At any time prior to the completion of a sex offender's term of 30 community custody, if the court finds that public safety would be enhanced, the court may impose and enforce an order extending any or 31 all of the conditions imposed pursuant to this section for a period up 32 to the maximum allowable sentence for the crime as it is classified in 33 chapter 9A.20 RCW, regardless of the expiration of the offender's term 34 35 of community custody. If a violation of a condition extended under this subsection occurs after the expiration of the offender's term of 36 37 community custody, it shall be deemed a violation of the sentence for the purposes of RCW 9.94A.195 and may be punishable as contempt of 38 39 court as provided for in RCW 7.21.040.

(11)(a) When a court sentences a person to the custody of the department of corrections for a sex offense, a violent offense, any crime against a person under RCW 9.94A.440(2), or a felony offense under chapter 69.50 or 69.52 RCW ((not sentenced under subsection (6) of this section)), committed on or after July 1, 2000, the court shall in addition to the other terms of the sentence, sentence the offender to community custody for the community custody range or up to the period of earned release awarded pursuant to RCW 9.94A.150 (1) and (2), whichever is longer. The community custody shall begin ((either)):

(i) Upon completion of the term of confinement ((er)); (ii) at such time as the offender is transferred to community custody in lieu of earned release in accordance with RCW 9.94A.150 (1) and (2); or (iii) with regard to offenders sentenced under subsection (6) of this section, upon failure to complete or administrative termination from the special drug offender sentencing alternative program.

(b) Unless a condition is waived by the court, the conditions of community custody shall include those provided for in subsection (9)(b)(i) through (vi) of this section. The conditions may also include those provided for in subsection (9)(c)(i) through (vi) of this The court may also order the offender to participate in section. rehabilitative programs or otherwise perform affirmative conduct reasonably related to the circumstances of the offense, the offender's risk of reoffending, or the safety of the community, and the department shall enforce such conditions pursuant to (f) of this subsection. As part of any sentence that includes a term of community custody imposed under this subsection, the court shall also require the offender to comply with any conditions imposed by the department of corrections under subsection (15) of this section. The department shall assess the offender's risk of reoffense and may establish and modify additional conditions of the offender's community custody based upon the risk to community safety. The department may not impose conditions that are contrary to those ordered by the court and may not contravene or decrease court imposed conditions. The department shall notify the offender in writing of any such conditions or modifications. In setting, modifying, and enforcing conditions of community custody, the department shall be deemed to be performing a quasi-judicial function.

(c) If an offender violates conditions imposed by the court or the department pursuant to this subsection during community custody, the department may transfer the offender to a more restrictive confinement

- status and impose other available sanctions as provided in RCW 1 2 9.94A.205 and 9.94A.207.
- (d) Except for terms of community custody under subsection (8) of 3 4 this section, the department shall discharge the offender from 5 community custody on a date determined by the department, which the department may modify, based on risk and performance of the offender, 6 7 within the range or at the end of the period of earned release, 8 whichever is later.
- 9 (e) At any time prior to the completion or termination of a sex 10 offender's term of community custody, if the court finds that public safety would be enhanced, the court may impose and enforce an order 11 extending any or all of the conditions imposed pursuant to this section 12 13 for a period up to the maximum allowable sentence for the crime as it is classified in chapter 9A.20 RCW, regardless of the expiration of the 14 15 offender's term of community custody. - 29 (g) By the close of the next business day after receiving notice of 30 a condition imposed or modified by the department, an offender may request an administrative review under rules adopted by the department. 31 The condition shall remain in effect unless the reviewing officer finds 32 that it is not reasonably related to any of the following: (i) The 33 34 crime of conviction; (ii) the offender's risk of reoffending; or (iii) 35 the safety of the community.
- (12) If the court imposes a sentence requiring confinement of thirty days or less, the court may, in its discretion, specify that the sentence be served on consecutive or intermittent days. A sentence 39 requiring more than thirty days of confinement shall be served on

1 consecutive days. Local jail administrators may schedule court-ordered 2 intermittent sentences as space permits.

- 3 (13) If a sentence imposed includes payment of a legal financial 4 obligation, the sentence shall specify the total amount of the legal financial obligation owed, and shall require the offender to pay a 5 specified monthly sum toward that legal financial obligation. 6 Restitution to victims shall be paid prior to any other payments of 7 8 monetary obligations. Independent of the department, the party 25 or entity to whom the legal financial obligation is owed shall have the authority to utilize any other remedies available to the party or 26 27 entity to collect the legal financial obligation. Nothing in this section makes the department, the state, or any of its employees, 28 29 agents, or other persons acting on their behalf liable under any 30 circumstances for the payment of these legal financial obligations. If 31 an order includes restitution as one of the monetary assessments, the county clerk shall make disbursements to victims named in the order. 32
- 33 (14) Except as provided under RCW 9.94A.140(1) and 9.94A.142(1), a 34 court may not impose a sentence providing for a term of confinement or 35 community supervision, community placement, or community custody which 36 exceeds the statutory maximum for the crime as provided in chapter 37 9A.20 RCW.
- 38 (15) All offenders sentenced to terms involving community 39 supervision, community service, community placement, community custody,

or legal financial obligation shall be under the supervision of the department of corrections and shall follow explicitly the instructions and conditions of the department of corrections. The department may require an offender to perform affirmative acts it deems appropriate to monitor compliance with the conditions of the sentence imposed.

- (a) The instructions shall include, at a minimum, reporting as directed to a community corrections officer, remaining within prescribed geographical boundaries, notifying the community corrections officer of any change in the offender's address or employment, and paying the supervision fee assessment.
- (b) For offenders sentenced to terms involving community custody for crimes committed on or after June 6, 1996, the department may include, in addition to the instructions in (a) of this subsection, any appropriate conditions of supervision, including but not limited to, prohibiting the offender from having contact with any other specified individuals or specific class of individuals. For offenders sentenced to terms of community custody for crimes committed on or after July 1, 2000, the department may additionally require the offender to participate in rehabilitative programs or otherwise perform affirmative conduct, and to obey all laws.

The conditions authorized under this subsection (15)(b) may be imposed by the department prior to or during an offender's community custody term. If a violation of conditions imposed by the court or the department pursuant to subsection (10) of this section occurs during community custody, it shall be deemed a violation of community placement for the purposes of RCW 9.94A.207 and shall authorize the department to transfer an offender to a more restrictive confinement status as provided in RCW 9.94A.205. At any time prior to the completion of an offender's term of community custody, the department may recommend to the court that any or all of the conditions imposed by the court or the department pursuant to subsection (10) or (11) of this section be continued beyond the expiration of the offender's term of community custody as authorized in subsection (10)(c) or (11)(e) of this section.

The department may require offenders to pay for special services rendered on or after July 25, 1993, including electronic monitoring, day reporting, and telephone reporting, dependent upon the offender's ability to pay. The department may pay for these services for offenders who are not able to pay.

- (16) All offenders sentenced to terms involving community 1 supervision, community service, community custody, or community 2 placement under the supervision of the department of corrections shall 3 4 not own, use, or possess firearms or ammunition. Offenders who own, use, or are found to be in actual or constructive possession of 5 firearms or ammunition shall be subject to the appropriate violation 6 7 process and sanctions. "Constructive possession" as used in this 8 subsection means the power and intent to control the firearm or 9 ammunition. "Firearm" as used in this subsection means a weapon or 10 device from which a projectile may be fired by an explosive such as 11 gunpowder.
- 12 (17) The sentencing court shall give the offender credit for all confinement time served before the sentencing if that confinement was 14 solely in regard to the offense for which the offender is being 15 sentenced.
 - (18) A departure from the standards in RCW 9.94A.400 (1) and (2) governing whether sentences are to be served consecutively or concurrently is an exceptional sentence subject to the limitations in subsections (2) and (3) of this section, and may be appealed by the defendant or the state as set forth in RCW 9.94A.210 (2) through (6).
 - (19) The court shall order restitution whenever the offender is convicted of a felony that results in injury to any person or damage to or loss of property, whether the offender is sentenced to confinement or placed under community supervision, unless extraordinary circumstances exist that make restitution inappropriate in the court's judgment. The court shall set forth the extraordinary circumstances in the record if it does not order restitution.
 - (20) As a part of any sentence, the court may impose and enforce an order that relates directly to the circumstances of the crime for which the offender has been convicted, prohibiting the offender from having any contact with other specified individuals or a specific class of individuals for a period not to exceed the maximum allowable sentence for the crime, regardless of the expiration of the offender's term of community supervision or community placement.
- 35 (21) The court may order an offender whose sentence includes 36 community placement or community supervision to undergo a mental status 37 evaluation and to participate in available outpatient mental health 38 treatment, if the court finds that reasonable grounds exist to believe 39 that the offender is a mentally ill person as defined in RCW 71.24.025,

- and that this condition is likely to have influenced the offense. An order requiring mental status evaluation or treatment must be based on a presentence report and, if applicable, mental status evaluations that have been filed with the court to determine the offender's competency or eligibility for a defense of insanity. The court may order additional evaluations at a later date if deemed appropriate.
- 7 (22) In any sentence of partial confinement, the court may require 8 the defendant to serve the partial confinement in work release, in a 9 program of home detention, on work crew, or in a combined program of 10 work crew and home detention.
- 11 (23) All court-ordered legal financial obligations collected by the 12 department and remitted to the county clerk shall be credited and paid 13 where restitution is ordered. Restitution shall be paid prior to any 14 other payments of monetary obligations.
- 15 (24) In sentencing an offender convicted of a crime of domestic 16 violence, as defined in RCW 10.99.020, if the offender has a minor 17 child, or if the victim of the offense for which the offender was 18 convicted has a minor child, the court may, as part of any term of 19 community supervision, order the offender to participate in a domestic 20 violence perpetrator program approved under RCW 26.50.150.

- (25)(a) Sex offender examinations and treatment ordered as a special condition of community placement or community custody under this section shall be conducted only by sex offender treatment providers certified by the department of health under chapter 18.155 RCW unless the court finds that: (i) The offender has already moved to another state or plans to move to another state for reasons other than circumventing the certification requirements; (ii) no certified providers are available for treatment within a reasonable geographic distance of the offender's home, as determined in rules adopted by the secretary; (iii) the evaluation and treatment plan comply with the rules adopted by the department of health; or (iv) the treatment provider is employed by the department. A treatment provider selected by an offender who is not certified by the department of health shall consult with a certified provider during the offender's period of treatment to ensure compliance with the rules adopted by the department of health. The frequency and content of the consultation shall be based on the recommendation of the certified provider.
- 38 (b) A sex offender's failure to participate in treatment required 39 as a condition of community placement or community custody is a

- 1 violation that will not be excused on the basis that no treatment
- 2 provider was located within a reasonable geographic distance of the
- 3 offender's home.
