- 4 **Sec. 1.** RCW 26.50.160 and 1995 c 246 s 18 are each amended to read 5 as follows:
- 6 To prevent the issuance of competing protection orders in different
- 7 courts and to give courts needed information for issuance of orders,
- 8 the judicial information system shall be available in each district,
- 9 municipal, and superior court by July 1, 1997, and shall include a data
- 10 base containing the following information:
- 11 (1) The names of the parties and the cause number for every order
- 12 of protection issued under this title, every criminal no-contact order
- 13 issued under chapter 10.99 RCW, every antiharassment order issued under
- 14 chapter 10.14 RCW, every dissolution action under chapter 26.09 RCW,
- 15 every third-party custody action under chapter 26.10 RCW, ((and)) every
- 16 parentage action under chapter 26.10 RCW, and every order for
- 17 protection issued under chapter 74.34 RCW;

- 1 (3) Other relevant information necessary to assist courts in

- 4 **Sec. 2.** RCW 74.34.130 and 1999 c 176 s 13 are each amended to read 5 as follows:
- The court may order relief as it deems necessary for the protection of the petitioner, including, but not limited to the following:
- 8 (1) Restraining respondent from committing acts of abandonment, 9 abuse, neglect, or financial exploitation;
- 10 (2) Excluding the respondent from petitioner's residence for a 11 specified period or until further order of the court;
- 12 (3) Prohibiting contact by respondent for a specified period or 13 until further order of the court;
- 14 (4) Requiring an accounting by respondent of the disposition of 15 petitioner's income or other resources;
- 16 (5) Restraining the transfer of property for a specified period not exceeding ninety days;
- 18 (6) Requiring the respondent to pay the filing fee and court costs, 19 including service fees, and to reimburse the petitioner for costs 20 incurred in bringing the action, including a reasonable attorney's fee.
- 21 Any relief granted by an order for protection, other than a 22 judgment for costs, shall be for a fixed period not to exceed one year.
- 23 The clerk of the court shall enter any order for protection issued
- 24 under this section into the judicial information system.
