1            AN ACT Relating to a task force on funding for community-based  
2 services to victims of crime; adding a new section to chapter 43.31  
3 RCW; and providing an expiration date.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5            NEW SECTION.    **Sec. 1.** A new section is added to chapter 43.31 RCW  
6 to read as follows:

7            (1) There is created the Washington state task force on funding for  
8 community-based services to victims of crime.

9            (2) The task force shall consist of the following members:

10           (a) The director of the office of community development, or the  
11 director's designee;

12           (b) The secretary of the department of social and health services,  
13 or the secretary's designee;

14           (c) The director of the department of labor and industries, or the  
15 director's designee;

16           (d) At least eleven, but not more than fifteen, additional members,  
17 selected by the director of the office of community development,  
18 including: At least one representative each of community-based  
19 organizations that focus on providing services to homicide survivors,

1 assault victims (other than sexual assault and domestic violence),  
2 robbery victims, child abuse victims, and victims of drunk and drugged  
3 drivers (vehicular assault and vehicular homicide); one representative  
4 of organizations that provide services primarily to domestic violence  
5 victims; one representative of organizations providing services  
6 primarily to sexual assault victims; one representative of programs  
7 that provide services to victims who are deaf, blind, or otherwise  
8 disabled; one representative of organizations that provide services  
9 solely for victims to whom English is a second language; one  
10 representative of victim service programs administered by law  
11 enforcement agencies; and one representative of victim/witness  
12 assistance programs administered by county prosecuting attorneys;

13 (e) Four legislators, two from the senate to be chosen by the  
14 president of the senate and two from the house of representatives to be  
15 chosen by the speaker of the house of representatives. Not more than  
16 one member from each chamber may be a member of the largest political  
17 party caucus.

18 (3) The task force shall be chaired by the director of the office  
19 of community development, or the director's designee.

20 (4) The task force shall carry out the following activities:

21 (a) Measure and evaluate the progress of the state in providing  
22 funding to community-based programs that provide services to victims of  
23 crime, especially the underserved victim populations identified as:  
24 Homicide survivors, physical assault victims (non-domestic violence and  
25 nonsexual assault related), robbery victims, child abuse victims,  
26 vehicular assault and homicide victims and survivors, and victims of  
27 property crimes;

28 (b) Identify available federal, state, and local programs that  
29 provide services to underserved victims as defined in (a) of this  
30 subsection;

31 (c) Identify federal and private funds, including funds from  
32 foundations and other nonprofit organizations, that may be available  
33 for community-based programs that provide services to crime victims;

34 (d) Make recommendations on methods to provide a cost-effective  
35 coordinated system of support and assistance to persons who are victims  
36 of crime;

37 (e) Make recommendations on funding necessary to provide  
38 appropriate services to the underserved victims, with recommendations  
39 on revenue sources; and

1 (f) Identify statutory and administrative barriers to improving the  
2 delivery of cost-effective and coordinated services to crime victims.

3 (5) State and local government agencies that participate in the  
4 delivery of services to crime victims shall, upon request, provide  
5 information and technical assistance to the task force, within existing  
6 funds.

7 (6) The task force shall report its findings and recommendations to  
8 the governor and the legislature by November 30, 2002.

9 (7) The office of community development shall provide necessary  
10 administrative and clerical support to the task force.

11 (8) The members of the task force shall serve without compensation,  
12 but shall be reimbursed for travel expenses as provided in RCW  
13 43.03.050 and 43.03.060.

14 (9) The task force expires March 1, 2003.

15 (10) This section expires March 1, 2003.
