1 AN ACT Relating to harbor lines in Blaine, Edmonds, Ilwaco,
2 Kennewick, and Pasco; and amending RCW 79.92.030.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 79.92.030 and 1989 c 79 s 1 are each amended to read
5 as follows:

6 The commission on harbor lines is hereby authorized to change,
7 relocate, or reestablish harbor lines in Guemes Channel and Fidalgo Bay
8 in front of the city of Anacortes, Skagit county; in Grays Harbor in
9 front of the cities of Aberdeen, Hoquiam, and Cosmopolis, Grays Harbor
10 county; Bellingham Bay in front of the city of Bellingham and in
11 Drayton Harbor in front of the city of Blaine, Whatcom county; in
12 Elliott Bay, Puget Sound and Lake Union within, and in front of the
13 city of Seattle, King county, and within one mile of the limits of such
14 city; Port Angeles harbor in front of the city of Port Angeles, Clallam
15 county; in Lake Washington in front of the cities of Renton and Lake
16 Forest Park, King county; Commencement Bay in front of the city of
17 Tacoma, Pierce county; and within one mile of the limits of such city;
18 Budd Inlet in front of the city of Olympia, Thurston county; the
19 Columbia river in front of the city of Kalama, Cowlitz county; Port

1 Washington Narrows and Sinclair Inlet in front of the city of
2 Bremerton, Kitsap county; Sinclair Inlet in front of the city of Port
3 Orchard, Kitsap county; in Liberty Bay in front of the city of Poulsbo,
4 ((King)) Kitsap county; the Columbia river in front of the city of
5 Vancouver, Clark county; Port Townsend Bay in front of the city of Port
6 Townsend, Jefferson county; the Swinomish Channel in front of the city
7 of La Conner, Skagit county; and Port Gardner Bay in front of the city
8 of Everett, ((Snohomish county,)) except no harbor lines shall be
9 established in Port Gardener Bay west of the easterly shoreline of
10 Jetty Island as presently situated or west of a line extending S 37°
11 09' 38" W from the Snohomish River Light (5), and in front of the city
12 of Edmonds, Snohomish county; in Oakland Bay in front of the city of
13 Shelton, Mason county; and within one mile of the limits of such city;
14 in Gig Harbor in front of the city of Gig Harbor, Pierce county; and
15 within one mile of the limits of such city, at the entrance to the
16 Columbia river in front of the city of Ilwaco, Pacific county; in the
17 Columbia river in front of the city of Pasco, Franklin county; and in
18 the Columbia river in front of the city of Kennewick, Benton county.
