EFFECT: Requires a person registering to vote in person to present proof of identity at the time of registration. Requires a person registering to vote by mail to send a copy of proof of identity along with his or her registration application. Specifies what types of identification constitute proof of identity. Requires registration applications to contain instructions to the applicant to provide proof of identity. Eliminates the requirement for proof of identity for registration for federal elections if a court of competent jurisdiction rules that such a requirement violates federal law; maintains the requirement for registration for state elections.
