2 "<u>NEW SECTION.</u> Sec. 4. A new section is added to chapter 29A.08
3 RCW to read as follows:

4 (1) Short Title. This section may be cited as the "Washington
5 Taxpayer and Citizen Protection Act."

(2) Findings and Declaration. The legislature finds that illegal б immigration is causing economic hardship to this state and that illegal 7 immigration is encouraged by public agencies within this state that 8 9 provide public benefits without verifying immigration status. The legislature further finds that illegal immigrants have been given a 10 11 safe haven in this state with the aid of identification cards that are issued without verifying immigration status, and that this conduct 12 contradicts federal immigration policy, undermines the security of our 13 14 borders, and demeans the value of citizenship. Therefore, the legislature finds that the public interest of this state requires all 15 public agencies within this state cooperate with federal immigration 16 authorities to discourage illegal immigration. 17

18 (3) Form of Registration. In addition to the requirements of RCW 19 29A.08.010, the form of registration provided by the secretary of state 20 or county auditor must include a statement that the applicant must 21 submit evidence of United States citizenship with the application and 22 that the county auditor or secretary of state shall reject the 23 application if no evidence of citizenship is attached.

(4) The county auditor or secretary of state shall reject any
application for registration that is not accompanied by satisfactory
evidence of United States citizenship. Satisfactory evidence of
citizenship includes any of the following:

(a) The number of the applicant's Washington state driver's license
or Washington state identification card issued by the department of
licensing, but only if the department indicates on the applicant's
driver's license or identification card that the applicant has provided
satisfactory proof of United States citizenship;

1 (b) A legible photocopy of the applicant's birth certificate that 2 verifies citizenship to the satisfaction of the county auditor or secretary of state; 3

(c) A legible photocopy of pertinent pages of the applicant's 4 5 United States passport identifying the applicant and the applicant's б passport number or presentation to the county auditor or the secretary of state of the applicant's United States passport; 7

(d) A presentation to the county auditor or secretary of state of 8 the applicant's United States naturalization documents or the number of 9 the certificate of naturalization. If only the number of the 10 11 certificate of naturalization is provided, the applicant must not be included in the registration rolls until the number of the certificate 12 of naturalization is verified with the United States Immigration and 13 Naturalization Service by the county auditor or secretary of state; 14

15 (e) Other documents or methods of proof that are established under 16 the federal Immigration Reform and Control Act of 1986; or

(f) The applicant's Bureau of Indian Affairs card number, tribal 17 18 treaty card number, or tribal enrollment number.

(5) Notwithstanding subsection (4) of this section, any person who 19 is registered in this state on the effective date of this section is 20 21 deemed to have provided satisfactory evidence of citizenship and may 22 not be required to resubmit evidence of citizenship unless the person is changing voter registration from one county to another or 23 reregistering to vote. 24

(6) Proof of voter registration from another state or county is not 25 satisfactory evidence of citizenship. 26

(7) After a person has submitted satisfactory evidence of 27 citizenship, the county auditor or secretary of state shall indicate 28 this information in the person's permanent voter file. After two 29 years, the county auditor or secretary of state may destroy all 30 documents that were submitted as evidence of citizenship." 31
