- 7 (3) No person shall knowingly use public facilities to clone a human being or to attempt to clone a human being.
- 9 (4) No public employee shall knowingly allow any person to clone a 10 human being or to attempt to clone a human being while the person is 11 making use of public funds or public facilities.
- 12 (5) Any person who violates any of the provisions of subsections 13 (1) through (4) of this section is quilty of a class B felony."

- 16 On page 1, line 6 of the title, after "sections;" insert 17 "prescribing penalties;"
 - <u>EFFECT:</u> Prohibits individuals from knowingly engaging or participating in human cloning, knowingly using public funds to engage

or attempt to engage in human cloning, and knowingly using public facilities for engaging in or attempting to engage in human cloning. Public employees are also prohibited from allowing other individuals to engage in or attempt to engage in human cloning while using public funds or public facilities. Violation of the bill is a class B felony.
